Issues of importance to the MINERAL COUNTY area are
As follows:

1. EMPLOYMENT - The area has an unemployment rate exceeding most other areas in the State of West Virginia. There is a definite need for jobs especially to replace those lost in recent years by company closings and furloughs.
2. PUBLIC HEALTH – The area has a significantly high percentage of Senior citizens and low-income families, which precipitates higher Incidences of health issues.
3. SENIOR CITIZENS – A large part of the population of the MINERAL COUNTY area is comprised of senior citizens and their concerns include health, living on a fixed income, transportation and housing.
4. FAMILY & YOUTH – This Mineral County community is unique. The Citizenry is parochial, provincial, embraces old and established family Principals and worries about its children leaving the area to seek work after graduation because of local economic conditions.
5. CRIME – Although rural, Mineral County has experienced a significant Increase in crime in the last five years attributed mainly to completion of Interstate 68. This portion of the tri-state area is becoming more and more the next “bedroom community” for the Baltimore/Washington Metropolitan area.
6. ENVIRONMENT – As in most areas of the country the environment where Residents reside is a great concern. This community takes pride in the Beauty of the area and want their community to stay in this condition.
7. TOURISM – Fifteen years ago the Tri-State area was an economy of Smokestack industries...today, it is an economy that is more diversified; A composite of service and tourism related job opportunities.
