Baby Your Baby and Check Your Health – Both are ongoing campaigns hosted by Mary Nickles and designed in partnership with KUTV and the Utah Department of Health. Baby Your Baby is a health program for mothers-to-be encouraging early and regular prenatal and postnatal care. Check Your Health is committed to bringing viewers the latest information to help keep families healthy. Both of these segments run in all of our newscasts.

Healthy Living - Airing every day in our weekday 5pm newscast that deals with health and medical issues. The emphasis is on health issues that affect a majority of people, such as healthy eating, exercise, common children's health issues etc. We occasionally do stories on rare medical conditions, or cutting edge medical procedures. The stories outline new trends or problems and offer advice and solutions from professionals, such as doctors, dieticians, fitness trainers, etc. The stories are fronted by anchor Shauna Lake.

Get Gephardt - Investigative reporter Matt Gephardt takes on major corporations or government entities helping viewers who are caught in red tape. In addition, the Gephardt Unit investigations serve as a warning to consumers about potential fraud happening locally. The Gephardt unit takes many calls from the tip line each week and several e-mails weekly from viewers with consumer complaints. The Gephardt stories air during the 10:00pm newscast.

Family Matters - Family Matters is a pro-social campaign that emphasizes the most important information Utah parents need to know and is designed to strengthen and celebrate families. The campaign offers meaningful insight into the topics that frequently impact our families. Family Matters is a station wide initiative and yearlong campaign.

Pay It Forward - Every Wednesday, KUTV's Mark Koelbel features a Good Samaritan in the community. Mark will give the Good Samaritan \$500 in cash for this person to give to their cause. This franchise highlights people and organizations working in the community on a grassroots level to make life better for others. Every Wednesday during the 10pm News there will be a billboard open to the weekly story. KUTV will also run the Pay It Forward story the following Thursday Morning in KUTV2 News This Morning and in the 2News at 7PM on KMYU.

Person 2 Person - A recent feature in our Sunday 10P News is Person 2 Person. Every Sunday Shauna Lake has a conversation with some of Utah's most influential people. From doctors to politicians to people with extraordinary life events, Person 2 Person lets the community know about extraordinary individuals whose work, personal endeavors or personal experiences may have an impact on Utah's society.

CRIME & PUBLIC SAFETY:

WVC Robbery (aired 01/01/2014 @ 5am, :30) – Police in West Valley are looking for some help after a robbery at a credit union. Police say the man walked into the University Federal Credit Union at 2752 South Redwood Road, and demanded money. This story describes the robber, and lets viewers know who police are looking for.

Move to Dismiss (aired 01/05/2014 @ 5am, :30) – Attorneys for convicted killer Martin MacNeill will ask a judge to dismiss a separate sexual abuse case. MacNeill is accused of sticking his hands down a family member's pants, and then trying to make her sign a document saying he didn't do it. MacNeill's lawyers say information released during the murder trial would hurt jury selection for this case. This story updates viewers on his separate case, and tells them why MacNeill wants it thrown out.

Esar Met in Court (aired 01/07/2014 @ 5am, :30) – The trial begins for a Burmese refugee accused of killing a 7-year-old girl in South Salt Lake in 2008. 27-year-old Esar Met is accused of kidnapping and killing Hser Ner Moo. It's taken nearly six years to get the case to trial due to language barriers and Met's difficulty understanding the court process. This story updates viewers on the case, and reminds them why the case has been delayed for so long.

Millerberg Pretrial (aired 01/07/2014 @5am, :25) – An Ogden man accused of drugging and killing a teenage baby sitter will have his pre-trial hearing. Eric Millerberg is scheduled to appear before a judge. This story is an update for viewers on what is happening in the case.

Vasques Final Pretrial Hearing (aired 01/07/2014 @5am, :20) – Today is the final pretrial hearing for the man accused of shooting and killing two people in Sandy. Alexander Leroy Vasquez is accused of killing his uncle and another man. This story updates viewers on the case.

Raquel Borce Court (aired 01/08/2014 @4:30am, :30) – A Weber County woman accused of feeding alcohol to her 3-year-old disabled daughter will appear before a judge. Raquel Borce will make her initial court appearance in the case. This story lets viewers know the latest in the case, and remind them what Borce is accused of doing.

Child Porn Sentencing (aired 01/09/2014 @5am, :25) – A long investigation into a child pornography website ended with 5 Utahns sentenced from one year to 87 months in prison. The 5 Utahns were just part of more than 600 Americans convicted, the founder of the site is a man in the Ukraine, he agreed to a 30-year prison sentence. This story lets viewers know about the far reaching effects of this large investigation.

South Salt Lake Chief Retiring (aired 01/08/2014 @5am, :25) – The South Salt Lake police Chief decided to step down. Chief Chris Snyder announced on Twitter that he will retire at the end of the month. This story lets viewers know of Snyder's plan, and that Deputy Chief Jack Carruth will be taking his place.

Carbon Deputy Stealing (aired 01/08/2014 @5am, :30) – A former Carbon County Sheriff's Sergeant accused of taking drugs from an evidence room will spend 30 days in jail, have 3 years of probation, have to pay a \$700 fine, and go to substance abuse counseling. Christopher Basso was put on leave after failing two drug tests. Prosecutors say a hidden camera caught him going into the evidence locker at odd hours. This story updates viewers to his case.

Lafferty Competent (aired 01/9/2014 @5am, :25) – Condemned killer Ron Lafferty got the go-ahead to be part of court proceedings, dealing with his execution sentence. The 71-year-old was found mentally competent to understand what is going on in the case. This story updates viewers to this trial.

Capitol Steps (aired 01/14/2014 @5am, :30) – A Layton man accused of driving his pickup truck up the steps of Utah's State Capitol is now facing charges. Prosecutors have filed criminal mischief, assaulting an officer, and reckless driving charges against 36-year-old Weston Gerald Green. This is an update to this story, and lets viewers know about the most recent happenings in the case.

Syracuse Shooting (aired 01/14/2014 @10pm, 2:15 minutes) – This is a developing story out of Davis county where police found three people dead inside a home. Police are releasing very little information about the victims or if they have a suspect. This story explains what witnesses saw and what investigators are doing to try and figure out if there is a suspect on the run or if this was an isolated incident.

Banksy Vandalism Video (aired 01/14/2014 @10pm, 2:30 minutes) – New video may lead Park City Police to the suspect who destroyed a couple of popular graffiti murals. Investigators believe the suspect may have recorded himself trashing the popular art pieces by world-renowned street artist, “Banksy.” This story updates our viewers on a story that we have been following, shows the video, explains what police know about the vandal and lets viewers know what to do if they recognize the criminal.

Orem Shooting Plea Deal (aired 01/15/2014 @5am, :45) – Travis Waldron and Mason French could get a possible plea deal for charges they face for allegedly shooting and killing a man over a drug debt back in November. This story updates viewers to the case.

Shelter Stabber Charged (aired 01/15/2014 @5am, :30) – A transient woman has been charged with killing a man near a Salt Lake City Homeless Shelter. 50-year-old Natalie Fern Bluehouse faces first degree felony murder charges in connection with a stabbing that happened in November. Police say Bluehouse admitted to being drunk when it happened. This story updates viewers to the charges she now faces.

Snowbasin Suspects in Court (aired 01/16/2014 @5am, :35) – Four people accused of kidnapping and killing a West Valley city man for a drug debt made their first court appearance. They face several charges including aggravated kidnapping, homicide, and obstruction of justice. This story lets viewers know about the most recent legal proceedings in the case.

Rettig Arraignment (aired 01/21/2014 @5am, :25) – A man convicted of murder will hear the charges he faces in a separate case in court. Benjamin Rettig faces obstruction of justice charges for refusing to testify in a murder trial. This story updates viewers to this case.

UDOT Fatalities (aired 1/21/2014 @5pm, 2:00 minutes) – The Utah Department of Transportation released statistics for highway fatalities in the state. In 2013, 219 people died on Utah roads. 152 of those people were driving a car, and 71 of those in the car were not wearing seatbelts. That means nearly half of the people who died did not buckle up. Transportation officials said seat belts were the number one contributor in fatal crashes, and wanted to remind the public to wear seat belts. The Utah Department of Transportation was also looking to get the seat belt law in the state changed—making it so drivers who are not wearing seat belts could be pulled over. Right now, people can't be pulled over for not buckling up unless they are under 18 years of age.

LDS Abuse Lawsuit (aired 01/23/2014 @10pm, 2:45 minutes) – Two Utah men have filed suit against the LDS Church claiming they were abused by one of their leaders. The alleged sexual abuse happened decades ago in Hawaii. The men are coming forward now after a new statute of limitations law in Hawaii allows them to go after their alleged abuser. In this story both men talk about the alleged crime and how it changed their lives. It lets viewers know that there are allegations of abuse at the church owned pineapple farm and explains what people can do if they know of other potential victims.

WVC Town Hall (aired 01/23/2014 @10pm, 2:15 minutes) – In an effort to clean up its image, the West Valley Police Department is holding open public meeting with city residents. The police chief wants to hear from community members about what is happening in the city, what they are happy about and what they would like to see done better. The chief's hope is that the open dialog will get back some of the public trust which has been lost following a year of scandal. This story lets our viewers know how and when they can share their concerns.

Teacher Abuse Plea (aired 01/24/2014 @5am, :45) – A former teacher and coach faces up to 20 years in prison after pleading guilty to sexually abusing a student. Police say Stephen Niedzwiecki pleaded guilty to reduced charges. This story let viewers know about his plea deal, and the victim came forward to say she thought he shouldn't be allowed to take a plea deal.

Johnson & Swallow (aired 01/24/2014 @5am, :30) – The Utah businessman who was part of the scandal that forced former Attorney General John Swallow from office says he faces exaggerated charges in a criminal case in Utah. Johnson says Swallow conspired with one prosecutor in the federal criminal case and in a separate federal lawsuit he faces in Las Vegas.

Idling Car Thefts (aired 01/26/2014 @5am, :30) – Ogden Police say they are stepping up enforcement of the state's anti-idling law after a wave of preventable thefts. Police say car thefts are on the rise because people leave their cars running unattended. This story lets viewers know there could be other consequences to leaving their car unattended other than just having it stolen.

Therapist Sex Abuse Charges (aired 01/27/2014 @5am, :30) – A former social worker has pleaded guilty in a sexual abuse case involving a 16-year-old girl. Scott Peterson took a plea deal; he'll be sentenced on March 10th. This story is an update, and lets viewers know about the charges Scott Peterson is now facing.

Active Shooter Training (aired 01/30/2014 @10pm, 4:15 minutes) – Police and schools are taking measures to try and stop active shooters. Police, the FBI, educators and even college professors have studied the after-action reports of major active shooter incidents and have changed their tactics. This story explains to the viewer what local agencies are doing to try and keep our community safe and details what changes have been made since an active shooter opened fire at Trolley Square.

Bulletproof Glass for Cop Cruisers (aired 02/11/2014 @10pm, 2:45 minutes) – The death of a Utah County Sheriff's Sargent has one woman taking action to protect police officers inside their patrol cars. Nan Wride, the widow of Sgt. Cory Wride, has begun a crusade to equip police cars with bullet proof glass. Sgt. Wride was shot and killed while he sat inside his cop car. His wife wants to see change and has reached out to officers, police chiefs, lawmakers and the governor to try make it happen. This story lets viewers know about her campaign and explains what they can do to help.

Magna Attempted Abduction (aired 02/13/2014 @10pm, 2:30 minutes) – An attempted kidnapping in Magna have police asking for help. The young girl was walking home from school when a man in a blue mini-van pulled up alongside her. He grabbed her and tried to pull her inside the van. She started screaming, the suspect let go and drove away. This story let viewers know that there is a potentially dangerous man in the area and gives them a description of the suspect and his vehicle.

Millerberg Verdict (aired 02/14/2014 @10pm, 2:15 minutes) – Jurors reached a verdict in the trial of Eric Millerberg. He is accused of giving his babysitter a deadly dose of drugs and then hiding her body. Millerberg was found guilty on all four charges against him. This story updates our viewers on a story we have been covering for years and lets them know when Millerberg will be sentenced.

Prosecutors Charge Meagan Grunwald (aired 2/18/14 @5am, 1:10) Utah County prosecutors announced they are pursuing murder charges against Meagan Grunwald. Grunwald is the 17-year-old accused in the shooting death of Sergeant Cory Wride. Prosecutors plan to charge Grunwald as an adult.

SLCO Jail and Body Scanner (aired 02/19/2014 @10pm, 2:15 minutes) – The Salt Lake County Sheriff's Office plans on adding full body scanners at the jail. The sheriff says there has been a dramatic escalation of inmates trying to smuggle drugs into the facility and the scanners will be a tool to help better detect contraband, keeping it out of the jail. This story explains what steps officials are taking to try and stop the smuggling problem and the cost associated with installing the scanners.

University of Utah Attempted Kidnapping (aired 02/19/2014 @10pm, 2:30 minutes) – University of Utah police are on high alert after two serious incidents involving women. Last month, a student was picked up in a car and sexually assaulted before she escaped. Today, officers responded to a report of an attempted abduction. This story explains what happened in each incident, describes who police are looking for and what student and others on campus need to do to keep themselves safe.

E-Cigs for Sex? (aired 2/20/2014 @5am, :30) – A man is behind bars accused of trying to use e-cigarettes to lure minors into sex. Police say 49-year-old Charles Randall Redwen tried to talk a boy into having sex by offering him e-cigarettes. This story updates viewers to this case, and the charges Redwen faces including sexual exploitation of a minor and seducing a minor by internet or text.

Robinson and Weed Wax (aired 02/21/2014 @10pm, 2:30 minutes) – A new kind of marijuana is making its way to Utah and police have made an arrest in a case where they say the suspect was making the new drug. It is called “dab” or “shatter” and is made by cooking marijuana. It is a waxy, brown substance, which is more expensive and stronger than pot. This story explains to viewers that the new drug has made its way into local communities and lets the viewers know that police are aware of the drug and they’re arresting people who are making it.

Brigham City Doctor (aired 2/24/2014 @5:30am, :30) – A Brigham City Doctor convicted of illegally prescribing pain medicine lost out on his chance to take his case to the Supreme court. The court denied Dewey Mackay’s “evidence challenge.” This story updates viewers on the case and lets them know he will still be serving out his 20 year sentence for causing the death of a man who overdosed.

Diem Sentencing (aired 2/25/2014 @5:30am, :15) – An Orem Man who plead guilty to beating his step-father to death will learn his fate today. Strider Diem pleaded guilty to reduced charges in the case. This story updates viewers on the case and lets them know he faces up to five years in prison.

Orem Case (aired 2/25/14 at 7am for :30) - Two men accused of shooting an Orem driver over an apparent drug debt and causing a traffic accident went to court. Travis Waldron and Mason French considered a plea deal in that case. A judge ruled on a request to bind the court to the plea agreement terms.

Wyoming Case (aired 2/26/14 at 7am for :30) - A Wyoming man was accused of multiple counts of 1st degree sexual assault and sexual abuse of a minor. Rock Springs police say they identified multiple victims who have reported sexual contact with the 79-year-old defendant and said they think there may still be more. The name of the man was not being released at the time.

Driving to Hospitals (aired 2/26/2014 @5pm, 2:00 minutes) – An alarming amount of people with heart attack symptoms are coming to the hospital in a car. According to a study from Utah’s Mountain Star Network, 96% of patients at one hospital in Utah County drove themselves or got a ride to the hospital when they thought they were having a heart attack. It was 80% of people at another hospital in Salt Lake. Doctors say most of those people should be arriving by ambulance. In our story, experts warned that every second counts when it comes to a heart attack and urge the public to call 911 rather than get their own ride to the hospital. Doctors say paramedics have all the equipment they need to help a heart attack patient. They can arrive to a home a lot faster than it would take for a person to drive to the hospital. It could also be potentially dangerous on the roads if someone is driving with a medical condition.

Pot Igloo (aired 2/27/2014 @5:30am, :20) – Four University of Utah students could face disciplinary action after a security guard says he found them smoking pot in an igloo. All four of the students could face academic sanctions including expulsion. This story

lets viewers know about the pot bust, and the charges the students could face for getting caught.

Altice Arraignment (aired 2/27/2014 @6:00am, :20) – A Kaysville teacher accused of having sex with a 17-year-old student will hear the charges she faces in court today. Brianne Altice has been on paid leave from Davis High School since her arrest last October. This story updates viewers on the latest in the case.

Dating Violence Report (aired 2/27/2014 @5pm, 2:00 minutes) – A new survey from the Utah Department of Health shows one in every four high school students who dated in Utah last year experienced some sort of abuse. Those numbers have the health department and other violence prevention experts worried—and they’re now working to educate students. The health department is releasing a “relationship tool kit” they hope to get into every school across the state. Our story also gave some warning signs that a person is in an abusive relationship. Experts say the biggest obstacle in these situations is getting kids to talk about it. Many times they don’t realize they are being abused.

Drive-by Shooting (aired 2/28/2014 @6:00am, 1:30 minutes) – Salt Lake City Police are investigating after a late night drive by shooting. One man went to the hospital after having a panic attack. This story was new this morning, and updated viewers to a shooting that happened over night.

Fotu Sentencing (aired 2/28/2014 @6:00am, :30) – The man accused of obstructing justice in a triple murder investigation will be sentenced today. Davis Fotu plead guilty to the charges against him. Police say Fotu was inside a Midvale home when David Fresques went room to room shooting and killing three people. This story updates viewers on the case.

Missing Kids (aired 03/03/2014 @10pm, 2:30 minutes) – Breaking news about two missing children. Police in Taylorsville say a 12-year-old boy did not return home from school. They are worried he might be in danger because he has a mental disability. West Valley Police are looking for a 12-year-old girl who also did not return home from school. Both police departments are asking for the public’s help in finding the two children.

Two Runaways Found (aired 03/03/2014 @10pm, 2:30 minutes) – Four teens escaped from a center for troubled youth in Draper last night. Police found two of the suspects but are still searching for the other two. Investigators say the teens ran across the freeway, stole a car and then went on a joy ride. This story lets our viewers know that officials do not believe the teens are dangerous but explains that officers still want to find them. This story gives the suspects names and description and tells viewer what to do if they see the teens.

Yellowbear Arrest (aired 3/6/2014 @6:00am, :40) – Police arrested a man in West Valley early this morning who was wanted for parole violations. 29-year-old Tyson Yellowbear had a brief standoff with police before coming out on his own. Police

tracked him to a house. Yellowbear was wanted for parole violations on a homicide, from a drug deal in 2006. He will also face charges for a restricted person possessing a gun. This story updates viewers to an early morning confrontation with police.

UVU Arrest Video (aired 03/06/2014 @10pm, 3:30 minutes) – A Utah Valley University student says unnecessary force was used when she was arrested for writing on a campus map. Ginger Anderson says she wrote on the map because it was wrong and students were getting lost. When university police approached her about writing on the map, she claims she tried to explain what happened and couldn't believe they were going to arrest her for something so small. Officers told her she would need to go to the office with them and she would be issued a citation. When she refused and continued to ask questions, an officer pushed her up against the wall, then threw her to the ground and handcuffed her. The whole incident was captured on the cops' lapel camera. She claims the use of force was excessive. University police and the sheriff's office conducted an investigation and say Anderson was passively and actively resisting arrest.

Last Two Teens Found (aired 3/7/2014 @6:00am, :40) – Police say they have found the last two missing boys who escaped from a center for troubled teens in Draper. Two of the boys were found last night just after 10pm. The boys left the Genesis Youth Center Tuesday night. This story updates viewers to where the boys are and what will happen to them next.

Cell Phone Bill (aired 03/10/2014 @10pm, 2:45 minutes) – A state lawmaker is proposing a bill that would make it illegal to use your cell phone while driving without using a hands free device. That means the driver would not be allowed to dial a phone number, email, or send a text message while behind the wheel. The new measure would also make using your cell phone while driving a primary offense in the state of Utah. This story explained how the law would work and how likely it is to be signed into law.

Burglary Arrest (aired 3/11/2014 @5:30am, :35) – A man is behind bars in Cache County, facing burglary charges for allegedly stealing appliances and other items from several homes. 29-year-old Roy L. Meyer was linked to a stolen truck and breaking into several homes and cabins across Northern Utah. This story updates viewers to a crime that happened in their area.

Give Trucks Space (aired 3/14/2014 @5pm, 1:30 minutes) – Salt Lake City Police are rolling out a new campaign to make drivers more aware of commercial trucks. The campaign is called "Trucks Need Space" and police hope they will save lives by getting the word out. Through the campaign, police want drivers to be aware that the stopping time for a large truck is much greater than a passenger vehicle. Police are seeing more cars cutting trucks off in traffic, which can often have fatal results. Truckers say if other drivers follow simple driving rules, it can help everyone avoid accidents. Salt Lake City police encourage the public to visit their website and pledge to drive more carefully around big commercial trucks.

BYU Groper (aired 03/18/2014 @10pm, 2:15 minutes) – BYU Police are on high alert tonight as evidence points to the possibility of a serial groper on campus. There have been more than six attacks on BYU's campus since the beginning of the year. Investigators say it seems the cases are getting progressively worse, from simply touching women inappropriately as they walk on campus to breaking into their apartments. This story explains what exactly has been happening, where the attacks have taken place and gives a description of the suspect.

Shell Robbery (aired 3/20/2014 @5:30am, :40) – Unified police are looking for a man that robbed a Shell gas station overnight. Police say the robber walked in the station located at 4111 South Redwood Road, claimed he had a weapon, and took cash. This story updates viewers to a crime that happened overnight.

EDUCATION:

Teachers Take Gun Class (aired 1/3/14 @4:00pm, 1:25) - Dozens of Utah teachers used part of their winter break to earn their concealed weapons permit. Organizers of the classes say they created the teacher focused seminars to help keep schools safe. Opponents say arming teachers sends the wrong message to students.

Preschool Funding (aired 1/16/2014 @5pm, 1:30 minutes) – The Salt Lake County mayor wants the legislature to put up some money for a program to help poor children read. If the proposed program got funding, Salt Lake County, United Way and the Granite School District would take kids who are poor and score low on tests and put them in a preschool. Goldman Sachs would pay the costs for schooling upfront. And if the kids are doing well enough by third grade, taxpayers would then pay the money back to Goldman Sachs. Mayor Ben McAdams claims educational success would eventually save taxpayer money. But some groups don't like the plan, and will fight it before the legislature.

New Education Adviser (aired 01/22/14 @4:30am, :30) – Governor Gary Herbert announced who will be his new Education Adviser. Herbert has chosen Utah State School Board Member Tami Pyfer. This story lets viewers know about an update to the Governor's staff.

Tuition Protest Dollars (aired 01/23/2014 @5:00am :25) – A University of Utah student says he paid his tuition bill with two-thousand one-dollar bills to protest the rising cost of college. Undergraduate in state tuition rates have more than doubled in Utah over the past 10 years. This story lets viewers know about one student's creative way to protest.

Uintah Lunch Follow (aired 02/04/2014 @10pm, 2:30 minutes) – School district officials and parents are meeting together after students' lunches were taken away and thrown in the trash. The school board heard from parents who are asking for immediate change following the controversial decision. Parents acknowledged that the students had a negative account balance when the lunches were taken and trashed but said no child should ever have their lunches taken away from them. The school district agreed

and announced changes that will take effect immediately. This story explains the policy change to the viewers and keeps them informed on a story that sparked a lot of interest in the community.

Sundays @7 (aired 2/12/14 at 6:50am for 3:00 minutes) - The School of Music for the University of Utah spoke in studio about their "Sundays@7" program. They also performed to showcase their talent. They talked about how the program allows students and aspiring musicians to perform for people on a regular basis. They showed people where they could go at the University to go see the performances. They explained why this is a good program for students at the music school.

Charter Schools (aired 2/17/14 at 7:30am for :30) - The Salt Lake Tribune reports that Representative Rich Cunningham says that charter schools can build wherever they want and it's hard for cities to regulate the schools. Others say that Cunningham is just siding with a wealthy land owner who lost some land to a charter school because the school needed a canal built through his property. Cunningham says he wants to change the rules so that Utah cities have more control over the schools.

WJ Parents (aired 2/19/14 at 7am for :45) - Some parents in the Jordan School District are worried that the district is considering closing down a school that's been around for more than 30 years. The parents gathered to come up with a plan to stop the closure. After voters turned down a bond proposal that would have paid for new schools, the Jordan School Board formed a committee recently to see how best to use their school buildings to solve a big overcrowding problem at some schools.

School Buses (aired 2/19/14 at 7:30am for :30) - One school district is toying with the idea of using cameras on school buses to catch traffic law violators. The Daily Herald says the Alpine School District has a camera installed on one bus. It can get a picture of the car, plates, and face if someone tries an illegal pass. They say the goal isn't to get money from tickets but to keep kids safe.

Elizabeth Smart Supports Child Sex Education Bill (aired 2/19/2014 @4:00pm, :50) - Elizabeth Smart testified before a House committee about the importance of educating kids on sex abuse. Smart said that many kids don't know they have an option to say no to their abuser. The committee approved the bill, and sent it to the full house for consideration.

Huge Donation to Harvard (aired 2/20/14 @4:30pm,:25) - Hedge fund chief Ken Griffin donated \$150 Million to Harvard. Griffin said the endowment will be used to fund 200 full scholarships and a money match for an additional 600 students. Yearly tuition at Harvard costs about \$56,000 per year.

Good Parent Teacher Conferences (aired 2/20/14 @4:30pm, 2:30 minutes) - Heidi Hatch interviewed Paula Logan, the Principal of Butler Middle School about what parents can do to prepare for Parent Teacher Conferences. Butler recommended

several suggestions, such as setting goals and coming up with a list of questions for your child's teacher before the meeting.

Lockhart Plan (aired 2/20/14 at 7am for :45) - During the legislative session, Utah house speaker Becky Lockhart had a plan for Utah schools to buy every kid a tablet or computer, but Governor Gary Herbert said it would cost too much and the plan had to be scaled back. The plan failed to get votes and the bill died.

Lunch Relations (aired 2/21/2014 @5:30am, :30) – The Salt Lake School District says they're considering hiring a public relations firm after they received harsh criticism for throwing away school lunches. This story updates the latest with what the school district is doing.

South Jordan School District? (aired 02/24/2014 @10pm, 2:30 minutes) – Officials are discussing the possibility of splitting up the school district in the south end of the Salt Lake Valley. The new South Jordan mayor is looking into the possibility of breaking away from the Jordan School District. A meeting was held to get feedback from other local officials on how to deal with overcrowding, especially after a school bond was voted down in the last general election. This story lets parents and viewers know that this option is being considered and lets them know they can give their input on how to deal with too many kids and not enough classrooms.

District Split Bill (aired 2/25/2014 @5pm, 1:30 minutes) – South Jordan city is exploring the idea of breaking away from the Jordan School District. But, it may not happen if a new bill passes during the legislative session. HB84 would make it harder for cities with money to separate from cities that don't have as much cash. The bill states that if a city finds that in a five-year projection it would bring in 105% or more of the money needed for their schools, they would legally not be able to break away from its district. The bill already passed committee and does leave the door open for school districts to split up, but the school board would have to say they want to get rid of their schools and give up some power. South Jordan city leaders are actively trying to defeat the bill.

Online Classes (aired 2/26/14 at 7am for :30) - The State Office of Education says a new study shows that online classes for some Utah students are falling short. The Salt Lake Tribune says the report shows many students from charter schools only take a few classes at a time but the school gets state funding as if they are full time students. The audit showed two offending charter schools in particular - Harmony Education Services of Provo and My Tech High Inc. of Spanish Fork.

Spritz App (aired 3/11/2014 @ 5pm, 2:00 minutes) – Technology developed in Utah could transform the way people read and learn. A small start-up, called "Spritz," claims their product can make people read faster. Our story showed viewers how this app works. In the app, you read individual words that are flashed in front of you instead of reading line to line, page to page. You can change the pace of words per minute you read. The people behind the technology say they're heard from people with learning

disabilities like dyslexia, ADHD and even stroke victims that the technology has been a huge success for them.

Tuition Hike (aired 3/13/14 at 6:30am for :30) - The University of Utah is getting a 6% tuition hike starting the next academic year. University trustees approved the increase. The tuition hike will raise salaries, increase academic advising and help with maintenance. The university is also increasing the number of scholarships it will offer next year.

Skip School Bill (aired 3/14/14 at 6:30am for :30) - Utah lawmakers passed a bill to let kids who skip school off the hook as long as they keep up their grades. The bill exempts parents from truancy court if the student is 16 or older and has a 3.5 GPA or higher. The bill's sponsor says court is a school's last resort. Schools will still be able to enforce their own penalties, like keeping students with poor attendance from graduating.

Leapfrog (aired 3/19/14 at 7:15am for 2:30 minutes) A representative from Leapfrog spoke in studio to give away a Leappad and talk about STEM (Science, Technology, Engineering, and Math) learning. This came on the heels of the Governor of Utah trying to make a big push for more STEM learning in the state. Leapfrog talked about the benefits of STEM learning and gave advice to parents on what they could do to help their kids focus on these aspects of education. They talked about the need for more engineers and scientists.

CONSUMER AFFAIRS:

Target Class Action Lawsuit (aired 01/7/2014 @10pm, 2:00 minutes) – A Utah law firm filed a class action lawsuit against Target. This comes after 40 million Target card members had their personal information hacked. The lawsuit was originally filed with the names of four people, alleging losses of at least 5 million dollars in the data breach. This story explains the details of the lawsuit and lets viewers know how they can join the suit if they had their information stolen.

Buying and Selling a Home (aired 1/14/14 at 7:15am for 2:30 minutes) Jennifer Gilchrist is a real estate expert in the Salt Lake City market. She spoke in studio about the current market for selling a home. She gave tips to make your home's value go up and talked about the housing market changing. She also talked about what people can look for as they buy homes.

Pot Polls (aired 1/17/2014 @5:00am, :30) – New polls just released show what Utahns think of marijuana in the state. A poll of 600 Utahns shows about 50% think Utah should legalize Marijuana for Medical Use only 27% think it should be legal for recreational use. This story lets viewers know what their neighbors might think on the recent marijuana issues.

Target Malware (aired 01/16/2014 @10pm, 2:00 minutes) – The target credit card breach is now being handled by homeland security. The attack could be part of a large scheme to cripple the economy and other retailers could have also had customer's

information stolen. Scammers are able to get the personal information thanks to a new breed of malware. This story explains to viewers how hackers can get their sensitive information and what they can do to make sure their information is not stolen.

About the House: Changing Out a Toilet: (aired 1/21/14 at 7:50am for 2:30 minutes) Kristin Calderwood from the Home Depot spoke in studio to show viewers how to save some money by taking out and installing a new toilet. She talked about the best process and the cheapest way to do the best job. Her goal was to help people save some money by doing their own work around the house.

Ottobock Tax Incentive (aired 01/22/14 @4:30am, :30) – Utah has granted a company that makes prosthetic devices a tax incentive to expand operations in Salt Lake City. This story lets viewers know about a business, and possible jobs that could be coming to Utah.

Michaels Hack (aired 1/27/2014 6:15pm :30) - Michael's store announced they may have been hacked and some of its customer's payment information may have been lost. The store is popular in Utah so viewers who may shop there learned to check their cards for possible identify fraud or fraudulent payments.

Southwest Airlines (aired 1/27/2014 6:15pm :30) - Southwest Airlines announced new international flights. They will now be flying to Aruba, the Bahamas and Jamaica. The flights start in July. Viewers who are planning summer vacations learned new options for places they can fly on Southwest Airlines.

Airplane Safety Checks (aired 1/27/2014 6:15pm :30) - THE FAA is doing safety checks on hundreds of planes. They are checking for a possible problem with the tail of the plane. This story informs viewers of what the Federal Aviation Administration is doing to keep their airplanes up to date and safe.

Home Sales Report (aired 1/28/2014 6:15pm :30) - The number of homes sold last year along the Wasatch front topped numbers from 2007. This is a sign that Utah's economy is recovering. This information is valuable for viewers who are thinking of buying or selling their home.

Google Glasses (aired 1/28/2014 6:15pm :30) - Google is adding style to the new Google Glasses. The company released a new line of stylish frames and prescription lenses for the gadgets. This story informed 2News viewers of the latest trends and updates in the ever evolving technology world.

Target Data Breach Investigation (aired 1/29/2014 6:15pm :30) - The United States Attorney General announced the Justice Department is investigating the Target data breach. A lot of viewers were impacted by the breach. 2News viewers gained the latest information into what the government is doing to get to the bottom of the breach that stole data from more than 70 million customers during the holiday shopping season.

New Credit Card Scam (aired 1/29/14 at 7:30am for :30) - The Better Business Bureau issued a national alert that warned consumers about a new credit card scam. They were telling people to check their credit and debit cards for unexplained charges of less than 10 dollars. Experts believed that the thieves thought people could get away with that as long as the charges on people's cards were not too much. The thieves planned to take a little money from a lot of people.

Toyota Sales Freeze (aired 1/31/14 @4:00pm,:25) - Toyota announced a temporary sales freeze on several models due to faulty seat heaters. The car company calls the freeze a pre-emptive strike and declined to issue a recall, because they claim the problem does not pose a safety risk.

Moving to Colorado for Marijuana (aired 2/18/14 @ 4:00pm, 1:20 minutes) - Dozens of families are moving to Colorado for access to Cannabis oil, a substance derived from Marijuana. Many parents use the oil to help treat seizures and other disorders in children. Toxicologists supported that claim, but also expressed concern about the side effects of long term cannabis oil use on children.

Google Fiber Coming to Salt Lake City? (aired 2/19/2014 @4:00pm, 1:00 minute) - Salt Lake City Mayor Ralph Becker spoke with officials from Google Fiber to announce that Salt Lake City is one of several metro areas being considered for Google Fiber service. Becker said Salt Lake is a strong candidate for several factors, one being the city's proximity to Provo, a city which already has Google Fiber.

House of Cards Season 2 (aired 2/19/2014 6:15pm :30) - Verizon and Netflix had a dispute the same time the popular Netflix series "House of Cards" debuted. The two companies couldn't agree on fees for streaming content which may have caused a drop in speed when watching online. This story is informative for customers who may have experienced the glitch and wondered why it was happening.

Hot Pocket Recall (aired 2/19/2014 6:15pm :30) - The Philly Steak and Cheese Hot Pockets were recalled. The meat supplier issued a recall for its beef last week. Viewers learned what to do if they bought the frozen food item.

Americans Love Mail (aired 2/19/2014 6:15pm :30) - A new report shows that Americans love getting their new mail every day and they want delivery to stay the way it is. As the mail trend seems to dwindle, viewers learned that most people still love to get mail.

Unemployment Numbers (aired 3/07/2014 6:15pm :30) - Utah job numbers are up and the unemployment numbers are down. Utah's unemployment rate is now under 4%. That is the lowest it's been since 2008. Viewers learn about the economy in Utah and the big milestone it hit.

Home Show (aired 3/7/14 at 6:50am, 7:15am, 7:50am for 6 minutes)

We sent one of our anchors to the Salt Lake Home and Garden Show where she interviewed people about home and garden care. She asked experts on home care what people can do to spruce up their own homes. She got tips on construction and repair as well as aesthetic changes. She asked garden experts about the best times to plant and other tips on gardens. This was done to help viewers get ideas on what they can do in their own homes.

Home Sales (aired 3/12/14 at 6:50am for 2:30 minutes) Jennifer Gilchrist is a real estate expert who answered in studio questions about the home selling market. She explained that at the end of winter, people should start preparing their homes for sale if they plan to sell soon. She said that winter is a really slow time for real estate because of the cold temperatures outside. She talked about what this year's spring home market looks like. She also gave tips on what people can do to get their homes prepared for selling.

Utah Business Forbes (aired 3/13/14 at 7am for :30) - Two Utah cities got high marks for their outlook on giving people jobs in the next few months. Forbes magazine came out with a list of the top hiring cities in the country, and Provo was number one on the list. Salt Lake City was number 4. They asked businesses all over the country what their outlook for new jobs was, and these two cities made the top 4. This only included plans to hire in the next quarter of the year.

New PS4 Headset (aired 3/19/2014 6:15pm :30) - Sony is showing off a new virtual reality headset for the PS4. The company unveiled the project at the game developer's conference in San Francisco. Viewers into gaming learned a new accessory that they can buy.

Pandora One Cost Goes Up (aired 3/19/2014 6:15pm :30) - Pandora is raising the cost of its ad-free subscription music streaming service. The price will go up to \$4.99, up a dollar from the previous rate. Viewers who use Pandora learned about the price hike.

Credit Score Access Proposal (aired 3/25/14 @ 4:30pm, 2:15) - Al Bingham, a financial advisor stopped by the newsroom to talk about a new proposal from the Consumer Financial Protection Bureau, or CFPB. The CFPB wants to require credit card companies to provide consumers with a monthly report detailing their credit score. Bingham says making the change, would help people score better interest rates and save money.

YOUTH AND FAMILY

No Poke System (aired 1/3/14 at 5pm runs 1 minute 15 seconds) - Babies born prematurely will undergo a lot of tests while they are in the NICU. Between the IVs and blood work, a baby could get poked hundreds of times. Doctors are now looking into whether those tests are necessary. At Dixie Regional Medical Center in St. George doctors are trying to reduce the amount of tests that a premature baby will undergo during their hospital stay.

Working from Home (aired 1/10/2014 @5pm, 2:00 minutes) – Working from home is on the upswing in the United States. Experts estimate that by the year 2016, the number of people who work from home will grow by 21%. A Gallup report also shows nearly four in ten employees spend some amount of time working remotely or in locations apart from their co-workers. One mom featured in our story said that working from home helped them deal with their home life, including helping with family dinners and family activities. Our story also gave tips to those considering working from home on how to speak with management about making the change.

Utah Kids & E-Cigarettes (aired 1/23/14 @4:00pm, 1:45) - The Utah Health Department claims fewer teens are smoking traditional cigarettes, but more are turning to e-cigarettes for a nicotine fix. Representative Paul Ray said 30% of teens in Weber County admit using e-cigarettes and announced he plans to introduce a bill in the legislature that would make it harder for teens to obtain the devices.

Preconception Visit (aired 1/24/14 at 5pm runs 1 minute 15 seconds) - Right now, many female viewers may be thinking about trying to become pregnant. Experts say before you start trying, you should go see your doctor for a preconception visit. During this visit, you and your doctor can discuss things like your diet, weight, and medical history.

Swallow Dangers for Kids (aired 02/07/14 at 5pm runs 1 minute 15 seconds) – It is inevitable that your child will likely swallow something they shouldn't and in most cases, it's harmless. However, doctors say they are seeing more cases of kids swallowing objects that are dangerous. Doctor Thomas Sutton is a pediatric gastroenterologist at Utah Valley Regional Medical Center. He says the most common items kids will swallow include coins, toys and toothpicks. He is also seeing an increasing number of children swallowing batteries. The chemicals inside batteries can eat through the tissue of a child's GI tract, another concern for doctors are magnets. Items like marbles and parts of toys will likely pass on their own; however, coins, batteries and sharp objects need to be removed immediately by a physician.

Kids & Caffeine (aired 2/10/2014 @5pm, 1:30 minutes) – A new study shows that almost 75% of kids have caffeine every day. Experts with the Centers for Disease Control and Prevention were surprised to learn that much of that caffeine comes from coffee and energy drinks. They say that's concerning, because coffee and energy drinks can contain much higher amounts of caffeine than soda and iced tea. The American Academy of Pediatrics says caffeine has no place in a child's diet because it's a mild stimulant and can be potentially harmful. Caffeine could also have emotional and physical side effects for kids like anxiety, panic attacks and even high blood pressure.

Newborn Hearing Tests (aired 02/14/14 at 5pm runs 1 minute 15 seconds) - Hearing loss is the most common birth defect in Utah. According to the Utah Department of Health, every year, three out of a thousand babies are born with permanent hearing loss. That is why your baby will have a hearing test before he or she leaves the hospital.

Todd Hoffman is an audiologist at Utah Valley Regional Medical Center. He administers hearing tests to babies about a day or two after they are born. The test he does is actually mandated by law. If the baby fails the test they will be sent to a specialist for more testing.

Pac Sun T-shirt Controversy (aired 02/17/2014 @10pm, 2:30 minutes) – An Orem mom is not happy with a mall window display she calls pornographic and because the store refused to take the offensive shirts off display, she bought every t-shirt the store had in stock. She says the shirts violate the city's decency code and when no one would do anything about it, she gladly spent near 600 dollars to buy all the shirts. This story explains her reasons for doing what she did and what she plans on doing next.

The Potty Watch (aired 02/21/14 at 5pm runs 1 minute 15 seconds) – Potty training is something many parents dread. First, you have to figure out whether your child is ready. And when they are ready, where do you begin? Every parent has stories of success. We spoke to one busy mom who uses a potty watch with her 2-year-old son, Korver. Korver Kennedy is one of 4 children and potty training hasn't been so easy for mom Melanie. She uses a potty watch as a reminder. The potty watch is a watch that you can buy at the store. You set a timer and when the music starts playing, it's time to run your child to the restroom.

First Lady & Vending Machines (aired 2/25/14 @4:00pm, runs 1:20) - Michelle Obama and the Secretary of Agriculture spoke out against vending machines in America's schools. Together they proposed limiting the calories, fat and sugar of items sold in schools. Opponents argued that healthier foods will cost more and that could leave some kids who don't have much money with nothing to eat.

Adoption Lawsuit (aired 2/26/2014 @5:30am, :25) – The Utah Supreme Court has ruled in favor of a man challenging the constitutionality of the state's adoption laws. Christopher Carlton filed the suit in 2010 after his girlfriend came to Utah and gave their child up for adoption without his permission. This story updates viewers on the case, and what it could mean for adoptions in the state.

Gay Marriage & Advocates (aired 2/28/2014 @6:00am, 35 seconds) – A group of Same sex couples spoke at the Capitol building, after they say Utah's Attorney General set policy to deny their adoption rights. This story lets viewers know why the group says they're being denied adoption and the latest in the division on Gay Marriage rights in Utah.

Pre-term Births (aired 03/07/14 at 5 pm runs 1 minute 15 seconds) - Pre-term births are the leading cause of newborn deaths in the U.S. A collaborative study between Intermountain Medical Center and the University of Utah has identified a new approach to preventing pre-term births. Statistics show nearly half a million babies are born prematurely every year in the United States. Doctor Sean Esplin is a maternal fetal medicine specialist at Intermountain Medical Center in Murray. He was one of the authors of a study that looked into whether doctors could prevent premature births.

Progesterone is a hormone that is naturally produced during pregnancy. This study showed that injections of progesterone early in pregnancy reduced the risk of having another preterm birth by about a third.

Driving Test Bill (aired 3/10/14 at 7:30am for :30) - The state legislature considered a new bill requiring a new driving test. The bill would have Utah teens take a final written exam before they get behind the wheel with a driver's license. Representatives say the test will focus on how to avoid fatalities on the road. The bill passed unanimously in the house, then went to the senate for a vote on this day.

LDS Anti-bully Video (aired 03/12/2014 @ 10pm, 2:30 minutes) – A video aimed at putting an end to teenage bullying is getting major hype and is going viral on social media. The video was made by the LDS Church with the help of local teens and paints a very real picture of what many teens go through on a daily basis. The ten minute video shows a young man involved with other kids at school who bully fellow students. Eventually the boy's own sister becomes a victim of cyber bullying. The anti-bully message is summed up in two words, "stop it." The video has been viewed more than half a million times. This story gives our viewers a better understanding of what some kids face as they go to school and shows viewers what is being done on the local level to try and stop bullying.

Sex Abuse Bill (aired 3/13/14 at 7am for :30) - A measure aiming to prevent child sex abuse by creating an awareness program in Utah schools went to the Governor for his signature. The bill lets schools choose whether to teach students what to do if they are abused. The measure has the backing of former kidnapping and sexual assault victim Elizabeth Smart.

Vaginal Births After a C-Section (aired 03/14/14 at 5 pm runs 1 minute 15 seconds) – Statistics show that most women who had a cesarean delivery can still have a natural delivery with future pregnancies. We spoke with Angela Anderson, the director of the Intermountain Nurse/Midwifery program at Intermountain Medical Center. She says a vaginal birth is a safe option for most women who have had a prior cesarean delivery. If a woman is interested in having a natural delivery after a c-section, she should discuss it with her primary care physician.

Cannabis Girl Dies (aired 3/16/14 at 7am for 45 seconds) The young girl who inspired an effort that resulted in the legalization of medical cannabis oil in Utah has died. Charlee Nelson was six-years-old. Her father believes his daughter "held on" for the legislation to pass. The oil comes from the marijuana plant and is said to help children who have severe epilepsy.

Honda Recall (aired 3/16/14 at 7am for :30) Honda is recalling nearly one million minivans over a defect that could cause a fire. It applies to the Honda Odyssey vehicles made between 2005 and 2010. The company says a defect could cause the car to burst into flames. This is a popular family car and would affect many families.

Food Packaging Sensors (aired 3/17/2014 @5pm, 1:30 minutes) – Expiration dates on food may soon be a thing of the past. Scientists have invented a smart tag that can help families know when food has gone bad in the fridge. It's estimated the average American family throws out more than \$2,000 of food every year. But new smart tags could help keep that number down. The gel based and temperature sensitive tags are put on the packaging and change color over time—showing the rate at which food goes rotten. The inventor of the tag hopes it will help keep parents from throwing out valuable food and wasting money.

Utah Taxes (aired 3/19/14 at 7am for :30) – There is big news for Utah's tax paying families. The website "Wallethub" places Utah at number 14 for lowest taxes in the nation. The news gets better if you figure in cost of living - then Utah has the 10th lowest taxes. According to the site, Utahns pay just over six thousand dollars a year on average in taxes.

Liquid Nicotine Poisoning (aired 03/24/2014 @10pm, 2:30 minutes) – E-cigarettes are becoming more popular with adults and they are becoming more of a danger to kids. An increase in the number of child poisonings is being linked to the personal vaporizers. Health officials say parents are leaving the vaporizers around and kids are picking them up, inhaling them and getting sick. In 2012, there were 9 calls about kids getting into vaporizers. Last year that jumped to 47 possible poisonings and so far this year, 21 calls. This story explains the problem and explains what parents need to do to keep their kids safe.

Paper Box Pilots (aired 03/25/2014 @10pm, 2:30 minutes) – At just 13 years old, a Utah county teen has turned a simple idea into a clever money maker and is the CEO of a profitable company. "Paper Box Pilots" sends you a kit which customers use to turn an ordinary cardboard box into an airplane. The business was launched last October and so far has sold nearly 1,000 kits. This story shows our views how local teens are doing great things in the community and shows our younger viewers that they too can turn a simple idea into a successful business.

ENVIRONMENT

Utah Growing (aired 1/1/2013 @5am, :20) – According to new census data, Utah is one of the fastest growing states in the country. Over the past year, Utah's population grew by 46,000 people. This story tells viewers how fast our state is growing and possible repercussions for the future.

Dead Eagles (aired 01/07/2014 @4:30am, :30) – Utah Wildlife officials say the number of bald eagles killed by the West Nile Virus has climbed to 40, and five more birds are in rehab. This story lets viewers know how many birds have gotten sick and what's killing them.

Volcano Fears (aired 1/9/2014 @5pm, 2:00 minutes) – A super volcano is located under Yellowstone National Park. Researchers at the University of Utah discovered that the molten rock reservoir under the volcano is a lot bigger than people thought. When

the volcano erupted two million years ago, it was 2,500 times more powerful than the Mt. Saint Helens volcano back in 1980. Scientists say the magma under the volcano located in the park is two and a half times larger than once thought. Heat from the magma drives Yellowstone's geysers, like Old Faithful. The super volcano has erupted three times, and scientists don't know when it will happen again. But they say they will see it coming, and that Utah will experience hundreds of earthquakes when it does happen.

Oil Shale (aired 1/15/14 at 7am for :30) - A new company is trying to move into the "oil shale" business in Utah. The Salt Lake Tribune says that the British company Tom Co Energy filed to mine on state land in Uintah County. The company expects to start mining shale in a few months. They say they will use a new method for getting the oil that they say is more environmentally friendly.

Athletes for Clean Air (aired 01/16/2014 @10pm, 2:30 minutes) – Some local athletes are joining forces to call attention to the air quality problem in Utah. The group, Athletes for Clean Air, spends a lot of time outdoors training and competing and they hope their united voice help clean up the air. This story explains what the group plans to do to get state officials attention and changes they would like to see made. This lets viewers know that another group has joined in the fight to clear out the bad air and explains what the Governor says he is doing to help fight the problem.

Bald Eagle Findings (aired 1/20/14 at 7am for :30) - The National Wildlife Health Center has released their findings into what has killed more than 50 bald eagles in Utah. Experts say migrating "eared grebes" are what have been passing the West Nile Virus onto the bald eagles. According to the salt lake tribune, up to 20,000 grebes died last year and officials believe eagles feasted on the infected birds.

No Water (aired 1/21/2014 @ 5pm, 1:30 minutes) – In January Utah water officials stated that this year's snowpack in Southern Utah is not ideal. Officials say the snowpack for Southwest Utah has dropped to 67% of normal. Statewide, snowpack is at 75%. Without more snow, there won't be enough spring runoff to recharge reservoirs. Dry weather also made the water levels in Lake Powell unpredictable. Experts say some late winter storms could salvage the season.

Bad Air Bills (aired 01/22/2014 @10pm, 2:30 minutes) – Utah Republicans and Democrats are coming together on 15 bills focused on clearing out the inversion. This story explains what options lawmakers are looking at, including cutting back on incinerator waste and getting people to switch from wood burning stove and fireplaces to a cleaner form of heat. This story keeps our viewers up to date on the efforts being made to clean up the air and that law makers plan to tackle the issue during the upcoming legislative session.

Exercise During an Inversion (aired 1/23/14 @4:00pm, 1:20) - Doctors claim the inversion makes outdoor exercise in Utah a hazard. We interviewed a Sports Medicine specialist who said a good way to avoid the inversion is to exercise in the mountains

where the air is cleaner. He also suggested skipping runs every few days, in favor of an indoor activity like swimming or weight lifting.

Stericycle Moving? (aired 01/24/2014 @10pm, 2:30 minutes) – A controversial medical waste incinerator may be moving out of Davis County. Stericycle started the process to move to a remote part of Tooele County. Neighbors have been protesting the incinerator for months after state officials cited the company for exceeding emission levels. This story explains what has to happen before the company could move and when the move could actually be a reality.

SLC Green Segment (aired 1/25/14 at 7:50 am for 2:30 minutes) The people from SLC Green spoke in studio to talk about saving energy. They presented numbers on the money that people can save if they turn off the power for a certain amount of time during the day. They also showed how good it would be for the environment if people turn off their power more. They had charts and graphs as visuals, as well as light bulbs.

California Drought (aired 1/31/14 @4:30pm, 1:30) Roughly 90% of California is experiencing drought conditions. Water levels at several lakes and reservoirs are below 40%, and water sports businesses say the drought is hurting their business. Elsewhere, farmers say the lack of water is making it more expensive to grow crops. Analysts expect higher produce prices this summer.

Stericycle Study (aired 02/11/2014 @10pm, 2:30 minutes) – A new health study shows elevated cancer rates in the area surrounding the medical waste incinerator, Stericycle. This facility has sparked heated debate among community members who believe the incinerator is emitting harmful pollutants into the air. According to the new study, the elevated cancer rates probably has nothing to do with Stericylce but residents say the study is further proof that the facility needs to go.

Stericycle Study (aired 2/14/14 at 7:30am for :30) - Opponents of the medical waste incinerator Stericycle tried to reject a state health study on cancer rates surrounding the facility. The health department's study found the elevated cancer levels people experienced around the facility were not those caused by exposure. People who lived around the plant at the time wanted Stericycle shut down completely, but the state legislature passed a bill to get them moved.

Clean Air Bills (aired 2/19/14 at 7am for :30) - Lawmakers have their own view of their work done on clean air during the legislative session. The Utah House's bipartisan "clean air caucus" says Utah lawmakers approved a record number of bills in an effort to tackle the state's air pollution issues. They also say lawmakers approved 4.7 million dollars aimed at improving air quality.

Pollution Laws (aired 2/19/14 at 7am :30) - Utah advocates are calling for more laws to cut pollution and are handing out grades to lawmakers. The groups graded Governor Gary Herbert and state legislators for their efforts to address air quality during the 2014 legislative session. The governor earned a "B" and lawmakers in the house earned a

"B-" but the senate got a "D". They say the governor and house made some moves for cleaner air but gave the senate the "D" after a measure to strengthen state regulators' power failed to get a vote.

Stericycle Officials Talk (aired 02/19/2014 @10pm, 2:30 minutes) – The Stericycle medical waste incinerator in North Salt Lake is one step closer to leaving town. A house committee advanced a bill today that would give the green light to building a new facility in Tooele. Representative from Stericycle spoke for the first time on-camera about the controversy surrounding their facility. This story continues to follow the ongoing battle between people who live near the incinerator and the company who operates the facility.

Driving Tax Credit (aired 2/25/14 at 7am for :30) - A new bill offering an income tax credit if you buy monthly transit passes during bad air months was introduced to the state legislature. The bill offered credits for buying transit passes through January, February and July - the months when inversions and pollution are usually the worst. The credit would be 25% of the cost of passes, up to \$50.

Drought Help (aired 02/25/2014 @5:30am, :25) – Governor Gary Herbert is asking the Federal Government for more help during drought season. Herbert pressed President Obama on the topic during a meeting. This story lets viewers know what their lawmakers are doing about water issues.

Mussel Infestation (aired 2/25/2014 @5pm, 1:30 minutes) – The dropping water level at Lake Powell has revealed an alarming discovery—thousands of invasive clams are attached to canyon walls, the dam and other structures. These clams could end up costing taxpayers millions of dollars. The Quagga mussels colonize on its body so it builds up layer after layer in water pipelines, and eventually clog the pipeline. Water officials say to try and prevent that, they will use chemicals in the pipeline to try and kill the clams.

Environmental Concerns (aired 03/04/2014 @10pm, 2:15 minutes) – Dozens of Utah businesses have less than four months to comply with the new clean air regulations and for some companies this could mean buying thousands of dollars in new equipment. This story explains the new regulations and lets our viewers know that the state has money to help them make the changes. This is an ongoing effort by the state to try and clean up the state's bad air quality.

Mass Transit Bill (aired 3/5/14 at 7:30am for :30) - A proposal is defeated that would help clean Utah's air by encouraging more mass transit riders. The Salt Lake Tribune says lawmakers ended talks to give a tax credit to those who buy transit passes during months where the inversion is at its worst. Opponents say the bill failed because it made the state give more money to mass transit as taxpayers pay for as much as 80% already.

Hive Pass (aired 3/6/14 at 7am for 45 seconds) - The sale of UTA's new "hive pass" is off to a great start, but only people in Salt Lake County can get their hands on it. Riders get an all access pass for less than a dollar a day. There has been a big push from some to get more people on public transportation to help keep the air cleaner.

Wildfire Season Worries (aired 3/6/2014 @5pm, 1:30 minutes) – Wildfire officials in Southern Utah are planning for what could be a very active fire season. Their main worry is dry conditions because of a lack of snowpack. In Southwest Utah, the snowpack has dipped to just 47% of normal, so firefighters are preparing now for possible wildfires this summer. The rains last fall also resulted in a bumper crop of invasive grasses in the lower areas, providing supercharged fuel for fires. Fire officials may put fire restrictions into place as early as mid-May. They are asking the public to get prepared and make sure there is defensible space around their homes.

DIVERSITY

Same Sex Marriage Petition (aired 01/9/2014 @10pm, 2:30 minutes) – An online petition aimed at swaying Governor Herbert on same sex marriage has grown to over 40,000 signatures. The petition will be delivered to the Governor following a rally on the capitol steps. The hope of those who signed the petition is that the Governor will change his mind about appealing the federal judge's ruling that says Utah's ban on gay marriage is unconstitutional. This story explains why the person who started the petition did so and lets our viewers know how they can get involved on either side of the issue.

Lee's Religious Liberty Bill (aired 01/09/2014 @10pm, 2:15 minutes) – Utah Senator Mike Lee has introduced a bill designed to protect religious organizations that do not support same sex marriage. The bill would protect the tax exempt status of an organization that refuses to marry gay couples. But some say instead of protecting religion, the bill allows for discrimination. This story explains why Senator Lee proposed the bill and why equality groups say the bill is misleading and dangerous.

Trayvon Martin Mom (aired 01/10/2014 @4:30am, 35 seconds) – The mother of slain teen Trayvon Martin will speak at the University of Utah in observance of Martin Luther King Jr. Day. She'll be speaking about racial profiling. This story lets viewers know where and when they can listen to her speak.

Same Sex Marriage and Kids (aired 01/13/2014 @10pm, 2:30 minutes) – Children are the focal point of the debate over whether to legalize same sex marriage in the state. Utah officials are arguing that children raised by same sex parents are at a disadvantage. In this story we talk to a man who was raised by two mothers. This story gives our viewers a firsthand account of what it was like to grow up in home with same sex parents and explains why this man doesn't feel like he was at a disadvantage. The story also explains that there are studies supporting both sides of the argument.

Possible Sam Sex Marriage Class Action Lawsuit (aired 01/14/2014 @10pm, 2:30 minutes) – The ACLU is preparing for a possible class action lawsuit against the state of Utah. The lawsuit would be focused around the more than one thousand couples who

were married legally in the state during a two week period. Those couples are now in limbo as they wait for an appeal court to hear the case. This story explains why the ACLU thinks they have a case, whom would be eligible to join the suit and when a decision is expected to be made whether to move forward with the class action suit.

Same Sex Marriage and Work Force Services (aired 01/15/2014 @10pm, 2:45 minutes) – A Utah state agency has decided to honor at least one gay marriage despite Governor Herbert telling them not to recognize the legal unions. One couple claims work force services is recognizing their marriage because it benefits the state. They say honoring their marriage means one spouse will no longer get disability benefits because being married changes his income status. The Governor's office says because the process of changing the man's status to married had been started, it had to be finished. This story explains the ongoing confusion surrounding same sex marriages and lets the viewer decide if this is a double standard.

AG to Name Counsel (aired 01/16/2014 @4:30am, 35 seconds) – Attorney General Sean Reyes will announce the special counsel he's hiring to assist his office defense of Utah's same sex marriage ban. This story lets viewers know about the most recent legal happenings in the case.

Massachusetts Recognize Marriages (aired 01/17/2014 @4:30, :30) – The State of Massachusetts says it will recognize same sex marriages that were performed in Utah before the hold. This story lets viewers know that another state is willing to recognize those marriages even though Utah is not.

Utah Attorneys Update (aired 01/17/2014 @4:30am, :30) – Utah will spend \$300,000 dollars to bring in a team of three outside attorneys to help defend the state's same sex marriage ban before the Federal Appeals Court. Gene Scaerr has been hired to lead the team with help from John Bursch and Monte Neil. This story updates viewers to who will be representing Utah in the case.

Same Sex Marriage Appeal (aired 01/20/2014 @5:00am, 40 seconds) – Lawyers for Utah's same sex couples are asking a Federal Appeals Court to deny the state's request for more time in preparing Utah's defense of its same sex marriage ban. This story is an update to the latest in the state's same sex marriage ban.

Governor Herbert on Same Sex Marriage (aired 1/23/14 @ 4:00pm, 1:00) 2News reporter Rod Decker interviewed Governor Gary Herbert about same sex marriage. The Governor reaffirmed his support for traditional marriage and said 2004's Amendment 3 proves a majority of Utahns feel the same way.

Dueling Rallies (aired 1/28/14 at 7am for ::30) - People held two different and dueling same sex marriage rallies at the capitol. The Salt Lake Tribune reported same sex marriage supporters would get together for "a rally for equality" on Utah's Capitol steps. Those who support the ban on same sex marriage in Utah would follow that up with a rally of their own inside the capitol later in the evening.

Anti-Discrimination Bill (aired 01/31/2014 @10pm, 2:15 minutes) – Republican State Senator, Steve Urquhart is pushing a law which would protect the LGBT community from discrimination in the workplace and housing. This is the 6th year in a row he has been trying to get an anti-discrimination bill signed into law but this year he knows it will be a battle. This story explains why Urquhart feels the biggest challenge will be getting lawmakers to understand that the bill can go forward without affecting the gay marriage court case.

LDS Dress Article (aired 02/18/2014 @10pm, 2:30 minutes) – An article in an LDS church magazine has sparked controversy. The point causing concern is something referred to as the rape mentality; meaning that if a woman dresses provocatively, what happens to her next is her fault. Tod R. Callister, an LDS General Authority, said “the dress of women has a powerful impact on the minds and passions of men; if it's too low too high, too tight it might prompt improper thoughts in the mind of a young man striving to be pure.” Critics say the article creates fear instead of a healthy conversation about human sexuality.

New Utah City (aired 2/21/14 at 7am for :30) - Holladay is the 20th Utah city to pass an ordinance that bans discrimination in housing and employment based on sexual orientation or gender identity. The Salt Lake Tribune reports that the ordinance passed in a 5 to 1 vote last night.

Arizona Bill (aired 2/26/14 at 7am for :30) - A bill in Arizona that pitted religious freedom against civil and gay rights is now vetoed. The bill would have allowed businesses to refuse service to gays based on religious grounds. Corporations and businesses threatened to boycott the state of Arizona because of the law. Similar legislation is being considered in several other states. Lawmakers in Ohio recently withdrew a similar bill.

LGBT and Lawmakers Meeting (aired 02/26/2014 @10pm, 2:45 minutes) – Lawmakers held a meeting with members of the LBG^T community, despite the fact that state legislators are holding off on adopting an anti-discrimination bill this year. Dozens of people showed up to share their personal stories of discrimination. It turned into an emotional night, not only for those who spoke out but for many of the lawmakers as well. This story informs viewers how state officials are trying to reach out to the LBG^T community and how this meeting with help as legislators move forward on the issue of discrimination.

Gay Adoption (aired 2/27/14 at 7am for :30) - A group of same sex couples spoke at the capitol building. They say Utah's attorney general set policy to deny their adoption rights. They say as they file for adoption Attorney General Sean Reyes is filing memorandums in each case asking the judges to deny couples the right to adopt. Utah law says that legally married couples can petition for adoption and individuals can petition for adoption by themselves, but couples not legally married cannot petition for adoption together.

Same Sex Marriage Filings (aired 03/03/2014 @ 10pm, 2:30 minutes) – Dozens of court documents were filed by individuals and businesses in support of and against gay marriage. A local restaurant was among those who decided to take a political stand to the issue of same sex marriage. This story explains why the owner of Tony Caputo's Deli decided to get involved in the court case. His argument is that a ban on gay marriage is bad for business and hampers the ability to recruit and retain top talent. In all about 50 amicus briefs were filed and there were about split on both sides of the issue. They will now be reviewed by the appellate court.

Capitol Rally (aired 3/5/14 at 7:30am for 45 seconds) - Hundreds of people supporting a statewide anti-discrimination law rallied today at the state capitol. The group also honored 13 protesters who were arrested three weeks ago. More than 200 supporters gathered at the capitol to support the bill that would protect citizens against jobs and housing discrimination. Republican senator Steve Urquhart sponsored the anti-discrimination bill. He said gays and their allies will work for it and it will eventually pass.

Gay Marriage and The Economy (aired 03/06/2014 @ 10pm, 2:30 minutes) – Utah's jobless rate has dropped to its lowest point in five years but some say it could even be better if there was marriage equality. A businesses recruiter believes the fight over same sex marriage is about more than a moral issue. She says technology companies are less likely to move into the state because they cannot offer their employees the same rights they can in other states. This story explains how a ban on gay marriage is impacting the state in a way some viewers may not have thought of and explains how the marriage equality could be a boost to the state's business community.

Ordain Women (aired 3/9/14 at 7:30am for :45) - A group called 'Ordain Women' says they will ask to be let inside the men only LDS priesthood meeting next month. A spokesperson says they expect about twice the number of people as the last time they tried. The group wants the LDS church to reorganize their hierarchy to include women in more of the top positions. The LDS church already said the group will be turned away.

Gay Marriage Court (aired 3/12/14 at 7:30am for :30) - A federal judge will hear arguments on a lawsuit to get Utah to recognize the marriages of the 1,000 same sex couples who were legally married last year. The lawsuit was filed by the American Civil Liberties Union on behalf of the couples. Last month the ACLU filed for the state to officially recognize the same sex marriages while the lawsuit continues.

New Marriage Group (aired 3/17/14 at 7am for :30) - A former U.S district attorney asked Utah officials to reverse the state's ban on gay marriage. Brett Tolman co-chairs "Utah Unites for Marriage", a new group advocating for gay marriage in the state. They presented their case to the state. The Denver based 10th circuit court of appeals will hold a hearing on the case April 10th.

HEALTH/HEALTHCARE

Inversion Health Concerns (aired 01/02/14 at 4 pm runs 1 minute :30) – The Wasatch Front is notorious for its inversions. The Utah Department of Environmental Quality has issued a red alert for this week. Doctors say the bad air can cause health problems. People can get watery eyes and a scratchy throat in addition to coughing. Doctors warn the bad air can cause long term consequences to your health. They advise that you remain inside on bad air days.

Running Indoors on Bad Air Days (aired 01/02/14 at 5pm runs 1 minute 15 seconds) - A new year means new goals to get in shape. But the bad air may derail your plans to exercise more in 2014. Luckily, you can run indoors at places like the Olympic Oval in Kearns. The Oval is not just home to winter sports like speed skating and hockey. Inside the facility is a 442 meter track where you can run, walk, sprint, or do whatever you need to do to get in shape.

Sperm Switcher (aired 01/08/2014 @10pm, 4:30 minutes) – A couple who underwent artificial insemination at a Utah fertility clinic discovers the husband's sperm had been switched with someone else's. The couple discovered their daughter's biological dad was a convicted felon who served time for kidnapping. This story explains how the family found out, let's our viewers know where it happened and explains what the hospital is doing to find out if this is the only case or if there could be other victims out there.

Strength Program for Seniors (aired 01/09/14 at 4 pm runs 1 minute :30) – Many people have the goal to lose weight and maybe get into shape for the New Year. Older people might have a goal to get a little stronger. If one is hesitant about going to the gym, you can sign up for classes at the LiVe Well Center at Dixie Regional Medical Center. Trainers at the LiVe Well Center will customize programs for seniors to help them improve their strength, balance, and overall confidence.

Weight Loss and Nutrition with Intermountain Healthcare (aired 1/14/14 at 7:50am for 2:30 minutes) - During one of their regular visits to the 2News Studio, Intermountain Healthcare spoke about healthy weight loss and nutrition tips for those that want to call in and ask. They had a group of people on phones throughout the show to take calls and answer people's questions. They also had experts available in each segment to talk about why Intermountain Healthcare was there and give a little bit of generic weight loss and nutrition advice.

Gym Intimidation (aired 01/16/14 at 4 pm runs 1 minute 15 seconds) - For many people, the hardest part of working out is not the cardio or spin class; it is walking into the gym. Exercising has many benefits and it is important to exercise on a regular basis. However, fear is keeping many people from going to the gym. One reason for that fear is the atmosphere of the gym can be intimidating. Experts offer the following advice to help you overcome gym intimidation: have a plan of attack before you show up to the gym; research movements and classes ahead of time; ask the staff for help; go with a friend or a group of friends.

Pregnancy and the Flu Season (aired 01/17/14 at 5pm runs 1 minute 15 seconds) - The common cold and the flu are both making their rounds in Utah. In fact, the Utah Department of Health says more than 400 people have been hospitalized in Utah from flu related problems. Doctors warn that pregnant women may be more susceptible to getting sick this time of year. They say if you are pregnant and do get sick, the most important thing you can do is rest. If you have mild symptoms, try to avoid taking medications. However, Doctor Tanner says there are many medications that pregnant women can take to help relieve symptoms for a cold or the flu. But be sure to talk to your doctor or pharmacist.

Exercising and Inversions (aired 01/23/14 at 4pm runs 1 minute) – Doctors say exercising in inversions can be risky to your health. If you need to run or workout outdoors, they say you should head to Park City or up the mountains to get exercise. They say you can snowshoe instead of run. You can also take your workouts to the gym or a local running track.

Volunteers Needed for MS Study (aired 01/23/14 at 5 pm runs 1 minute 15 seconds) - Researchers are asking for volunteers for a study that could unlock the mysteries of Multiple Sclerosis. Multiple Sclerosis is a disease that attacks the central nervous system. Doctors say it is very common in young adults in Utah. Currently, there is no cure for Multiple Sclerosis but doctors say there is hope. Researchers at the University of Utah are trying to determine if there are markers of MS that can be discovered before symptoms of the disease even surface. They currently need volunteers to participate in the study.

Twin Tested: Intermountain Healthcare Visit (aired 1/23/14 at 7:50am for 2:30 minutes) - Brooke and Brittany Graham are twins who work at 2News and one of them fainted on air during a skiing segment in December. They both went to the medical center and got tested for what makes them faint on the ski slopes. This was for people who may have the same problem and were wondering what is happening to them. One of the twins got an MRI and discussed it with a specialist.

Importance of Folic Acid (aired 01/31/14 at 5 pm runs 1 minute 15 seconds) - A lot of recent studies are questioning the effectiveness of multivitamins. Some experts claim they are a waste of money. However, there is one vitamin that should not be overlooked if you are pregnant or are planning to become pregnant. Studies looking into the effectiveness of folic acid have been proven time and time again. Experts say folic acid can help prevent birth defects such as spinal bifida. If you are thinking about becoming pregnant, you should take at least 400 micrograms of folic acid every day. A great source of folic acid is prenatal vitamins. Prenatal vitamins also have other nutrients that are proven to be both safe and effective.

Sleep Problems May Stem from Structure of the Face (aired 02/06/14 at 5pm runs 1 minute :30) - Millions of people suffer from sleep problems. In fact, experts say there is evidence to suggest that the large percentage of the population is not even getting 6

hours of sleep. We know that factors such as weight and caffeine can cause sleep problems. Sleep problems can cause health problems as well. One doctor told us that one factor of sleep problems may be the shape of your face. For example, if you have a long, skinny nose, you may have trouble breathing air while you sleep and that can cause sleep apnea. Treatment for sleep problems can vary depending on the person. In most cases, doctors will have you use a CPAP machine. The machine will help keep the airway open while you are asleep. If you are having trouble sleeping, the best advice is to see your doctor.

Sleep with Intermountain Healthcare (aired 2/11/14 at 7:50am for 2:30 minutes) All morning on 2/11/14 we had Intermountain Healthcare in studio to talk about sleep health. They covered everything including best sleep practices, the right kind of bed to sleep on and when to sleep. Experts spoke to the anchors about sleep. We also had a group of Intermountain employees on the phones so that people could call in and ask their questions about sleep.

Harp Music Can Help Patients Heal (aired 02/13/14 at 4pm runs 1 minute 15 seconds) - Medicine and harp music have a history together that dates back to the ancient Greeks. According to Greek mythology, the Greek God Hermes played an instrument similar to a harp to sooth anger and stress. Modern day studies show that harp music can very therapeutic and even promote healing. At Utah Valley Regional Medical Center in Provo, guests are welcomed with the sounds of the harp as soon as the walk through the doors. Volunteers play the harp for patients and visitors in the lobby of the hospital. The harp was donated to the hospital through the Utah Valley Healthcare Foundation. Volunteers are on hand to play the harp 4 days a week. The hospital hopes more volunteers will play music throughout the week. The music not only helps patients, but it also helps the staff at the hospital.

Teen Cancer Fighter (aired 02/13/2014 @10pm, 4:00 minutes) – Doctors in Utah and all over the world want to find a cure for cancer and a local high school student has joined the effort. Neveen Rathi is only 17-years-old but is already doing cancer drug research at the University of Utah. He is helping test a device that can feed different drugs through small channels and then test up to 48 drugs at one time on the patient's cancer cells. This story shows our viewers how a high school senior is working to find a cancer cure and highlights the ongoing research being conducted in Utah.

Autism Insurance Bill (aired 02/14/2014 @10pm, 2:30 minutes) – A bill that would provide insurance coverage to families with autistic children cleared its first hurdle this legislative session. A senate committee voted to support the legislation that would mandate insurance coverage for autistic kids. This is the second year a measure like this has gone before the legislature and supporters say a new pilot program shows that treatment is not expensive but it is effective. Utah has a high number of families with autistic children and this story keeps them informed on where the legislation stands and the chances it has to become law this year.

Eye Infections (aired 2/20/14 at 4 pm runs 1 minute 15 seconds) - Conjunctivitis is one of the most common infections among children and adults. Conjunctivitis, or pink eye, can be caused by either bacteria or viruses. Pink eye was trending online last week, after television host Bob Costas contracted the infection apparently while in Russia covering the Winter Games. We spoke to Doctor Randy Carter with the Eye Institute of Utah. He says like a common cold or flu bug, eye infections are very contagious. Doctor Carter says you should also treat the infection no differently than if you have a cold. You should stay home and rest. You also wash your hands regularly. If your kids have conjunctivitis, they should also remain at home until the infection is gone.

Backcountry Safety (aired 2/27/14 at 4 pm runs 1 minute 15 seconds) - Many people have spring fever and in a few weeks, spring conditions will attract skiers and snowboarders to the backcountry. But doctors warn, avalanche danger isn't the only thing you need to be prepared for while in the backcountry. Doctor Jeoff Crocket is an emergency room physician at Park City Medical Center. He says you should always be prepared when you head into the backcountry. First, you should ALWAYS carry a beacon. Second, carry supplies you could use in case of an emergency.

Getting Kids to Eat Healthy (aired 2/27/14 at 5 pm runs 1 minute :30) - According to health experts, about half of what your child eats is supposed to be fruits and vegetables. But getting kids to eat healthy can be tricky especially if they are picky eaters. Fruits and vegetables both have nutrients that are important for children. We spoke with Kayla Leitzke, a registered dietician with Harmons. She says parents shouldn't force their children to eat their fruits and vegetables. Instead, you can sneak healthy foods into their meals.

Bed Rest (aired 2/28/14 at 5 pm runs 1 minute 15 seconds) – There are a number of reasons why doctors will prescribe bed rest to pregnant women, but there are cases where a woman will have to be admitted to the hospital weeks before her baby is due. If a pregnant woman is experiencing complications during her pregnancy, and needs to be monitored closely, she will be admitted to the hospital for observation until she delivers her baby.

Allergy Season (aired 3/6/14 at 4 pm runs 1 minute 15 seconds) - Trees and flowers are getting ready to bloom and that means you may want to pack some extra Kleenex if you suffer from allergies. The biggest culprit in early spring is tree pollens. Pollen can travel for miles so even if you don't have trees in your yard, you can still get allergy symptoms. Sneezing and itchy eyes are just a few symptoms of allergies. Over-the-counter medications and nasal sprays can help relieve the symptoms.

E-Cigs Bill (aired 3/10/2014 @6:00am, :30) – A senate committee snuffed out a bill to regulate the sale of electronic cigarettes in Utah. They suggest studying the issue for a year to not interfere with people's rights. They say the health effects of e-cigarettes have not been adequately studied. This story lets viewers know about a bill that didn't pass and why.

Small Device Treats Glaucoma (aired 3/6/14 at 5pm runs 1 minute 15 seconds) - It is the smallest device to ever be implanted into the human body. And it is helping to treat a condition that can cause blindness. According to experts, glaucoma is the leading cause of blindness. One way doctors are treating glaucoma is by inserting a device called an IStent. The IStent is a very small implantable device that helps to control pressure in patients who have glaucoma. The device is barely visible once it is implanted into the eye.

Medicaid Hearing (aired 03/06/2014 @10pm, 2:30 minutes) – Utahns with life threatening illnesses say while politicians bicker over Medicaid, their health and lives are at stake. They went to the capitol to convince lawmakers to take federal money and get Medicaid to more people. Only six lawmakers showed up to listen to people’s emotional stories about not being able to afford health insurance. This story continues to update our viewers on this ongoing issue being debated at the state capitol and explains what options are being looked at by state officials.

Cannabis Oil Approved (aired 03/11/2014 @10pm, 2:30 minutes) – A win for dozens of parents on capitol hill as the state senate voted to approve the use of a cannabis oil in the state. The oil is the last hope for many families who have children with severe epilepsy. The parents lobbied at the state capitol for weeks trying to convince state lawmakers that the oil has nothing to do with medical marijuana. In the end, even the most skeptical senators were convinced. The bill now goes to the Governor's desk for his signature. This story explains who will be eligible to use the cannabis oil and rules that parents must abide by once it is signed into law.

Importance of Colonoscopies (aired 3/13/14 at 5pm runs 1 minute 15 seconds) – Colon cancer is the second leading cancer causing death in the United States. And experts say it is also treatable if caught early. However, every year thousands of people will die from colon cancer. One way doctors say you can detect colon cancer early is to have a colonoscopy. During the procedure, doctors use a scope to look for polyps. Polyps typically develop into colon cancer so if doctors can discover the polyps early, they can remove them before they turn into cancer.

Deep Brain Stimulator (aired 3/20/14 at 4pm runs 1 minute :20) – Parkinson’s disease is a degenerative disorder of the central nervous system. As the disease progresses, it can cause debilitating symptoms such as tremors. Doctors are now using a brain pacemaker to help patients control these symptoms. The deep brain stimulator is surgically inserted. The device then sends electrical signals to the brain to help the patient control their symptoms.

E-Cig Hospitalization (aired 3/24/2014 @6:00am, :25) – The number of children sent to Utah hospitals after using electronic cigarettes is on the rise. According to the Utah poison control center, e-cigarettes have sent nearly 80 children under the age of six to the hospital in the past 2 years. This story lets our viewers know about the dangers of e-cigarettes and why they are appealing to young children.

Mapping Your DNA (aired 03/25/2014 @10pm, 2:30 minutes) – University of Utah Researchers say genetic testing is becoming more common place and in five years it will be as routine as a blood test. Once that happens, the next hurdle to clear will be translating the information into usable data for primary care doctors. Teams at U-Star are working to make sure that technology is ready to go, reliable and accurate before the new wave of medical testing takes off. This story explains how genetic testing works and lets our viewers know that the new medical tool could be used by their doctors in the very near future.

GOVERNMENT/POLITICAL

Unemployment Insurance (aired 01/06/2014 @10pm, 1:45 minutes) – More than a million out of work Americans did not get an unemployment check today. Congress left for the holiday without extending long term unemployment insurance. The senate is back on Capitol Hill trying to work out a solution. This story explains what options are being looked at and what plan is most likely pass and how to get checks back into the hands of the unemployed.

Horse Carriage Debate (aired 01/07/2014 @4:30am, :30) – The horse-drawn carriage debate is headed back to the Salt Lake City Council. The council will discuss an overhaul of the ordinance regulating carriages downtown after the death of Jerry the carriage horse. This story updates viewers on the controversy, and lets them know when they can attend a public forum on the matter.

Swallow Investigation Committee (aired 1/14/14 @4:00pm, 1:00) - Utah's Lieutenant Governor said evidence proves that Attorney General John Swallow broke campaign finance laws. The House Investigative Committee says Swallow failed to disclose his income, falsified documents, and created phony companies to hide his money.

Chris Christie Bridgegate Scandal (aired 1/14/14 @4:30pm, 1:20) - New Jersey Governor Chris Christie delivered his "State of the State" address, and took responsibility for the so-called "Bridgegate" scandal. While he claimed no prior knowledge of the intentional bridge closures, Christie said any misconduct in his administration is ultimately his fault.

Huntsman Left Off Straw Poll (aired 01/15/2014 @10pm, 2:30 minutes) –A familiar name was left off the Republican presidential straw poll. Former Utah Governor, Jon Huntsman Jr. was not included in the poll. We talked to a political expert about the possible reasons behind leaving Huntsman of the ballot and what the chance is he may make another run for the White House.

Huntsman Atlantic Council (aired 01/17/2014 @5:00am, :30) – Former Utah Governor Jon Huntsman is now the new Chairman of the "Atlantic Council." He's taking over for Chuck Hagel who stepped down after being appointed Secretary of Defense. This story lets viewers know about the most recent appointment of a local leader.

'Mitt' the Movie (aired 01/17/2014 @10pm, 2:45 minutes) – 'Mitt' the movie made its world premiere at Sundance in Salt Lake City. The documentary is eight years in the making and shows an all access, behind the scenes look of a presidential campaign. The film follows the Mitt Romney campaign during both of his White House runs. This story lets our viewers know the documentary is out there and gives them information about how and where they can see it.

Three Strike Law (aired 01/20/2014 @5:00am, :30) – A Utah Lawmaker wants to soften a law that makes a person's third misdemeanor offense an automatic felony. Senator Daniel Thatcher of West Valley is sponsoring a bill that would make a fourth misdemeanor offense a felony. This story lets viewers know about a possible law change.

LDS Church and Liquor Laws (aired 01/21/2014 @ 10pm, 2:30 minutes) – The LDS church is making a very public stand on the state's liquor laws. The statement comes just a week before the start of this year's legislative session. In a video statement posted on the LDS church website, a LDS church leader says the states liquor laws are good and should not be changed. This story explains to the viewer why the LDS church feels this way and explains that this could mean an uphill battle for any kind of liquor legislation.

State of the Union (aired 01/28/2014 @10pm, 2:30 minutes) – President Obama addressed the nation in his State of the Union speech. The President urged members of congress to stop the political bickering and inaction on issues like raising the minimum wage, helping families and small businesses. He added that if congress won't act, he will use his executive powers to go around them. This story keeps our viewers informed on what is going on in Washington and explains how it impacts them.

State of the Union Response (aired 01/28/2014 @ 10pm, 2:30 minutes) – The Republican Party gave their response to the President's State of the Union address. The response focused on giving the American people a pep talk, saying the true State of the Union lies in the American peoples' hearts and homes. The Tea Party gave a response as well and Utah's own Mike Lee delivered the address. He blames the inequality in the country on the government as a whole. This story gives our viewers the other side of the debate following the President's speech.

Legislature Gay Marriage (aired 01/29/2014 @5:00am, :30) – Utah's Legislative Leaders say lawmakers are likely to stay quiet this year on issues related to Gay Rights. The next court to consider the case of gay marriage in Utah is not expected to rule until at least March. Leaders say they don't want to risk affecting the State's pending appeal to federal court. This story lets viewers know why Legislatures might not be addressing the issue.

4th District Race (aired 01/29/2014 @5:00am, 35 seconds) – The son of former Democratic Congressman Wayne Owens has decided to run for retiring Rep. Jim Matheson's seat. Doug Owens says he'll take a leave of absence from his law firm to

run. This story lets viewers know who they might see as a candidate in the next 4th district race.

Biden's Plan for 2016 (aired 1/29/14 @4:30pm, :45) Vice President Joe Biden appeared on "CBS This Morning," where he fielded questions about whether or not he plans to run for President in 2016. Biden declined to give a timeline about when he'll make a decision, but said he'd make the decision to run independent of what Hillary Clinton chooses to do.

No Educational Liquor Licenses (aired 01/30/2014 @4:30am, :30) – Utah regulators say they believe a special type of liquor license is being abused, so they've stopped issuing them. The State Liquor Commission has put a hold on Educational Liquor Licenses. They're meant for culinary schools, and restaurants and grocery stores that do wine tastings. But officials say more businesses outside the food industry are taking out the permits. This story lets viewers know that more liquor licenses will be on hold while ground rules are set.

Homeless Survey (aired 01/30/2014 @5:00am, :25) – Homeless service providers will conduct an annual point in time count of the homeless population in Utah. The State Community Services office counts all the homeless people across the state to see what services are needed. This story lets viewers know what Utah is doing to help the homeless.

Farm Bill (aired 1/30/14 at 7:30am for :30) -This was a little under the radar for a lot of people, but for some in Utah, the farm bill was a big deal. The bill included PILT money that goes to local governments with a large amount of government land in lieu of taxes. We talked about the bill finally passing and the representatives who voted for it and against it that represent Utah.

DUI Law Change Bill (aired 02/03/2014 @10pm, 2:30 minutes) – A proposed change in the wording of Utah's DUI law could mean a big difference if you are pulled over by police. A state lawmaker would like to re-write the part of the law which defines impairment. His bill would change the definition from "incapable of safely operating a vehicle" to "impaired to the slightest degree." The change has some defense attorney's crying foul. They believe changing the wording would give police wide ranging powers. This story explains to the viewers what could happen if the law passes and why some think it is a bad idea.

Sex Abuse Bill (aired 02/05/2014 @10pm, 2:30 minutes) – Child sex abuse is a problem in Utah and one state lawmaker is trying to pass a law that would help protect kids from sexual predators. The bill would mandate training for kids in grades K-6, teaching them how to protect themselves from sexual predators. This story highlights one of the bill biggest supporters, a high school student who was a sexually abused herself. It also explains how the measure would be implemented if passed into law.

Governor Herbert vs Lockhart (aired 02/06/2014 @10pm, 2:30 minutes) – Utah’s Speaker of the House took a political jab at the Governor last week but the Governor is not countering that punch. Becky Lockhart called the Governor an “inaction figure” and today Governor Gary Herbert gave his response saying some people will criticize his leadership style but he stands by his conservative ways. Some are saying this is political posturing for the 2016 gubernatorial race, others disagree. This story gave both sides an opportunity to express their views and lets viewers make up their own mind if this is just a war of words or a set up to what could be a hotly contested political race.

DNA Bill (aired 02/12/2014 @10pm, 2:15 minutes) – All suspected felons may soon have to give up a DNA sample after being arrested. A state representative is presenting the bill before the legislature and it is gaining momentum on Capitol Hill. Law enforcement says it will help them catch criminals but opponents say it is a violation of civil rights. This story give both sides of the argument and lets the viewer decide if they think the bill is a good idea or if it goes too far.

Breathalyzers in Bars? (aired 02/13/2014 @10pm, 2:30 minutes) – A law is in the works that could require every Utah bar to have a breathalyzer near the door. A state representative says the alcohol analyzer could be a tool for patrols to use so they can judge their level of inebriation. Bar owners say installing the breathalyzer could backfire and turn into a drinking game to see who has the highest level of inebriation. This story lets our viewer know what kind of alcohol legislation is being discussed on capitol hill and gives the supporting and opposing views so they can decided for themselves where they stand on the issue.

Reyes Right (aired 2/17/14 at 7am for :40) - Utah's attorney general gave up a way to gather information because of privacy concerns. Sean Reyes dropped the AG's use of "administrative subpoenas", which let investigators gather certain internet or cell phone records without getting a warrant. Investigators now will get a judge's order to get that information. His decision came as Utah lawmakers are considering a bill requiring all law enforcement agencies in the state to submit subpoenas to the same judicial review.

Convention Hotel (aired 2/19/14 at 7:30am for :30) - The legislature worked on a bill this legislative session to use taxpayer money to build a huge convention hotel. We updated people throughout the session on the process. The proposal authorized up to \$75 million dollars in public money to go toward tax rebates to a private developer building a hotel with more than 850 rooms. A similar bill didn’t make it through the legislature the year before.

Zion Warning (aired 02/20/2014 @10pm, 2:30 minutes) – Restaurants that serve alcohol may soon have an alternative to the liquor barrier, known as the “Zion Curtain.” A state representative is proposing an idea that would allow restaurants to choose the “Zion Curtain” or an alternative nicknamed the “Zion Warning.” The “Zion Warning” would require restaurants to post a sign on their front door say that alcohol is dispensed in public view. Alcohol laws are a hot topic issue in the state and this story explains the latest push to possibly change the liquor laws.

Same Sex Marriage Answering Brief Filed (aired 2/26/2014 @6:00am, 1:30 minutes) – A new plea this morning from lawyers for three gay couples asks to uphold a Utah judge’s decision that same sex marriage should be legal in our state. This story looks at what the brief says and lets viewers know the latest in the states same sex marriage debate.

Legislature Texting & Driving (aired 2/28/2014 @5:30am, :30) – A new proposal from a Utah lawmaker says the laws against texting and driving aren’t harsh enough. He wants to make it illegal to dial a phone number or look up an address while driving. This story lets viewers know about the changes that could be coming to texting & driving laws.

Daylight Saving Bill (aired 03/03/2014 @10pm, 2:30 minutes) – A Utah lawmaker is taking what could be the first step in ending daylight saving. The Republican representative is proposing a measure that would approve an in depth study into if it is really necessary to set our clocks forward during the summer months. This story explains the positive and negative aspects to daylight saving and keeps our viewers up to date on what is going on in this year’s legislative session.

Mike Lee Speaks at CPAC (aired 3/6/14 @4:30pm, :40) - Senator Mike Lee delivered an address at the Conservative Political Action Conference. Lee took aim at President Obama in his remarks, claiming the President has lost the confidence of the American people. Lee also lambasted Mr. Obama for the botched rollout of his health care plan.

Herbert vs Lockhart (aired 03/06/2014 @10pm, 2:30 minutes) – Governor Herbert says he is going to veto House Speaker’s, Becky Lockhart, education technology bill if it passes. Some say it is a little early for the Governor to say no to the measure, adding this is his way of picking a political fight with someone who may want to take his job. At the beginning of the legislative session, Lockhart called the Governor an “inaction figure” and now many believe this is the Governor’s way of getting his own dig.

Reid and Lee (aired 3/14/14 at 7am for 40 seconds) - In the John Swallow investigation, The Salt Lake City and Davis County attorneys say they uncovered possible misconduct by U.S. Senators Mike Lee of Utah and Harry Reid of Nevada. They said the investigation tied Lee and his campaign fundraising efforts to Swallow. Allegations against Reid revolve around his possible financial and political relationship with online poker companies. Salt Lake district attorney Sim Gill says the alleged wrongdoing goes beyond what his office can prosecute.

Capitol For a Day (aired 3/21/14 at 7am for :20) - Utah’s capitol moved for one day. Governor Gary Herbert made Heber City his work place for the day as part of the "Capitol For a Day" initiative to get out and visit rural Utah. The governor visited schools, local businesses and met with county and city leaders.

Knitting for Veterans (aired 1/8/2014 @10pm, 3:30 minutes) – Maxine Whitten is a mentally disabled senior who is taking care of her father, a World War II veteran. Despite her physical ailments, she spends much of her time knitting warm hats for veterans spending time at the VA hospital in honor of her father. Our story highlighted the cause and showed viewers how they could help.

Ching Farm Rescue (aired 1/15/2014 @10pm, 3:30 minutes) – Faith Ching and her husband couldn't stand seeing farm animals being abused or put down once they were no longer useful. She created her own farm to take in everything from cows and horses to geese and llamas. Our story highlighted the cause and showed viewers how they could help.

Curtis Foundation (aired 1/29/2014 @10pm, 3:30 minutes) – In a strip mall in Murray is a shop that is selling collectibles to help people recovering from drug and alcohol addiction. The non-profit is called Curtis Foundation and it raises money for Odyssey House. Our story highlighted the cause and showed viewers how they could help.

Friendship Club (aired 2/5/2014 @10pm, 3:30 minutes) – We all need a good friend, and Jim Gunnuscio wants to make sure some of society's often forgotten people have just that. He remembers what it was like to raise his adopted special needs daughter Joanie and how hard it was to go to restaurants and church. So Jim started the Utah Chapter of the Friendship Club. Our story highlighted the cause and showed viewers how they could help.

Firefighters Ronald McDonald House (aired 2/12/2014 @10pm, 3:30 minutes) – The house that love built is getting a little more love thanks to some dedicated firefighters within the Unified Fire Department. The firefighters at the Olympus station love to build things and this week they made a special delivery to the new Ronald McDonald house apartment building. Our story highlighted the cause and showed viewers how they could help.

Chemo Cupid (aired 2/19/2014 @10pm, 3:30 minutes) – Dov Siporin was declared terminal with stage four colon cancer six years ago. Despite more than 3,000 hours of chemo, he refuses to stop fighting. He spreads love and humor to others being treated for cancer. He showed up recently at Huntsman Cancer Institute as the Chemo Cupid to hand out chocolate and celebrate Valentine's Day. Our story highlighted the cause and showed viewers how they could help.

Sam Durst (aired 2/26/2014 @10pm, 3:30 minutes) – Sam Durst learned to overcome what life has thrown at him and is making the world a better place for others. Sam lives with cerebral palsy, but his physical limitations don't keep him from volunteering at the Provo Food and Care Coalition. Our story highlighted the cause and showed viewers how they could help.

Goodtown USA (aired 3/5/2014 @10pm, 3:30 minutes) – Timothy Goodman takes the challenge of being a school teacher to the next level. He's not just educating our future generations; he's creating a community in his classroom to help his third graders become better people. Our story highlighted Goodtown USA at Saratoga Springs Elementary and showed viewers how they could help.

Sandy Lees MDA (aired 3/12/2014 @10pm, 3:30 minutes) – Sandy Lees has been busy collecting great prizes for her upcoming breakfast and raffle. She raises money to send children suffering with muscular dystrophy to a special summer camp. They will be able to camp, fish and play outdoors, something many young MD patients never get to do. Our story highlighted her cause and showed viewers how they could help.

Tech Junkies Club (aired 3/19/2014 @10pm, 3:30 minutes) – The Tech Junkies Club at the Stevens-Henager College brings old and broken computers back to life. Then they donate them to groups who could really use them like daycare centers, homeless shelters and other students struggling to get by during their education. Our story highlighted the cause and showed viewers how they could help.

AMP Athletics (aired 3/26/2014 @10pm, 3:30 minutes) – Amanda and Ryan Bowler want to make sure all kids enjoy a full childhood and are part of team sports. They created the non-profit AMP Athletics to help parents who may not have enough money to pay for recreation league fees. Our story highlighted the cause and showed viewers how they could help.

Child poverty and hunger are reaching alarming levels in Utah. More than 170,000 Utah kids are eligible for free school breakfasts and lunches and another 50,000 are eligible for reduced cost meals. Tragically these students are not eating well on the weekends. They should eat seven meals between Friday lunch and Monday breakfast, but they don't. KUTV launched the Souper Bowl of Caring on January 13, 2014 and the campaign ran through February 14th. 48 HOURS: "Over the Edge" (9:00-10:00p) - a report on the investigation into the 2009 disappearance of Dawn Viens, and why her husband, California chef David Viens, jumped off a cliff when he became a suspect in her disappearance. David Viens ran a successful restaurant in Lomita, California, working in the kitchen while Dawn was the hostess. After Dawn vanished, Viens promoted a young waitress, Kathy Galvan, to take Dawn's spot at work and in his personal life. Dawn's friends and family members turned to the police and a local newspaper reporter, Larry Altman (now a CBS News consultant) for help. Police worked methodically on the case, discovering that before moving to California, David was involved in the drug trade in Florida, and had helped authorities bust up a drug ring. After more than a year, as police were closing in, a frightened David Viens opened up to Kathy Galvan: he confessed that he killed Dawn, but claimed it was an accident. Then he recklessly drove on a California coastal highway, with Galvan in the car, to a scenic overlook, and jumped off a 200-foot-high cliff. Surprisingly, Viens survived the fall. His story was that Dawn had started using cocaine and crystal meth. They fought, and David Viens bound her (something he had done in the past), taping her mouth to keep her quiet, and went to sleep. He awoke and found her dead. While in the hospital he told police an incredible tale of disposing of Dawn's body in the way a chef knows best, by cooking her. He boiled her body in a pot for four days, broke down what would not boil down, and threw it away in the trash.

Nineteen months after his leap, a wheelchair-bound Viens was in court to face murder charges. The defense said that Dawn's death was an accident -- manslaughter, not murder -- and that he did not cook her. He was arrested. At trial, Brooks was found guilty of second degree murder. Through interviews with Cachay's family and friends, a picture of a successful woman with everything to live for is revealed, but one who was also having second thoughts about her much younger boyfriend. At the scene, police discovered an odd clue: bloody footprints intentionally left as part of a staged crime scene. Police questioned Ernie, but with no forensic evidence to tie him to the crime, they were unable to arrest him. Later, when new evidence came to light, Ernie had vanished. After a cross country spree of nearly one year, police, with the help of Ernie's wife, were able to apprehend and arrest him for the murder of his parents. 48 HOURS: "Pain and Gain" - a report about the crimes of the Sun Gym gang, a group of Miami, Florida drifters, petty thieves, and bodybuilders who kidnapped and killed

wealthy people to fuel their lifestyle, which provided the inspiration for the recently released black comedy motion picture "Pain and Gain". The story began with the disappearances of Frank Griga and his girlfriend Krisztina Furton in 1995. Police investigation led detectives to a connection to the Sun Gym, a Miami health club, and its manager Danny Lugo and his protégé Adrian Doorbal. Police would discover that they were at the center of a complicated and deadly plot which involved kidnapping, money, and murder. Lugo's girlfriend Sabina Petrescu played a crucial role as police gathered evidence connecting Lugo and Doorbal to the disappearance of Griga and Furton. In a bizarre twist, detectives in another Metro-Dade police department were also looking into Lugo and Doorbal in the kidnapping case of another Miami millionaire, Marc Schiller. Schiller told police that he had been grabbed by a gang and held for more than a month. Schiller also worked out at the Sun Gym, which provided the connection to Lugo and Doorbal. The plan was to kidnap Marc Schiller - a man who had many shady dealings -- have him write his own ransom note, and then kill him. There were several stupid attempts involving costumes, comic book code names, and a staged accident -- all of which provided Hollywood with inspiration for the movie. While imprisoned, Schiller was forced to sign over his assets to the gang. They went through the money in about five months and decided to find a new target: Frank Griga. Almost four years after Marc Schiller was left for dead, he faced the Sun Gym gang in court, as Danny Lugo and Adrian Doorbal went on trial for the murders of Frank Griga and Krisztina Furton. They were found guilty of first-degree murder. However, Marc Schiller's ordeal was not over. He was arrested by the FBI on charges involving Medicare fraud. In another twist, the trial judge, Alex Ferrer (now a TV personality), described how important Schiller's testimony was in bringing down the Sun Gym gang. In a plea deal, he ended up serving two years in federal prison and paying \$137,000 in restitution. On screen text graphics: Lugo and Doorbal remain on death row. Lugo and Doorbal have appealed their convictions multiple times over the past 15 years. Noemi Ponce Sigler, the original investigator's daughter, says her father was told to step away from the case because a deal had been made between the Church and the police regarding Feit. In 2002, the McAllen Police Department asked the Texas Rangers Cold Case unit to re-examine the murder. The investigation took a dramatic turn when a former monk, Dale Tacheny, told police that Feit admitted to killing a young woman while Tacheny was a counselor at a monastery. Joseph O'Brien, an assistant pastor at the church in 1960 also told investigators that Feit told him that he did it. Despite these new findings, Hidalgo County District Attorney Rene Guerra doesn't believe the case is strong enough to take to court, though he would have prosecuted Feit in 1962 on the charges. 48 HOURS: "Fateful Connection" - a report on the investigation led by a determined detective to solve a 30-year-old cold case involving two young women who went missing in Florida, in 1982. Amy Hurst and Wendy Huggy did not know each other. Hurst and her new husband, Bill Hurst, had recently moved to Pasco County, Florida, leaving her two young children in the care of relatives in Michigan. Then she just disappeared. Sixteen-year-old Wendy Huggy lived with her grandparents in Pasco County, and went to a party - she never returned home. A fisherman found a body floating in the Gulf of Mexico, wrapped in a homemade afghan, but identification proved difficult. There was no connection made to either woman, although Hurst's husband was immediately viewed as a suspect in her disappearance -- but he too disappeared, and both cases languished for decades. Detective Lisa Schoneman, a member of the cold case unit, stepped in and a new investigation began. In 2009, Amy Hurst's son discovered significant evidence about the afghan, through the Doe Network, and a body in a Tampa, Florida potter's field once thought to be Wendy Huggy's was examined. In 2011, it was determined to be that of Amy Hurst. Investigation led to her husband, Bill Hurst, who was in Kentucky. Police were able to get Hurst into custody, and he was indicted on first degree murder charges -- he was found guilty. Detective Schoneman says she will keep trying to find Wendy Huggy. **On-screen text graphic:** William Hurst will be 85 when he becomes eligible for parole. 48 HOURS: “aka Rockefeller” - a report about the mysterious life of Christian Gerhartsreiter, a con-man, who pretended, since he came to America from Germany, to be a bond trader, a TV producer, a baronet and even Clark Rockefeller, a member of the famous and wealthy Rockefeller family. In 2008, Gerhartstreiter, then claiming to be Clark Rockefeller, made headlines when he abducted his 7-year-old daughter. The Rockefeller family made it clear that he was not a part of their family. What he was, according to police, was a killer on the run. His arrest in the kidnapping case blew the lid off a 30-year con. All the other identities he had used came to light including the alias he was living under in 1982 in San Marino, California: Christopher Chichester, the 13th Baronet of Chichester. San Marino police believe he murdered John and Linda Sohus, who disappeared in 1985. Years later, the bones on John Sohus were found in the backyard of the house where they lived. At the time, Christopher Chichester lived in the guest house on the property. He went on trial for the murder of John Sohus and was found guilty. **On-Screen text graphic for original and rebroadcast:** “Rockefeller” fired his lawyers and filed his own petition for a new trial. The judge denied the motion. His daughter is now twelve-years-old. She has no contact with her father. 48 HOURS: “ryanferguson@lifeafterten” (9:00-10:00p) - a followup to “Dream Killer” (OAD: 02/18/06), “The Lost Night” (OAD: 03/26/11), and “The Accuser (OAD: 02/23/13), all dealing with the case of Ryan Ferguson, who was released from prison in November 2013, after nearly 10 years behind bars for the murder of Ken Heitholt, a Columbia Daily Tribune sports editor who was killed in 2001. Correspondent Erin Moriarty and the 48 HOURS team have been investigating the murder and the bizarre circumstances that put Ryan Ferguson in prison for the crime since 2006 and were with Ferguson when he was released from prison. Details of the case, which were presented in the original broadcasts, are interwoven into this report along with past interviews. Also included are new interviews with Ryan Ferguson; his parents, Bill and Leslie Ferguson; his attorney, Kathleen Zellner; his accuser, Charles “Chuck” Erickson; and his new girlfriend Myka Cain. Ultimately, Erickson, even after confessing, believes that he was not responsible for the crime and has a new attorney, the interest of the Midwest Innocence Project and the support of Ryan Ferguson. For now, Ferguson is concentrating on what he will do now: he is thinking about going back to college and may follow his father into the real estate business. **On-screen text graphic:** Ryan Ferguson has written a book that will be published in 2015. 48 HOURS: "Last Chance" (10:00-11:00p) - an interview with Damon Thibodeaux, who was wrongfully convicted of the 1996 murder of his 14-year-old cousin Crystal Champagne and who spent 11 years in Louisiana's notorious Angola prison.

Thibodeaux, a distant cousin who was staying with the Champagne family was immediately questioned by police after the girl disappeared. After nine hours of interrogation, he confessed to murdering - and raping - the girl. Thibodeaux says he confessed to police after an intense interrogation and because he was sure he would be cleared during trial. When he met with attorneys hours later, he denied having anything to do with the crime. At the 1997 trial, he was convicted and sentenced to death by lethal injection, even though none of the 84 pieces of physical evidence were ever tied to him. His case caught the eye of attorney Denny LeBeouf, who specializes in cases getting inmates off death row. LeBeouf sought the help of Minneapolis attorney Steve Kaplan. Their investigation revealed that Crystal Champagne had never been raped. Together, they came up with a risky plan to present their evidence to Jefferson Parish District Attorney Paul Connick. Connick agreed - to re-examine the physical evidence and Thibodeaux was freed two years later. 48 HOURS interviewed various individuals to piece together what may have happened to Champagne. **On-screen text graphic:** After Thibodeaux was released he earned his GED. He now works for a commercial trucking company. Thibodeaux was invited to testify before Congress about conditions on death row. Last year he became a grandfather.
