Date Aired & Issue Description:

10-15-16 Issue 1: Topic Election Ballot. Attorney Jason Samsone and Corey Perry discussed issues facing all candidates of all parties elected in Oklahoma. What's on the ballot for the November election. State questions and question 780 were addressed. Judicial elections, and judicial retention. The need for candidate transparency and how candidates can appeal to younger voters.

10-22-16 Issue 2: Election. Additional visit with David Hooten and attorney Trey Shelton. Detailed discussion on all the State Questions on the upcoming election. What they are, and what will people be voting on. What the outcome of each question will result in. The school tax question was addressed that would increase teacher salaries and its potential impact on public schools and classroom size.

10-29-16 Issue 3 (15 minutes): Oklahoma City County Health Department (OCCHD), Wellness Now Weekly Radio Program. Epidemiologist Megan Holderness on child related illnesses and vaccinations such as whooping cough. Concerns on how adults can be susceptible to such illnesses.

10-29-16 Issue 4 (15minutes) OCCHD – Wellness Now Weekly Radio Program . Amanda Ford of the Oklahoma County Cooperative Extension and a certified Dietician. Suggestions on holiday meal preparations, food leftovers, illness prevention with attention to senior citizens. Food recommendations and sanitary food preservation practices for Thanksgiving.

11-19-16 Issue 5 OCCHD- Wellness Now Weekly Radio Program. Ellen Parrett the Occupational Safety Coordinator discusses heart attacks and coronary disease. Explanation on administering CPR. Additionally, where CPR classes are routinely held and general public access to the classes.

12-3-16 Issue 6 (15 minutes) OCCHD- Wellness Now Weekly Radio Program. Joyce Towell, Women's Health Practitioner explains the need for women to have routine check ups and screening for cervical and breast cancer. Ages of women who need screening, and impacts on women who are pregnant, and city county assistance availability.

12-3-16 Issue 7 (15 minutes) OCCHD-Wellness Now Weekly Radio Program. Board member Scott Mitchell explains the structure of the city-county health departments governing board, its policy settings and funding. Included was a discussion on the OCCHD clinics throughout Oklahoma County, and the current state of health throughout the county.
