THE GOVERNOR ALSO MADE HIRING A CHIEF MARKETING OFFICER FOR THE STATE A HIGH PRIORITY, BUT FAILED TO OFFER DETAILED POLICY PERSPECTIVES ON OTHER HIGH PROFILE ISSUES IN HIS 43 MINUTE SPEECH.**

**TOPIC 3: THE DENVER CITY COUNCIL IS CONSIDERING A PROPOSAL THAT WOULD GIVE THEM AND OTHER CITY OFFICIALS A 10.9% PAY RAISE. COUNCIL SALARIES WOULD GO FROM 83,000 TO 92,000 DOLLARS A YEAR AND THE MAYOR WOULD GO FROM 155,000 TO 171,000 DOLLARS A YEAR. THE PROPOSAL PASSED A COMMITTEE BY A VOTE OF 4-3 THIS WEEK AND WILL NEXT HEAD TO THE FULL COUNCIL.**
