PRE-FILING AND POST-FILING RENEWAL ANNOUNCEMENT INSTRUCTIONS

The following three pages contain instructions for the broadcast of the pre-filing and post-filing renewal announcements for Sinclair's Bloomington, Illinois station. Included with these instructions are the texts of the two types of announcements and a Statement Certifying Compliance that needs to be completed, dated, executed and **placed in the station's online public inspection file within seven (7) days** after the last post-filing renewal announcement has been aired or by **October 23, 2013**. If for any reason the station did not air the required announcement on the specified days and during the specified time periods, please contact the company's communications counsel before the Statement Certifying Compliance is finalized, dated and executed.

Pre-filing Renewal Announcements for WYZZ-TV, Bloomington, IL, FAC ID 5875
