A defense attorney out of Green Bay is now on the other side of the lawyer/client relationship after he allegedly assaulted a Brown County Sheriff's Deputy. According to the criminal complaint, Mark Howe was attending the Rob Schneider performance at the Epic Event Center on June 16th and was acting unruly. Brown County Sheriff's Deputy Kelly Milks ask Howe to leave, but 10 minutes later, he was in the parking lot causing a commotion. As Deputy Milks approached Howe, he began to run away. She chased after him, and multiple times grabbed Howe to take him into custody. The last time she did, Howe pulled away, and Deputy Milks fell to the ground. Her knee popped, and she was unable to get up. Howe was eventually arrested, but as he was placed into a squad car, he made several derogatory statements about Deputy Milks.

Eric Genrich, Mayor of Green Bay  
Announces He Plans to Run for  
Another Term.

The current mayor of Green Bay, Eric Genrich, announced Wednesday on Twitter that he plans to run for another term.

Genrich was first elected mayor of Green Bay in 2019. Before that, he was elected to the state Assembly in November 2012. Serving three terms, he represented the 90th Assembly District which comprises the majority of the City of Green Bay, according to the city's website.

As mayor, Genrich has faced criticism over the city's management of recent elections, but the mayor has rejected these criticisms and defended the city's election staff. A case between Genrich and now-former election investigator Michael Gableman was dismissed in late August.

Additionally, Mayor Genrich held the second State of the City address in July, discussing the economy, diversity, and community safety, emphasizing a theme of "heart, healing, and hope."

Denny was found dead in the street near the intersection of Western and Perkins Avenues  
back in April.

Jacob Ventura was quickly arrested, but police continued looking for Alejandro and his  
brother Gustavo Cantu.

The latter was found in Texas, and shortly after he was detained, Alejandro was found in  
Green Bay.

Gustavo is due in court on October 10<sup>th</sup>, and Ventura is due back in November.

Gustavo Cantu bound over for trial  
in shooting death of Randall Denny

One of the two brothers charged with an April murder in Green Bay has been bound over for trial.

40-year-old Gustavo Cantu was in Brown County Court on Tuesday, where Judge Tammy Jo Hock made the ruling that there is enough evidence for the trial to take place. Gustavo, his brother Alejandro Cantu and Jacob Ventura are all charged with 1<sup>st</sup> Degree Intentional homicide for the shooting death of Randall Denny.

Prosecutors say various surveillance videos caught all three parties fleeing the area and arriving at another location, where it is believed they all destroyed evidence.

Gustavo's arraignment hearing is scheduled for October 10<sup>th</sup>, Alejandro is due in court for a preliminary hearing on Friday, and Ventura will enter his plea on November 14<sup>th</sup>.

Chad Weininger, the Director of Administration for Brown County, has filed paperwork to start running for the position of mayor in Green Bay, Wisconsin.

According to a release, his actions on Wednesday will allow him to talk to voters about his potential campaign and raise funds for the race.

"I'm ready to roll up my sleeves and put in the hard work it will take to make our city safer and more prosperous. I'll work for lower taxes, less crime, and more good jobs to ensure my children and your children have the opportunity to make Green Bay their home now and in the future," said Weininger.

There are plans in the works to make an official campaign announcement later this year.

Weininger says he previously represented the far west side of Green Bay in the Wisconsin State Legislature. He has also owned a real estate company and a restaurant in the Green Bay area.

Some of his previous roles include Green Bay's City Clerk, which oversaw elections and business licenses.
