WOOD License Company, LLC ("Licensee"), licensee of television station WOOD-TV, Grand Rapids, Michigan (the "Station"), located in the Grand Rapids-Kalamazoo-Battle Creek DMA, hereby gives notice to Charter Communications, Inc. that pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC's Rules, Licensee elects to assert its right, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC's rules, to have the broadcast signal of the Station carried on cable systems only if we have provided our express written consent. This election applies to the cable system(s) identified above as well as any other cable system(s) or other video distribution system(s) that you own, operate, or manage.
