Hi Rebecca-

Thanks for your time on the phone.

As discussed, you currently have \$170 credit. And unfortunately I cannot add to KCYE because you are maxed out at the lowest unit rate in each daypart on the station. If you choose to do that you than move to the stations prevailing rate, which is much higher.

I would recommend to take the \$170 and book next week on KKLZ at lowest unit rate:

- Monday -Friday 6a-10a 1x each day at \$30 which would total \$150
- Monday-Thursday 7p-12m 1x each day 4 spots at \$5 which would total \$20

This would get you 9x spots on the station.

This would use your credit of \$170—does this work for you?
