The Taylorville School Board was presented with the Fiscal Year 2013 School District Audit at their meeting Tuesday night. CPA Adam Mathias (Ma-thigh-us) from the Lively, Mathias, and Hooper firm pointed out some key financial figures for operating funds:

Mathias said it was evident that the Taylorville School District watched their expenditures closely but there is still work to be done to achieve a balanced budget.

The Taylorville School Board approved the issuance of alternate revenue bonds up to 12-million dollars. David Pistorius (Pi-story-us) with First MidState told the Board that there are two more steps in this process:

The bond will help building and equipping additions to, improving the sites of, and altering, repairing and equipping the existing school building and facilities of the Taylorville School District.

The Board also approved the District ISBE Rising Star school improvement plan.

Governor Quinn Announces \$691,000 Infrastructure Investments in Christian and Shelby County Communities

Governor Pat Quinn announced on Thursday a \$691,000 state investment in Christian and Shelby Counties to support critical public works improvements and home rehabilitations for low-income residents.

The investments were made under the Illinois Department of Commerce and Economic Opportunity (DCEO)'s Community Development Assistance Program, which targets areas with populations of less than 50,000 that are outside of urban counties. Larger towns and cities are eligible for similar funding by direct application to the federal government.

The awards include:

Christian County

Stonington: Replace a raw water line from well to treatment plant. \$450,000 grant, \$603,000 total project cost.

Shelby County

Findlay: New water main to connect with another water source. \$241,000 grant, \$321,490 total project cost.

Statewide, investments totaling \$8.83 million were made in 23 towns or townships for improvements to water and sewer systems, and with the required local matching funds the total investment will be \$13.94 million

The Board also approved a preliminary engineering agreement with WHKS and a soil boring agreement with Atlas Soils, Inc for the Rosamond Bridge #9 repairs. The Board approved the purchase of a snow blower and a spreader since the County no longer has a contract with someone to clear the walks and drives at the Courthouse and other buildings. The Board approved the budget for Fiscal Year 2014 and also the Christian County Tax Levy Ordinance.

Sheriff Kettelkamp Commends Harvel Resident for Catching Alleged Thief

Christian County Sheriff Bruce Kettelkamp would like to commend Mathew Meisner of Harvel for his help in apprehending an individual he observed committing a theft from his vehicle, which was parked inside his garage. As a result of Meisner's actions, Christian County Sheriff's Deputies arrested Cody Michael Caraker for residential burglary.

Meisner had suspected that someone had previously been entering his garage and taking items from his vehicle. As a result of this, Meisner placed a baby monitor in his garage to alert him if anyone entered his vehicle. On Monday around 2:08 A.M., Meisner was alerted, from the baby monitor, that someone had opened his car door. Meisner observed a male subject in his garage, later identified as Cody Michael Caraker, and detained him while Meisner's wife called the Christian County Sheriff's Office.

Meisner detained Caraker for approximately 14 minutes until the Deputies arrived on scene.

Caraker is suspected of entering into two other garages and taking items from their vehicles.

The action taken by Meisner is an excellent example of community policing where the citizens actions resulted in the arrest of a burglary suspect and the prevention of further crimes possibly being committed.

Taylorville City Council Swears in New Officer; Tables Several Issues

The Taylorville City Council was presented with a motion that there would be no charge for any area currently in the City or annexed into the City for fire hydrant installation. City Attorney Rocci Romano voiced concern over the wording of the motion:

Alderman Bruce Jones also voiced concerned saying that if the motion passed, new subdivisions could view it as not having to pay to install fire hydrants before dedicating that property to the City. Romano says that is something they would need to add to the possible ordinance:

The Council voted to table the matter and discuss the recommended ordinance at the next committee meeting.

The Taylorville City Council was presented with a motion to waive the water costs for a period of two years to Gowin Parc. City Attorney Rocci Romano suggested they table this matter as it could be a violation of a contract in its current proposed state:

Romano suggested re-working the contract with Christian County to add a clause that would allow each side to make changes to the benefits for enterprise zones. Alderman Shawn Burtle suggested that instead of re-working the whole contract, write a letter to the County Board to get their approval for this one proposal. Romano said that would work as well. The Council agreed to do so and voted to table the topic.

At the last Taylorville City Council meeting, City Attorney Rocci Romano told the Council that Spreser was never annexed into the City after a jurisdictional transfer. Romano updated the Council at their meeting Monday about similar situations after more research was done by City Clerk Pam Peabody:

The Council also tabled a subordination agreement with RECC concerning the city's storm sewer easement due to wanting to negotiate attorney and city engineering fees to be paid by RECC. The Council also approved the concept of a "shared sewer" with the property owner being responsible for up to \$2,500 and/or \$3,000 for sewer installation, maintenance and repair of the sewer lines and to direct the City Attorney to research legality of such a program.
