The Taylorville City Council made quick work of city business in their 20-minute meeting Monday night. Among items passed was a release and global settlement agreement with Jamal Shedadeh (shuh-HAHD-uh) who filed a host of Freedom of Information Act requests with the city and other law enforcement agencies, in an attempt to defend himself from charges that ultimately landed him in prison. Shedadeh (shuh-HAHD-uh), thru the agreement presented to Taylorville aldermen Monday night, dismissed pending court cases filed in U-S District Court against the city, Christian County, State's Attorney, and several other city and county officials regarding his Freedom of Information Act requests. Mayor Greg Brotherton told Regional Radio News that the requests will now end.

Brotherton added that Shedadeh (shuh-HAHD-uh) cost the City of Taylorville thousands of dollars in city attorney fees and time.

It was a short 15-minute meeting of the Taylorville City Council Monday night in the Council chambers.

Aldermen OK'd a lease agreement with the Taylorville Fire Protection District for leasing a 2006 Ford F450 Crew Cab Rescue Truck; they OK'd spending just over 6-thousand dollars with B-and-W Dozer Salvage of Cowden to refurbish the city's 2000 Cat Backhoe. Council members Monday night OK'd an agreement with J-B Vending for vending services with the City to receive a 10-percent commission; and they directed City Attorney Rocci Romano to prepare an ordinance to seek sealed bids for the sale of the city's 1996 street sweeper, a 1988 Ford dump truck, and 3 trench boxes.

The Taylorville City Council Monday night OK'd seeking bids for their annual concrete and sidewalk replacement program, curb and gutter replacement, fuel and trash removal services; and approved the January 20th Tree Board minutes. They OK'd the lowest bids for chemicals for the city's water treatment plant, and paid bills totaling just over 316-thousand 350-dollars.

The Taylorville City Council passed a number of motions and heard 3 different presentations from the public, at their Monday night meeting.

One of the public presentations was from neighbors John Adams and Mary Wetzel, who complained to the Council about their neighbor, Doug Hughes, who resides at 1001 East Stevenson. Adams and Wetzel said that Hughes operates a tree trimming business from his house, and as a result, several large trucks are parked in their neighborhood allegedly damaging culverts and blocking property. Adams cited some of the problems with the business being in their neighborhood, but Hughes allegedly told Adams he knew all the police.

During the regular monthly meeting of the Christian County Board Tuesday night, Chairman Paul Schmitz shared a letter of resignation submitted by longtime District 4 board member, Lloyd Washburn of Morrisonville who was absent from the meeting. Washburn cited physical difficulties as the defining factor in his necessity to resign. Chairman Schmitz expressed his regrets in having to accept the resignation in light of the years of service that Mr. Washburn has given to the people of District 4 and all of Christian County.

In an abbreviated meeting, the board approved the 2015 fuel bids. The winning bid was submitted by Christian County FS. A bid of 8 cents over refinery price for B2 clear and B2 dyed diesel and 3 cents for winter additive was approved as well as 8 cents over refinery price for gasahol. The board also approved the purchase of a Cobra Pro MK1 gas powered post driver. 3 bids were submitted with Decker Supply turning the low bid at \$4196.18.

Also at last night's Christian County Board meeting, Marchelle Kassbaum, Regional Superintendant of Education for Christian and Montgomery counties, gave a quick update on the progress of the wife and daughter of her assistant, Greg Patrick, who were involved in an auto accident 10 days previously. Both are doing extremely well and Patrick is expected back in the office within the next few days. Superintendent Kassbaum then introduced Julie Wollerman, Regional Superintendant of Education for Bond and Effingham counties. She notified the board that everything was moving forward smoothly for the consolidation of the 2 Regional offices of Education.

The meeting was adjourned at 6:50.

Christian County Board Approves Zoning Issues

The Christian County Board met in regular session on Tuesday night, February 17th. Among the items on the agenda, the amendment of the Zoning Ordinance to include the Village of Palmer. It was pointed out that the village no longer had any zoning board and had asked the county to take zoning back. The motion to amend the Ordinance was approved. Also, permission was given to reclassify an area in Ricks Township from Ag 1 to Commercial 2 for the purpose of relocating the Casey's General Store in Morrisonville. Casey's has applied to build a new facility in the rezoned location. Approval was unanimous.

In other business the Christian County Board agreed to place on the 2016 ballot for voter approval, the consideration of changing the Supervisor of Assessments position from an elected position to an appointed one. It was determined that if the position did become an appointed position, it would not take effect until 2018. If someone is appointed by the board to replace Michael Gianasi who has resigned, they will fulfill his term of office.

Several liquor licenses were approved including Burton's Tap, Blue Bell, Pana Country Club, Thunderbird, A Great Victory, Lucky Lady, South Fork Entertainment, Arpeggia Winery, Christian County Fair and Tri County Fair. Phillip Schneider was sworn in to replace the trustee position vacated by the resignation of Zenith Washburn. Schneider was sworn in by Judge Brad Paisley. Jane Workman was appointed as a trustee for the South Fork Sanitary District until the year 2018. The meeting was adjourned at around 7:15 pm.

Hot topics Havera talked to the Kiwanis members about included why so many cases are continued, why certain cases are dismissed, and the continuing drug problem in the county.

Havera added that Christian County has more orders of protection per capita than any county in the state, and he sees many of those domestic abuse cases go thru his office.

Kiwanis attendance chairman Dick Wamsley presented certificates to those with perfect attendance at Kiwanis meetings. Dean Ray was honored for 12 years of perfect attendance, Herman Altman with 10 years, Dan Sneed with 6 years, and Randal J. Miller with one year.

The Taylorville School Board, during their regular monthly meeting Tuesday night, heard a detailed report from Superintendent Fuerstenau on the changes that may be necessary to bring the 2015-2016 school year budget into a semblance of balance. Dr. Fuerstenau cited the perfect storm of prorated general state aid being funded at 2010 levels and prorated at 89%, as well as declining enrollment and the uncertainty of categorical payments as contributing factors in the future financial shortcomings of the district. To put the problem in a nutshell, state aid is going to continue to decrease and expenditures increase to a level in which the district will see its savings cushion depleted and the district will be operating in the red.

It was proposed by Dr. Fuerstenau that restructuring would alleviate approximately \$515,000 in the FY2016 budget. The restructuring would come in the form of restructuring grades K-2 from 8 sections to 7, restructuring the Junior High and High School schedules to an 8 period day and restructuring district support personnel. With the proposed restructuring, the district would see 5 certified staff positions reduced, 3 positions not filled and support staff positions reduced to equal a savings of \$514,557. It was agreed that, unfortunately, it was not possible to cut programs or supplies and still provide the quality of education that is expected in the Taylorville School District. Dr. Fuerstenau noted that even should the District see an unexpected increase in State Aid Funds, these changes are needed with larger deficits looming in FY 2017. The proposed changes will be voted on during the regular board

meeting in March.

In other business, the board approved a resolution providing for the issue of \$800,000 in school bonds for the safety improvement to the schools including a new roof and weatherproofing for Memorial grade school along with replacing windows at Taylorville Junior High. The board also accepted the resignation of Maureen Appleton, Junior High, Jon Bagby, Spanish at THS and Roy Roberts, English at THS. Request for leave of absence was granted to Lori Oyler and Tracy McCallister and the board agreed to hire Julie Lilly as Library Aide at the High School. The meeting was adjourned at 8:00 pm.
