The Christian County Board unanimously approved 2 new ordinances concerning the purchase of aggregate energy for the residents of Christian County. The first ordinance approved by the board was the appointing of Southern Illinois Municipal Electric Cooperative to serve as the County's sole consultant for its electric aggregation program and for the engagement of the lowest cost electric wholesale supplier. The second ordinance allows the voters to grant or deny the County the authority to arrange for the supply of electricity for its residential and small commercial retail customers who have not opted out of such a program.

The Christian County Board also approved the purchase of a single axle distributor for the Highway Department. The department had been using the distributor on a trial basis and found it to be more maneuverable and easier to handle. The purchase will be made from Louis Marsch at a figure of \$7000. The Board also agreed to sell the dual axle distributor that was purchased last year. There is already interest in the old distributor so it will be opened to sealed bids.

In other business the Board approved the purchase of 2 traffic counters by the Highway Department to be used for roadway planning, design, speed studies and more. The cost of the 2 counters to be purchased from MetroCount is \$2419.

There was some discussion as to the legality of docking Board Members for not attending meetings. It was determined by Chairman Schmitz that the input of States Attorney Tom Finks would be necessary in order to determine how much leeway the board has.

Greg Patrick was introduced as the Assistant Regional Education Superintendent.

The Kincaid Police recently arrested 24 year old Chad Johnson and 27 year old Donald Felton both of Taylorville.

The Taylorville City Council met on Monday night and many important issues were discussed. One of the most pressing issues of the night was brought up in the mayor updates, by Mayor Greg Brotherton. This issue was the one of the possibility of water rationing in Taylorville. Brotherton says that the levels at Lake Taylorville are pretty good considering the dry conditions.

Also brought up at the meeting was the agreement made by an arbitrator for the City of Taylorville and the Policemen's Benevolent Labor Committee. This agreement says that a person can be on the police force, a firefighter, or a member of AFCSME if they live within a 6 and a half mile radius from the Christian County Courthouse. The Taylorville Fire Fighters Union Local 3144 and AFSCME Council 31 Local 3349 were made a part of the Police Union and City of Taylorville's arbitrator agreement because of a "me too" clause regarding residence requirements. The motions legally, had to pass as an arbitrator made the decision for the City of Taylorville and the Policemen's Benevolent Labor Committee and that arbitrator's decision is legally binding, although there was a councilman who voted no to the motions.

Earl Walters of Ward IV was that alderman, and he says that if you work for the City of Taylorville you should be required to live within the city limits.

All other ordinances at the meeting passed unanimously, those ordinances include.

An ordinance to make appropriations to defray expenditures of the City of Taylorville for the fiscal year commencing May 1, 2012 and ending April 30, 2013.

An ordinance authorizing the submission to the electors of the City of Taylorville the question of whether the city shall have the authority to arrange for the supply of electricity for its residential

and small commercial retail customers who have not opted out of such a program although this ordinance only includes Ameren customers.

An ordinance amending title 6 chapter 5, section 1 as it relates to the definition of “damaged vehicle” of the Taylorville City Code (Re: Demo Derby Cars)

An ordinance suggested by the Plan Commission to re-subdivision CVS.

An ordinance to ratify the payment of bills which totaled \$255,597.12

A Beachcraft 18 2-engine plane carrying parachutists from Taylorville Municipal Airport, crashed in a residential area of Taylorville at 11:25 Saturday morning, killing the pilot but the parachutists got out before the plane went down.

Tony Molinaro, a public information officer with the Federal Aviation Administration, told Regional Radio News that the skydivers were released before the plane crashed in the Rich Street area of Taylorville. Molinaro said the pilot was the only person on board when the airplane went down, and he was killed.

Molinaro added that investigators from the F-A-A will be on scene to complete their work, then turn over their findings to the National Transportation Safety Board for a determination as to why the plane went down.

At 7:35 Saturday night, Christian County Coroner Amy Calvert Winans released the identity of the pilot. 30 year old Brandon Sparrow, of Augusta, Illinois was pronounced dead at the scene of the crash. An autopsy will be scheduled Monday in Bloomington.

Firefighter Tom Campbell of the Taylorville Fire Department talked with Regional Radio News late Saturday afternoon and said while the plane did crash into a residential area, no one on the ground was injured:

Campbell thanks the residents in the Rich Street area for their cooperation, and stressed the Taylorville Fire Department will allow them back into their homes as soon as possible.

An area bordered by Cheney to Shumway, and Vandever to Prairie Streets, was blocked off by fire officials just after the crash Saturday morning, in order to allow F-A-A officials to complete their investigation.

On Sunday afternoon there was a ceremony held to honor Major Francis M. Long of Taylorville who fought and died in the Civil War for the Union.

Kip Johnson a speaker at the event and a Historian of the 41st Illinois Volunteer Infantry for which Long fought says that Long and the 41st had courage, valor and heroism.

The Taylorville School Board met last evening and many important issues were discussed. One of the most important issues brought up at the meeting was brought up by some visitors at the meeting.

Jim Burgett First Vice President and Sean McCarthy First Vice President of Stifel Nicolaus an investment banking company headquartered in St. Louis brought up a sales tax that could help the district.

The tax is called the County School Facility Tax and was passed by the Illinois Legislature in 2007 based on a plan that is used in Iowa.

Superintendent Greg Fuerstenau says that this tax is worth a second look.

The tax revenue would go straight to the school district and the tax would be levied on everything except vehicles, boats, RV's, mobile homes, unprepared food, drugs, farm equipment and parts and farm inputs. Some counties who have passed the tax include Champaign and Macon County.

Fuerstenau says that he wants to start to talk to other school districts in Christian County about the tax.

Another issue brought up at the meeting was the new advisory period which will take place at the Taylorville High School daily for 36 minutes.

Fuerstenau says that this advisory period was made to help students be more successful.

On Mondays the advisory period will include sustained reading, on Tuesdays and Thursdays the period will include organization or club meetings and on Wednesdays and Fridays the period will include student conference with their advisory period teacher.

Also brought up at the meeting was the 2012-13 Budget for the district. The district is anticipated to lose over \$1.7 million in their education budget which will put the overall balance at the end of the 2013 fiscal year down to \$3,033,853.

Fuerstenau says that the district will have to be patient when making future years budgets.

The \$1.7 million loss in the education budget is nearly the same amount that the State of Illinois owes the Taylorville School District.

Items passed at the meeting include.

A consideration of the need for continuation of the designated hazardous walking areas within the District as previously granted by the Illinois Department of Transportation, the consideration of the Illinois State Board of Education Technology Loan Application, and the consideration of the contract facility agreement between Taylorville Community Unit School District #3 and C.E.F.S Head Start Program for the 2012-13 Program year.

All of those items passed unanimously.

The next Taylorville School Board meeting is scheduled for September 10th and school is scheduled to start on August 17th.

Standardized tests are a painful, but necessary evil for some students. These tests for Illinois students include the PSAE, ISAT and ACT.
