Governor Pat Quinn has announced \$100 million from the Illinois Jobs Now! construction program to repair municipal and township infrastructure throughout the state.

The announcement includes approximately \$5.5 million for local governments in Christian, Macoupin, Montgomery, Sangamon, and Shelby Counties. The funding is the last of a series of annual transportation investments that municipalities have received through the Illinois Jobs Now! Program.

The projects will be selected and managed locally, with the Illinois Department of Transportation (IDOT) providing oversight.

In addition to the Illinois Jobs Now! funds, local governments in the counties listed above will receive more than \$31.7 million in Motor Fuel Tax funds this year.

Governor Quinn Announces \$25 Million in Grants for Schools

Governor Pat Quinn has announced grant awards totaling \$25 million to enhance security at 448 public elementary and secondary school districts, community colleges and state universities in Illinois. Local schools receiving grants include: Edinburg, Morrisonville, Pana, Litchfield, Panhandle, Central A&M, Cowden-Herrick, Shelbyville, and Stewardson-Strasburg.

The Illinois Emergency Management Agency (IEMA) announced the Illinois School and Campus Safety Grant Program earlier this year. Only one application per school district or college campus was accepted, although an application could include multiple projects. IEMA received grant applications totaling more than \$54 million from 623 school districts and campuses.

Manar says the plan would limit the loss to one-thousand-bucks per student.
