Acknowledgment of Political Broadcasting Policies of Station WLOH

This will acknowledge receipt of "Information Concerning Political Advertising Policies" of Station WLOH.

I agree that all purchases of advertising time on WLOH which I make by or on behalf of legally-qualified political candidates will be made subject to this Acknowledgment and the WLOH Political Policy.

I certify that I have been fully informed concerning all classes of time which are available to advertisers; rotations of commercials, including without limitation the Station's willingness to negotiate combinations of time suitable to the needs of particular candidates; WLOH's policies concerning negotiated sales of time and sales of time based on audience guarantees; and WLOH's policy with respect to makegoods.

I recognize the exclusive jurisdiction of the Federal Communications Commission (FCC) under the Communication Act of 1934 (The Act), as amended, with respect to all disputes concerning purchases of advertising time by or on behalf of legally-qualified political candidates, specifically including all disputes concerning charges for candidates' "uses" of station facilities. I acknowledge that all such disputes will therefore be governed exclusively by the Act, and the rules and policies of the FCC, and must be resolved exclusively before the FCC, subject to such judicial review as is provided by the Act. In order to ensure that the material necessary to resolve such disputes is maintained, any such complaint should be filed with the FCC within ninety (90) days after the date of the election for which advertising has been purchased.

Unless I am, or represent, a candidate for federal elective office, I agree to indemnify and hold WLOH harmless from and against any and all damages and liability, including reasonable attorney's fees, which may be assessed as the result of advertising, which I purchase.

If I am an agent acting on behalf of a candidate, I certify that I have made full disclosure to the candidate of the information provided by WLOH concerning its political advertising policies, and if not, that I have been specifically authorized by the candidate to purchase advertising time on WLOH on his or her behalf without the need to make such full disclosure. I further represent that I am authorized by all candidates on whose behalf I purchase time to agree to the terms and conditions set forth herein.
