- e. On March 11, 2024, SEU partnered with local businesses and Lake Superior Community Partnership to host a Business After Hours event. The evening was educational with SEU staff on hand answering questions and networking with other local business owners. An opportunity to work for SEU was extended to individuals during the event. The event was heavily promoted using SEU stations and outreach from Lake Superior Community Partnership via email and social media.
- f. On March 20, 2024, SEU representatives attended a job fair at Northern Michigan University in Marquette, MI, to connect with aspiring broadcasters, collect resumes and provide information about the SEU.
- g. On April 16, 2024, a representative of SEU made a presentation to a marketing class on the campus of Northern Michigan University. 40 students were walked through a radio advertising campaign with a hypothetical business. There was an invitation to apply and/or intern with SEU at the end of the presentation.

- h. On May 17, 2024, SEU partnered with Dickinson Chamber of Commerce to promote and participate in 'Lemonade Day.' In this program, school aged children learned how to start, own and operate their very own business a lemonade stand. SEU helped facilitate the event by promoting it, offering radio station tours and interviewing participating students.
- i. An SEU representative serves on the board of Northern Michigan University's student-operated radio station (WUPX). As a Board member, the SEU representative provides advice to students involved in the operation of the radio station about best practices and careers in radio.
