## **Biennial Ownership Reports**

MLS Communications, Inc. (“MLS”) timely filed its biennial ownership reports for 2013, 2015, and 2019, but filed its 2017 biennial ownership report one business day late, due to technical issues and it being MLS’s first time filing an ownership report using the Licensing and Management System (“LMS”). After extensions by the Commission (based in part on the switch from CDBS to MLS), the 2017 biennial report was due to be filed by Friday, March 2, 2018; MLS worked to timely file its biennial report by that date, but encountered some technical difficulties with LMS (even seeking assistance from the LMS help desk, with the issue assigned tracking number HD0000422838), and was not able to complete the filing until the next business day, on Monday, March 5, 2018.
