

Hello KCPN-LD

- SIX ANNOUNCEMENTS: Renewing stations **must air** six (6) post-filing announcements during the four (4) consecutive weeks following submission.
 - * See Announcement below – **Part A**.
- TIMING: ALL post-filing announcements **must air** between 7:00 a.m. and 11:00 p.m. local time.
- SCHEDULING: Stations have discretion **when** to schedule those announcements during the week so long as they are between 7am – 11pm local time.
- WEEKLY RECURRENCE: Stations **must air** at least one (1) announcement each week over the next four (4) weeks.
- ANNOUNCEMENT LIMITATION: The station **may NOT air** more than two (2) announcements per week...and such announcements **MUST** be on separate days.
- TOTAL RUNS: Consequently, there will be two (2) weeks that a station **MUST air** two (2) announcements. As indicated above, stations have discretion **when** to schedule those announcements so long as they are between 7am – 11pm local time and no more than two (2) announcements per week – on separate days.
- FINAL CERTIFICATION: Stations **must complete and upload** a formatted certification statement within seven (7) days following the last announcement.
