G.A. FAMILY FOSTER SERVICES LAUNCHES HOLIDAY GIFT GIVING CAMPAIGN

Heal a Heart for the Holidays to Support Local Foster Children

G. A. Family Services has launched its annual gift giving donation campaign – *Heal a Heart for the Holidays*. Originally founded as an orphanage in 1886, G.A. Family Services, a division of Lutheran Social Services, provides multiple community-based services such as foster care, adoption and post-adoption support, Regional Permanency Center, Accountability and Responsibility After school program, Family Time Visitation, and children’s health home care management. There are currently over 175 children, ages 0-21, under G.A. Family Services foster care, health homes, post-adoptive, and community-based programs, with many more kids awaiting placement in the community.

“Foster care. Kids waiting for adoption. These are hard concepts at any time but even more during the holidays,” said Ericka Garcia-Allison, executive director, G.A. Family Services. “We need everyone’s help to bring holiday joy this Christmas collecting gifts and cash donations to purchase for each child under our care. Generosity today can only be truly realized when you think about the smile and joy on a child’s face, when they feel inside their heart they are loved.”

The program also provides gifts for the foster siblings in each host family home so that they can together rejoice in a holistic holiday family experience. Because many of the children represented are older adolescents and teenagers, monetary donations are encouraged so gifts can be purchased for this specific age group. In addition to monetary donations, G.A. can supply angel ornament gift tags for individual and business specific holiday giving plans. A GoFundMe page has also been established.
