Nashville Public Radio lost three of the four Vice Presidents in a short period of time, which created a significant leadership vacuum in critical departments. Nashville Public Radio's staff doubled between 2021 and 2023. Because of this growth the organization was already considering the creation of a Chief Operating Officer position. At this same time, the VP/Programming resigned with no-notice, creating an emergency need for management level programming oversight. The organization was unsuccessful in recruiting a suitable VP/Programming replacement during an extensive recruiting process. Then the organization became aware of a uniquely qualified individual with extensive programming experience as well as the skills necessary for the contemplated COO role. An unbudgeted exigent hire was made because of these reasons. There have been no other exigent hires at Nashville Public Radio within this or the prior reporting periods.
