## NAMBLA 2

Robert and Barbara Curley filed a \$200 million wrongful death lawsuit against NAMBLA -- the North American Man/Boy Love Association -- in 2000. That was three years after their 10-year old son, Jeffrey, was abducted and suffocated to death with a gas-soaked rag by Charlie Jaynes and Salvatore Sicari. Jaynes then raped the corpse. Sicari is serving a life sentence. Jaynes is eligible for parole in the year 2021.

## PARDONGATE HAUNTINGS

The controversial pardons handed out by Bill Clinton during his last days in office continue to haunt at least one member of the Clinton clan.

Clinton dished out 140 pardons in exchange for payments to family members and associates. Denise Rich gave hundreds of thousands of dollars to the Clintons. And Clinton pardoned her former husband who fled the country in 1983. Marc Rich was trading illegally with Iran while Americans were held captive during the hostage crisis. More recently, Rich traded with Saddam Hussein as part of the Oil-for-Food scandal.

## BORDER PATROL SHOOTING

There is little doubt the court case of Ignacio Ramos and Jose Compean will be making waves in the months ahead.

The pair was sentenced to federal prison last month. Ramos was given 11 years; Compean, 12. They were Border Patrol agents convicted of various charges including violating the civil rights of Osvaldo Aldrete-Davila. He is a Mexican alien who was caught smuggling nearly 750 pounds of marijuana -- about one million dollars worth -- in south Texas in February 2005. When Border Patrol agents stopped Aldrete-Davila's van, he fled, after scuffling with Compean. He was shot in the buttocks by Ramos while fleeing.

The drug smuggler escaped to Mexico and then complained that his civil rights were violated. Federal prosecutors agreed and charged the two agents. They were convicted last March although three jurors have since come forward alleging they were misled by the jury foreman and they believe the agents to be not guilty.

Aldrete-Davila has also filed a five million dollar civil lawsuit against the two now-fired Border Patrol agents. Federal prosecutors have given Aldrete-Davila immunity from prosecution for drug trafficking.

There is no word if the million dollars worth of dope was returned to the Mexican drug smuggler.

This case should be fast-tracked to resolution with President Bush pardoning both men.

The message is troubling, take 1. Longtime TV journalist Jane Pauley has filed a lawsuit against the New York Times and Dewitt publishing. Pauley, a strong advocate for mental health issues, claims she was duped by the defendants into participating in a telephone interview she believed was to have become a news story for the New York Times Magazine. Pauley claims her interview and a large photograph of her instead appeared in an advertising supplement for a pharmaceutical company.

The report notes that Iran's favoring of Shiite leaders in Iraq is actually supportive of U.S. efforts to provide greater Shiite leadership in a country formerly dominated by the Sunni minority.
