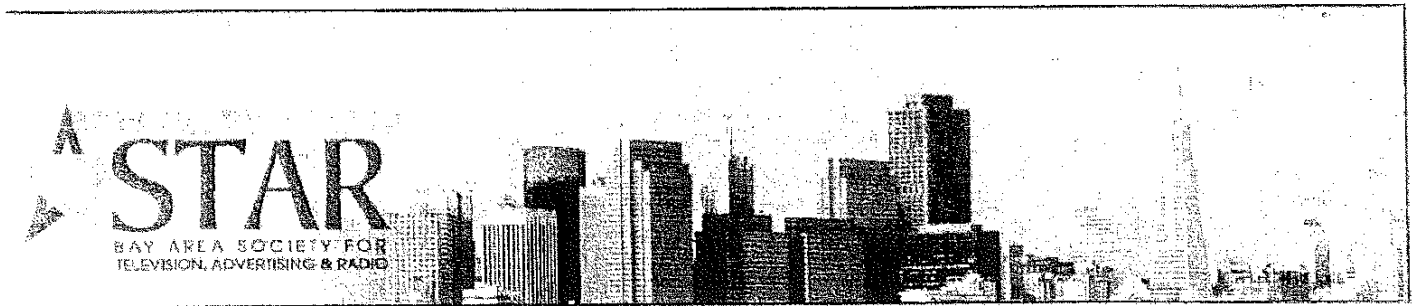

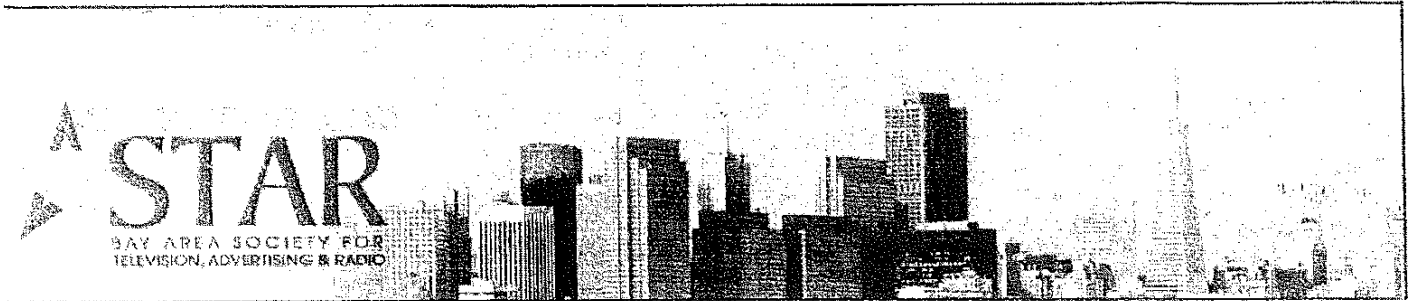

# Bill to Reform State Prisons

A bill by Senator Loni Hancock (D-Oakland) to revise and reform solitary confinement conditions in California's prisons passed its first legislative hurdle this week.

The Senate Public Safety Committee approved SB 892 by a vote of 6-1, with Republican support. It now goes to the Senate Appropriations Committee before heading to the Senate floor.

"Isolating large numbers of inmates for long periods of time as we are currently doing is an expensive and deeply troubling practice that undermines effective rehabilitation and long-term public safety," Senator Hancock said.

"There are many, many problems with the current solitary confinement system," Hancock continued. "It is ineffective at controlling gang behavior in prisons; useless in helping to rehabilitate prisoners; costly to taxpayers; and a threat to public safety when inmates are released directly to the streets after years - sometimes decades - of solitary confinement."

The bill will institute specific reforms to the solitary confinement process, including:

"The fact that I call myself a farmer is highly offensive to many people I've talked to," Carlisle said. "They look at me as if I'm from another planet sometimes. But, I am a farmer. Bottom line."

Not only is she a farmer, but clearly a very good one.

The beds of greens, broccoli, cabbage, and fava bean bouquets suggest someone in tune with the process of seed to soil, cultivation and growth. Acta Non Verba Farm is a quarter acre plot located at

And as a result of the proceeds made from the salsa, jam, sauce and other products from their vegetable garden, they go toward accounts.

"I have to keep the babies. I'm trying to cultivate their minds to help them realize the wonder of a gift of growing," she said.

Carlisle was inspired by the wonder of growing her own food. She thought of her parents' hard work growing the lard greens, tomatoes and pecan tree in the yard.

It wasn't until she was laid off from her job during the Barack Obama administration that she began thinking about the importance of growing her own food.

Attorney General Kamala D. Harris has issued recommendations to California businesses to help protect against and respond to the increasing threat of malware, data breaches and other cyber risks.

“My office issued this guide to support California’s businesses and ensure a robust economy,” Harris said. “This guide offers specific, straightforward recommendations to help businesses continue to thrive by reducing cyber security risks to employees and customers.”

The guide, “Cybersecurity in the Golden State,” provides recommendations focused on small- to mid-sized businesses, which are particularly vulnerable to cybercrime and often lack the resources to hire cybersecurity personnel.

In 2012, 50 percent of all cyber attacks were aimed at businesses with fewer than 2,500 employees and 31 percent were aimed at those with less than 250 employees.

WHEREAS, the Board of Supervisors continues to face diminished federal and state sources of health care funding which affect its ability to provide for the critical and urgent medical needs of low-income and uninsured adults, children, families and seniors of Alameda County; and

WHEREAS, the voters of Alameda County approved by over 78 majority vote the Essential Health Care Services Tax; and

WHEREAS, the Essential Health Care Services Tax will expire on June 30, 2019 if the voters of Alameda County do not approve an extension of the termination date; and

WHEREAS, the entity referred to as Alameda County Medical Center (ACMC) in the Essential Health Care Services Tax

transfers the County's 4 percent tax election held on March 2, 2004; and

WHEREAS, the amendment and extension of the Essential Health Care Services Tax is authorized by Article XIII A of the California Constitution, sections 23027 and 23028 of the California Government Code, and Chapter 2.08.207 of the Alameda County Ordinance Code;

NOW, THEREFORE, the Board of Supervisors of the County of Alameda enacts as follows:

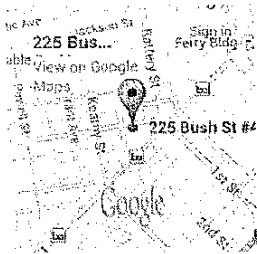
