Tribune Broadcasting Company (“Broadcaster”) provides Clear Vision Cable Systems Inc (“Operator”) with this notice pursuant to Section 325(b) of the Communications Act of 1934, as amended, and Section 76.64(f)(2) of the Rules and Regulations of the Federal Communications Commission.
