Purpose of Application

The purpose of this application is to seek Commission consent in connection with the pro forma transfer of control of the following authorizations - WCHL, Chapel Hill, NC and W250BP, Chapel Hill, NC (the "Stations") from the Leslie G. Rudd Living Trust to Christopher D. Ehrenfeld on a *nunc pro tunc* basis.

Chapel Hill Media Group, LLC ("CHMG") is the licensee of the Stations. On January 31, 2022, the Co-Trustees Darrell D. Swank and Steven Kay, acting on behalf of the Leslie G. Rudd Living Trust (the "Trust"), entered into an agreement to assign all of the Trust's membership interests (25%) in CHMG to Christopher D. Ehrenfeld. Mr. Ehrenfeld previously owned and controlled 25 percent of the issued and outstanding equity and voting interests in CHMG, and after the consummation of this transaction, Mr. Ehrenfeld's membership interests increased to 50 percent.

This transfer represents a transfer of less than 50 percent of the Membership Interests, and Mr. Ehrenfeld, as Transferee, was "passed upon" on "long form" in connection with the assignment of the Stations BTC-20151116AOA. Thus, use of a pro forma application is appropriate. *See Stuart W. Epperson*, Memorandum Opinion and Order, 46 Rad. Reg. 2d 567, ¶ 6 (1979) (citing *Clay Broadcasters, Inc.*, 21 Rad. Reg. 2d 442 (1971)). This transfer is being reported in the Licensee's 2023 Biennial Ownership Report.
