The Taylorville Police Department has terminated Officer Anthony Telford after the department completed its internal investigation of an incident involving Telford last month.

Telford, a seven-year veteran of the Taylorville Police Department, was facing domestic battery charges in Skokie, Illinois due to an incident with his wife following a Chicago Cubs game, where she accused him of choking and punching her in the face during an argument.

Those charges were dropped last week; however Telford had remained on paid administrative leave during the Taylorville Police Department's investigation. Regional Radio News will have more details on this story as they become available.

The Taylorville City Council met in regular session Monday Night at the Taylorville Municipal Building. The issue of an Ordinance that would annex a half acre parcel of land north and adjacent to 110 E. Heights dominated the discussion of the meeting, with discussion on the issue lasting nearly an hour. The issue that arose came from a resident who lives next to the property who has concerns about a project that is currently planned to turn the parcel of land into a parking lot that would exit next to his home should the land be annexed by the council. He stated how that project should it be built as planned would not only lower his property value, but also create a dangerous traffic situation in an area that is already a problem for him due to a fence that sits next to his driveway. Alderman Larry Budd commented on the issue agreeing with the Taylorville resident, and raising his own concerns as to why the project hadn't been discussed with the council.

Because the parcel of land is less than an acre in size, the city engineer can simply approve or deny a project without taking it to the council. More questions were raised however by Alderman Jones as to whether or not City Engineer Joe Greene was aware when he initially approved the project to the concerns that were being brought up in the city council meeting.

The project engineer who was in attendance was asked whether or not they could change the plans of the project so that the parking lot traffic would exit the parking lot at the same entrance it came in at, eliminating the need of a driveway next to the residence's home. The engineer stated plans could be drawn up, however they had to be submitted within the next two weeks for approval. Alderman Vota suggested a solution.

The Taylorville City Council met in their regular session on Monday Night at the Taylorville Municipal Building. One item on the agenda was a motion to approve the request for and to grant a special events permit for the 31st Annual Chillifest to be held on October 1st and 2nd at the Christian County Square. Alderman Earl Walters made a comment on the motion where he shared that this year's Chillifest is slate to be the biggest ever.

There is one event however that the city simply couldn't get put together, that event being the 5-k. That said, there is still plenty scheduled for Chillifest.

Ultimately the Taylorville City Council voted unanimously to approve the request. Barricades will be placed on the south side of the Taylorville square beginning at noon on Friday, September 30th, and the whole square will close at 6PM on Sunday the 2nd until the cleanup is done.

The Taylorville City Council met in their regularly scheduled meeting on Monday Night at the Taylorville Municipal Building. The meeting started off with the Mayoral Appointment of Ann Chandler to the Library Board, which the council approved unanimously. The Council also voted to accept the resignation of former Police Chief Dave Herpstreith, which also passed unanimously, with comments coming from the council commending the job that Herpstreith has done.

The major item of the night revolved around the pay of several elected officials. There were motions to direct City Attorney Rocci Romano to prepare ordinances to provide an annual salary of \$58,000 for the Mayor during the four-year term of office that begins in May of 2017, as well as for ordinances regarding pay for the city Alderman, as well as City Clerk and Treasurer. Alderman Shawn Burtle commented on the matter stating how he believes that a raise in the Mayor's pay doesn't always equate to a raise in performance from the office, bringing up examples of how the city had paid past mayors substantially more, and how current Mayor Greg Brotherton was currently doing a good job at a lower rate of pay without having a secretary.

Another issue that was brought up by Alderman Ernie Dorchinecz (dor-shin-ez) was the fact that two Alderman, Bruce Jones and Rob Heberling, were both absent from the meeting. He felt it was only fair that the motions regarding official salaries were tabled until they could be voted on by the full council. The motion to table for the raise for the Mayor's Salary was passed 4-3, with the motion to table for all other matters failing, and those motions all passing with only one no vote for each.

One item on the agenda that had received some interest in the community was an ordinance to eliminate the residency requirement for the City Librarian. Alderman Larry Budd read an e-mail he had received from a concerned citizen that stated how her grand kids attended schools in Taylorville, however lived in another city. The e-mail detailed how her kids could not utilize the Taylorville library, due to not technically being residents of the city. She asked that should the council eliminate the residency requirement for the City Librarian position, they consider allowing non-residence of the city to utilize the library, should they work or attend school in the city. Alderman Budd shared that he had explained to the citizen that the reason the city was eliminating the residency requirement for the Librarian position, was due to a lack of qualified candidates within city limits who were interested in the position. Ultimately the motion to eliminate the residency requirement for the City Librarian position passed unanimously.

Another topic of discussion at Monday Nights Taylorville City Council meeting revolved around the security at Lake Taylorville. The Lake and Airport Committee held a meeting prior to the city council meeting, where they voted on a motion to install a new security system at the Lake Area, which includes the replacement of cameras with new, high definition security cameras in many different locations around the lake and marina. The motion passed unanimously in the committee, as well as during the council meeting. Alderman Martin Vota wanted to let the public know that the issue of security at Lake Taylorville has been addressed.

After approving the payment of bills, the Taylorville City Council meeting adjourned at 7:52pm.

The Christian County Board met in regular session last night at the Christian County Courthouse. The meeting started off with the presentation of a zoning ordinance reclassification of a parcel of land being annexed into Taylorville from residential to commercial. The reason for this change was for the construction of a parking lot, and landscaping purposes. After the reading of communications, the meeting moved on to the various committee reports.

One item that generated some tense discussion during last night's county board meeting was discussion on the current financial software company that handles payroll for the county. When the county switched from the old software to the new, the county encountered some issues with the system as well as the company that makes the software. This has led to issues regarding the hours and money spent on the conversion. County Treasurer Betty Asmussen wanted clarification on why this was the case from Christian County Clerk Laurie Mense.

The Christian County Board met in their regular monthly session on Tuesday night at the Christian County Courthouse. The main items of the night revolved around dissolving the current Christian County 911 board, and approving the members that will represent Christian County on the new consolidated 911 board with Shelby County.

There was some concern from County Board Member Matt Wells as to the members representing Christian County on the new board. Wells was concerned about how there is not representation of all four of the Christian County districts on the new board. County Board member Jack Pearce informed Wells that the reason was that those members on the previous Christian County 911 board who are from the districts that wouldn't be represented on the new consolidated 911 board with Shelby County, had decided to step down from their positions when the Personnel Committee was nominating potential board members for the new consolidated 911 board.

There was also some discussion on whether or not Taylorville Police Chief Dave Herpstreith should remain as one of the nominated members of the new 911 board due to his decision to step down as Taylorville Chief of Police. The decision was made to keep Herpstreith on as a nominated member for now. Ultimately every member who was nominated to represent Christian County on the new Consolidated 911 Board with Shelby County was approved.
