### Taylorville City Council Story MOD 1

The Taylorville City Council met in regular session on Monday night. Before the council meeting, Chairman Larry Budd called a Finance Committee meeting at 6 p.m. to address the budget cuts for the 2015-2016 fiscal year budget. A total of \$529,000 was cut from the various departments that will meet the deficit. The amount will be included in the Appropriation Ordinance, should more funds become available. Mayor Greg Brotherton told Regional Radio News that they quickly had to go back over the budgets and get something that would match so the revenue expenses were much closer together.

Key 3 (...in the year) (:38)

Mayor Brotherton and the Councilmen had a lengthy discussion about creating a separate account or a new fund from the Video Gaming revenue. A motion was approved to approve the Fiscal Year May 1<sup>st</sup>, 2015 to April 30, 2016 Budget in the amount of some \$56 million dollars. Appropriations of the 2015-2016 budget was also approved in the amount of some \$74 million dollars. A motion was also passed to direct the City Clerk's office to prepare the Appropriation Ordinance budget and that the document will be available for public inspection in the City Clerk's office beginning July 10, 2015 and that a public hearing will be set for Monday, July 20, 2015 at 6:45 p.m. The Finance Committee meeting adjourned at 6:35 p.m.

Taylorville City Council Story MOD 3

In other Taylorville City Council action, an ordinance was approved to change the yield right of way street to a one-way stop on Second Street, easterly bound at the intersection with South Main Street. A motion was passed to change the date of the Tuesday, September 8<sup>th</sup> City Council Meeting to Wednesday, September 9<sup>th</sup>. A motion was approved to increase the insurance coverage on the high school water tower. In the finance section, the council passed a motion to contribute \$5,000 to the Christian County Senior Citizens which was included in the Fiscal Year 2015/2016 budget. A motion was approved of a resolution with SIMEC energy to continue serving as the City of Taylorville's exclusive consultant for its Electric Aggregation Program.

Another motion was passed to retain First Midstate Investment Bankers of Bloomington for \$3 million dollars in Alternate Revenue Bonds for funding the 30" Northeast Sewer Line. Aldermen noted it will help provide future development for the northeast side. A motion was approved to ratify the payment of bills of some \$166 thousand dollars.

The meeting adjourned at 7:50 p.m.

In other Taylorville City Council action, the Mayor stated he is looking for members on the Tree Board. Some of the trees growing along the boulevards in town are 50-70 years old and it can be expensive to take down a tree.

Mayor Brotherton brought up the traffic situation from North Pawnee Street to the Junior High School and North School, due to schools starting in mid-August. He says there is a safety concern for kids walking between North School and Taylorville Junior High School. It's been a problem for decades and is a mess, traffic-wise. Mayor Brotherton said they will close the road, as gates have been installed and will see how the traffic-flow is, though a few tweaks are possible.

Key 4 (...make them permanent) (:18)

Councilmen, Earl Walters, spoke briefly about one of the bat-wing mowers which is experiencing problems as it continues to break, however there is an opportunity for the City to trade-up and get a better bat-wing mower. Mayor Brotherton stated a vote to make the purchase of a bat-wing to replace the old one will come up in a future meeting.

In other Taylorville City Council action, a motion was approved for Police Chief Dave Herpstreith to send five police officers to the Basic SWAT/CQB Training in Lincoln at a cost of \$2,500. Mayor Brotherton says the new hires have not had this training yet. He added it would be a good experience for the officers and will greatly benefit the City in the long run.

A motion was passed for Cindy Brown to be appointed as the City's Plan Administrator for the Nationwide PEHP Plan. A motion was approved to bid and/or advertise a Heavy Equipment Operator position at the Street Department and a Deputy Treasurer Position. Mayor Brotherton stated where these positions can be filled in-house, or may hire outside if no one within the City departments' bids for it. A motion was passed to allow Lake Superintendent Alan Jackson to utilize UniQue Personnel to clean the Lake Cabins for the remainder of the year and to purchase four futons or roll-a-way beds in the next six months for the cabins. A motion was also approved the Mid America Sport Parachute Club Special Events Permit for "Old Timers Boogie" to be held Friday, August 28 through Sunday August 30th on Airport property and acre property owned by MASPC, subject to the receipt of proper insurance certificates for the Cessna Caravan and hot air balloon.

Tville City Council Story MOD 2

In other Taylorville City Council action, a resolution was approved for an agreement for engineering services with Vandevanter Engineering, related to the Market Street Lift Station Retrofit. The Council approved this, along with the waiving of bidding. Councilman Earl Walters stated the City must proceed on this as the consequences of the lift station would be big for the residents on the northeastern side of town. The City could apply for an Emergency Grant and hope to get something done. However, when the grant was filed, due to the state budget and the backload, it could be several months before the Emergency Grant committee could look into it. Mayor Greg Brotherton said this has to be fixed as soon as possible, as there's the danger of the Market Street lift station container giving way and the walls collapsing on it. However, there could be another option that might come at a lower price.

The City has worked with Vandevanter Engineering in the past and has a good working relationship with them. Mayor Brotherton stated they would have to work together as a team and fix it themselves. In the Lake/Airport section, the Council approved the motion to extend the City's deer hunting season to January 17, 2016 for bow hunting only, which would run concurrent with state law.

Sheriff Kettelkamp Strongly Opposes HB 218; Encourages Citizens to Write to Governor Rauner to Veto It

Christian County Sheriff, Bruce Kettelkamp, issued a statement Tuesday afternoon, encouraging every citizen in Christian County to contact Governor Rauner's office and ask him to veto bill HB 218. The purpose of this bill is to decriminalize the possession of 15 grams or less of cannabis. The bill has already faced opposition, as the Illinois Chiefs of Police Association and the Illinois Sherriff's Association strongly oppose it.

Kettelkamp told Regional Radio News that it is a bad deal for the following reasons. Contained in the bill is no age limit. Meaning that the legislation would allow a 13 year old to possess the equivalency of a pack of cigarettes of 20 to 30 joints, a minimum fine of \$55.00 and no limit on the petty offense you could receive, nor any accountability for one's actions with automatic expungement every 6 months.

Another issue with the bill that Kettelkamp pointed out was the number of nannograms. Law enforcement sources cite that 15 nannograms is equivalent to a blood alcohol content level of .30, which would make it four times over the legal impairment limit and the highest in the nation.

Key O (...veto this bill) (:38)

In a civil case, you would not be able to prove that an impairment driver who had 14 nannograms, killed an innocent victim. It would be a severe blow to someone filing a wrongful death suit.

Finally, Sheriff Kettelkamp stated that it is sending the wrong message to the youth.

Key P (...the wrong message) (:18)

HB 218 was introduced by Representative Kelly Cassidy (D-Chicago) and lead Senate sponsor Senator Michael Noland (D-Elgin).

COUNTY BOARD STORY MOD 2

In other Christian County Board action, the board approved a motion for the Sheriff's office to hire another deputy in order to enter the contract with the Village of Assumption. It will be for a three year period, as the deputy will also be an employee of the county and patrol the town. Assumption would have to provide a squad car, along with fuel, while the county will provide the deputy and benefits.

The wage proposal mirrors the FOP Step Program, with costs ranging from some \$62 thousand and increase to some \$72 thousand by the third year. The amount charged will go from \$68 to \$78 thousand dollars, County Board member, Ashley Linton, stated she has talked to residents recently in the communities of Mt. Auburn and Assumption and the people there have stated, they have been feeling left out when it comes to Christian County patrol. County Board Chairman, Paul Schmidt, says it gives the county flexibility by receiving revenue and helping the town of Assumption.

## Christian County Board Story MOD 2

In other Christian County Board action, the big topic of discussion was the possibility of the City of Pana and the County to apply for available grant funding for blighted properties. Attorney Steven Mahrt of Ancel Glink of Bloomington, Illinois came and spoke about the steps necessary in order to accomplish a grant application and also answered questions that Board members had. Pana Mayor Steve Sipes was also in attendance and told the Board in a recent committee meeting that the City and County could form a not-for-profit agency by an intergovernmental agreement like the Cook County Land Bank. After a lengthy discussion, the Board decided to move on with plans with a joint agreement with the City of Pana and the Board in establishing a Land Bank. There was also a motion where a \$1,000 rental fee will be used to create the Land Bank. Schmitz said the County will be the Land Bank and will hold the property for the City of Pana and the County. Ten properties will be identified to be torn down and will be back on tax rolls, where the tax money will be received by Pana and the County.

## Taylorville Development Association Rejects Offer of 34 Acres for Sale; Seeking Higher Offer

The Taylorville Development Association held a special board meeting on Wednesday morning at Peoples Bank & Trust to discuss an offer made for the remaining 34 acres for sale on Route 104, west of Hickory Estates and behind it. According to Ken Hart, President of the Taylorville Development Association, he said the offer was not high enough, so they rejected the offer. The acreage is listed with Curvey Real Estate. Hart says they are currently seeking a higher offer.

Hart and Mary Renner, President of the Christian County Economic Development Corporation, met with the Regional Economic Development Association in Carlinville a few weeks ago, about the process to apply for a grant for the Taylorville Industrial Park. Phase 1 for the Taylorville Industrial Park will cost about \$1.5 million. However, if they contribute half of the total amount which is \$800,000, then they can apply for the grant which will be used to pay for the remainder of Phase 1.

As July is drawing to a close and August is around the corner, it's a reminder that schools will be in session. The Taylorville School District has announced the dates and times of registration for the 2015-2016 school year.

Families of returning students may begin the online registration process on July 24. The primary guardian will have to log on to the district's Skyward Family Access page at [www.taylorvilleschools.com](http://www.taylorvilleschools.com). Parents or guardians, who may not have a log-in account and password, may call their school to obtain this information. Health, dental and vision exam forms, as well as elementary and junior high supply lists are available on the district's website on the registration page.

Registration in each of the elementary schools will be held on Tuesday, August 11, from 8:30 a.m. – 3:30 p.m. and Wednesday, August 12, from 12 noon to 7 p.m. Students entering kindergarten must be five years old by or on September 1, 2015.

Registration for Taylorville Junior High is on Monday, August 10 from 8:30 a.m. – 3:30 p.m. Tuesday, August 11 from 8:30 a.m. – 3:30 p.m. and Wednesday August 12, from noon to 7 p.m. There will be an orientation for all incoming fifth graders, and parents are welcomed and encouraged to attend. Fifth grade orientation will be held in the Forum on August 12, at 1 p.m., 4 p.m. and 6 p.m. Orientation for new sixth through eighth graders will be held in the forum on August 11 at 10:00 a.m.

Taylorville High School registration will be held during the week of August 10. Seniors is on Monday, August 10 from 8:30 a.m. – 3:30 p.m.; both sophomore and junior registration will be held Tuesday, August 11 from 8:30 a.m. – 3:30 p.m. and freshman can register on Wednesday, August 12 from 12 noon – 7 p.m. Regardless the grade, working parents can take advantage of registration during the evening hours on Wednesday.

## Lahey Elected as 2015-2016 Illinois Association of Student Councils State President

At the Taylorville City Council on Monday night, it was announced that Derek Lahey, an incoming senior at Taylorville High School, was elected as the new Illinois Association of Student Councils State President.
