Tville City Council Story MOD 1

The Taylorville City Council met in regular session on Monday night and approved several motions. The item on the agenda that spurred the most discussion was a motion to approve the final payment request documents to the Illinois Emergency Protection Agency for the Taylorville Municipal Airport Leaking Underground Storage Tank Program. This was due to leakage of fuel tanks at the airport that were removed and had to go through the IEPA Program to get it done, which required hiring someone of the expertise to remove them and to have an engineer to oversee the program and do the filing, which was done four years ago. Mayor Greg Brotherton told Regional Radio News this has been very frustrating with the pace the IEPA has been going, and may still be dealing with this for three-six more months due to the budget impasse at Springfield.

City Attorney, Rocky Romano, stated there was some trouble with the forms that the Mayor was asked to sign off the documents to certify if it's right or not. Mayor Brotherton stated the one problem he had was the length of all the documents which totaled some 700 pages and the engineering jargon.

A motion was approved for the Mayor to sign the two Certification forms that was drafted by Romano and the General Information for the Budget and Billing Forms. This will facilitate the processing and submittal of the final pay application and the final budget documents seeking the final IEPA payment, an "IEPA No Further Remediation Letter", the official IEPA closure of the pending Taylorville Municipal Airport Leaking Underground Storage Tank remediation program and to consummate the settlement with IEPA of the City's pending appeal before the Illinois Pollution Control Board.

Taylorville City Council Story MOD 3

In other Taylorville City Council action, Alderman Larry Budd announced the results of the City's FY 2014/2015 Audit as reported by Treasurer Nation. Budd stated the City finished in the black, but was warned by CPA Rich Hooper of Lively, Mathias, Hooper and Noblett of the conditions of the sewer infrastructure. Mayor Brotherton said money isn't being set aside for future repairs with the sewer, but will have to by the possibility of higher rates or taxing residents.

Some of the alderman also expressed their disappointment that Hooper could not attend the meeting, as he had scheduling conflicts. The City also approved the motion of purchasing two 2016 Ford Interceptor Utility all-wheel drive vehicles from the lowest bidder, Bob Ridings at a cost of some \$55,000 for the Police Department. The City also approved the payment of bills totaling some \$347,000 and the meeting adjourned at 7:58 p.m.

### Gagne Donates Distributing Buildings to City of Taylorville

Jim Gagne of Gagne Distributing has donated the two buildings to the City of Taylorville today (Friday morning) as Mayor Greg Brotherton received the keys to the structures. The donation saves the City hundreds of thousands of dollars. Brotherton told Regional Radio News it all started when Gagne contacted him this summer about donating the buildings, as he was getting ready to retire.

Though the buildings were donated, the City will have to pay for the electricity, and have insurance coverage for it. A survey was also recently conducted. The buildings provide an ample amount of space, which not only has several office rooms, but a large garage bay where the City's expensive equipment can be stored, so it can be protected against the elements. Superintendents of various departments within the City were in attendance and toured the building. With the arrival of public transportation coming to the county very soon, Mayor Brotherton also mentioned the possibility of the Central Illinois Public Transit storing some of their shuttles and buses.

Taylorville Park Board Story MOD 1

The Taylorville Park Board met in regular session on Monday night. The item that spurred the most discussion was the indemnity agreement update. Taylorville Mayor Greg Brotherton, City Attorney Rocky Romano and Taylorville Fire Department Assistant Chief Andy Goodall were in attendance to answer any questions that board members had, in regards to the intergovernmental cooperation agreement that the City of Taylorville approved last week during their council meeting. Romano stated the City wants to cooperate with the Park District. In a specific section of the agreement, Park Board Attorney, Quinn Broverman, said the indemnity does not indemnify them, so if any City worker gets hurt, then the Park is responsible. Mayor Brotherton and Romano attempted to clarify what the wording meant in the agreement.

Marlane Miller, President of the Park Board, told Regional Radio News the sticking point was the section of indemnification, and where the City will haul away the debris in the agreement was removed.

A motion was approved for the City to make changes to the agreement. The City will get back with the Park next week and a special meeting will be held to get it approved, as Goodall has to obtain a permit through the Illinois EPA for a controlled burn.

Tville City Council MOD 1

The Taylorville City Council held their regularly scheduled meeting on Monday night. The item that generated the most discussion was a motion to submit the proposed ordinance of amending sections to allow indoor firing ranges as a special use in Taylorville. At the ordinance meeting last week, Joshua Assad, owner of JMA Pawn told the committee last week, he would like to transform the former Goodyear Building on North Webster Street into a facility that could have an indoor range, archery range, armory and multiple showrooms. The Council approved the proposed ordinance with a 7-1 vote, with the lone "no" vote from Alderman Larry Budd. Budd told Regional Radio News he has a problem with the location, since it's in a residential area and also the amended ordinance of one section which would allow .50 caliber bullets to be fired and automatic weapons.

Tues Key 4 (...citizens of Taylorville) (clip 1) (:39)

Budd did make a motion to table this item and bring it back to the committee, but there was no seconded motion to table. It is a possibility that the indoor range could be a Class 3 Federal Firing License, which allows automatic weapons to be fired at the facility. Facilities that have this type of license are in the bigger cities such as St. Louis and Chicago. Alderman Rob Heberling said he would vote in favor of this, yet still has several issues, including putting some mandates on noise abatement and air quality issues. Alderman Bruce Jones noted the proposed document will go to the Planning and Zoning Commission and they can make changes to it, such as taking out the section of automatic weapons. Jones further stated a public hearing will be held on this issue.

In other Christian County Board action, the financial status of the 911 dispatching was discussed. On December 18, 2015, they will be out of funding. Due to the situation of the State, the last payment was in August. Legislation is proposed to take motor fuel tax monies to help 911 and the lotto, but even that may not be fully funded. In fact, the County is not receiving the motor fuel tax funds for the highway department for the projects they have allotted. Fred Curtin, Finance Committee Chairman provided an update during the meeting, saying the State swept all the 911 funds out and they're gone.

### Sheriff Kettelkamp Warns Citizens of Recent Scam

Christian County Sheriff Bruce Kettelkamp is warning citizens of Christian County of a recent scam that is going around the county. The scam is a call reported to be from the U.S. Grant Department, issuing individuals \$9,000 for being good citizens for not filing bankruptcy and paying their taxes. The only thing you have to do is go to Wal-Mart and call the scammer and they will instruct you on how to pay them \$200 in order to receive the \$9,000 grant.

The U.S. Department of Health and Human Services has provided advice when it comes to a grant scam that no legitimate federal government employee would ever call you and tell you that you qualify or have been approved for a grant that you've never applied. Citizens are to protect themselves from scammers that tell you that you need to pay a small processing fee to qualify to receive a grant for education costs, home repairs, home business expenses, or "money for nothing" grant offers.

If you think you may have been a victim of a government grant scam, you can file a complaint with the Federal Trade Commission, or call toll free at 1-877-FTC-HELP (1-877-382-4357). The FTC enters Internet, telemarketing, identity theft, and other fraud-related complaints into Consumer Sentinel, a secure online database available to hundreds of civil and criminal law enforcement agencies in the United States and abroad.

Christian County Board Story MOD 1

The Christian County Board met in regular session on Tuesday night. Board member Donna Hibbets was absent. On the agenda was the discussion and reviewing the Fiscal Year 2016 Budget. The proposed FY 2016 Budget reflects a \$718,000 deficit. The Board passed the FY 2016 Budget with a 9-6 vote. Paul Schmitz, Chairman of the Board, told Regional Radio News that he feels embarrassed due to the deficit in the budget, but says they have to work with what they get, as the State continues to hold back funds.

Schmitz said the income is roughly some \$6 million, while expenses are some \$689,000.

A motion was approved to adopt the proposed tax levy. Amanda Cole, University of Illinois Extension Unit 18 Director was in attendance and stated the money goes to Champaign, but comes back via the State One Match.

## County Board Approves County Assessor Resolution

The Christian County Board, in the final meeting of the year, approved a resolution to place on the upcoming ballot. The resolution gives the voters the choice of changing the County Supervisor of Assessments from an elected position to an appointed position. After much discussion concerning the merits of both positions, the Board passed the resolution with five members voting against.

In other business, the board approved a proposal by RICOH to provide every office in the County with printers and copiers. They will be removing some machines and converting others. It was pointed out that over the term of the five year contract an estimated savings of some \$52,715 is anticipated. The board also approved the purchase of a Ricoh Wide Format Printer/Scanner for the Highway Department. The wide format will allow the Highway Department to convert their old plats and maps to digital form. The purchase price was quoted at \$9880 with a \$1000 rebate applied if purchased before the end of the year. A service contract was also approved at a cost of \$62.19 per quarter.

The board received sealed bids for the delivery of gasoline and diesel fuel for 2016. Christian County FS was awarded the bid by presenting the low bid on Diesel, Dyed Diesel and Diesel Additive.

The meeting was adjourned at 7:25.

### GTCC Reminds Residents to Shop Local this Holiday Season

Following Black Friday and Small Business Saturday, many people are still shopping for gifts for their friends and family. A reminder was sent by the Greater Taylorville Chamber of Commerce, reminding area shoppers to shop locally and support the local economy. GTCC President and CEO Patty Hornbuckle, tells Regional Radio News that the upcoming holidays are an important time for the community and encourages residents to shop local first.

According to statistics in the statement, folks who shop locally will generate two to three times as much economic activity in the community, than if money was spent at a national chain in a near metropolitan area. An independent shop owner will keep \$56 to \$73 in the local economy out of \$100 that shoppers spend, and a non-locally owned business only keeps \$16 to \$43 in the local area out of every \$100 that consumers spend. There is also a stronger chance of purchasing an American made product at a local store than anywhere else. Hornbuckle states money pumped into the local economy generates the sales tax, which helps economic development.

### Senator Manar Visits Taylorville School District

State Senator, Andy Manar (D-Bunker Hill), stopped by the Taylorville School District on Thursday as he toured the pre-kindergarten program at North Elementary School. Sen. Manar tells Regional Radio News that Dr. Gregg Fuerstenau and the staff are leading the way to do things under difficult circumstances, because of the current state budget situation. He also described serving more students in pre-school and early childhood development programs.

As SB 1 awaits debate and a vote in the Senate, this year's state education budget set aside additional funding to assist financially distressed school districts. With the new funding, Taylorville schools receive an additional \$53,000.

### Local School Districts Feeling Effects of State Budget Impasse

The effects of the lack of a state budget are being felt in the state, as it has been several months since a budget has been passed. School districts in particular are feeling the effects. Dr. Scott Doerr (Pronounced: Do-Err), Superintendent of Nokomis Community Unit School District #22 tells Regional Radio News though the General Assembly and Governor Rauner signed the K-12 budget this summer, it only affects those monies coming in for general state aid, not the mandated categorical payments they should be receiving.

Doerr says from what he's hearing, a state budget may be passed in January, or early February. He also stated the timing is interesting, because in February or March, Rauner will be giving a budget address for the next fiscal year.

### Senator Manar Discusses New School Carbon Monoxide Law

Many new laws will go into effect on January 1, and one of those is protecting students and staff at Illinois public schools from the dangers of carbon monoxide leaks. This legislation was known as House Bill 152 and was started as a result of a faulty exhaust pipe at the North Mac Intermediate School in Girard that sent 150 students and staff to the hospital for carbon monoxide poisoning. At the time of the incident, there were no carbon monoxide detectors. State Senator, Andy Manar (D-Bunker Hill) of the 48<sup>th</sup> Senate District, told Regional Radio News this gas is odorless, colorless and in excess amounts, it can kill. He also mentioned they struck an appropriate balance with this new law.

Manar stated the law will require existing schools to install detectors within 20 feet of equipment that produces carbon monoxide such as a furnace. School districts that build a building or does any additions to a building, the law would require detectors to be installed next to smoke alarms.

Other states that have similar requirements for carbon monoxide detectors in schools are California, Connecticut and Maryland.

### U of I Extension and IDPH Provide Health and Safety Tips Following Flood

As central Illinois residents are cleaning up following the flood, the University of Illinois Extension and the Illinois Department of Health (IDPH) would like to remind residents of some safety tips as concerns about personal health and safety may increase in the following days and weeks. Doug Gucker (pronounced: Goo-ker), U of I Extension Educator of Local Food Systems and Small Farms of Unit 17, told Regional Radio News that flood water could be infected with sewage and other contaminants that could affect personal health.

Wed Key A (...water if possible) (clip 1) (:34)

Gucker added buildings that have water should be dried out as quickly as possible, and if the moisture doesn't get out, mold could form. He also mentioned injury can occur if objects that haven't drained well can be extremely heavy to lift.
