After 2 weeks of discussion among City Council members and the community, the Taylorville City Council <sup>Monday night</sup> voted 4 to 4 on the proposed amendment to the city's ambulance ordinance, to allow the Fire Department ambulance to be a choice for 911 callers. Mayor Greg Brotherton had to break the tie, and voted no, defeating the proposal.

Aldermen Ray Koonce and Martin Vota changed their votes from 2 weeks ago, voting against the ordinance change.

Koonce told aldermen he changed his vote after meeting with all parties concerned.

Vota told the City Council Monday night, that several questions he had after the last meeting, have yet to be answered.

## Mayor Explains Ambulance Vote

Taylorville Mayor Greg Brotherton recently found himself the decision maker in a controversial issue. The City Council was moving towards an ordinance which would have offered 911 callers the option of picking city ambulance service instead of just the two for profit services. The council originally voted six to two in favor of moving ahead with the plan. When Aldermen Ray Koonce and Martin Vota changed their positions, it became a four to four tie. The Mayor broke the deadlock, in favor of dropping the plan. Mayor Brotherton says it's a complicated issue:

By City Ordinance, the Mayor can only vote in the event of a tie.

The Taylorville City Council made quick work of business in a 26-minute meeting Monday night.

Aldermen OK'd the installation of a one-way stop sign southbound at North Abby Street; they OK'd an inspection of the Lake Taylorville Spillway Dam; they OK'd repairs to a police car totaling some 3-thousand dollars; OK'd 2 positions to be advertised in the Water Department; and OK'd directing the Fire and Police Commission to hire 2 police officers from the final eligibility list.

Taylorville Council members Monday night passed motions for the annual testing and inspecting of the city's 3 water towers costing nearly 22-hundred dollars; they purchased Ditch Witch equipment for the Water Department costing some 46-hundred dollars; and asked Verizon Wireless to pay the city some 5-thousand dollars towards attorney and consulting fees to consider the feasibility of installing cell phone antennas on the city's water tower at the high school.

Taylorville Aldermen Monday night accepted dedication of property at the end of Summit Avenue in exchange for the installation of a tape and service line; and OK'd the city's annual tax levy totaling some 2-point-6 million dollars.

## Christian County Board Hears Update on Grain Belt Express

The Christian County Board heard a report from Rick Cornell, director of Illinois Outreach for Clean Line Grain Belt Express project. The project is earmarked to build a 750 mile transmission line from Kansas to Indiana for the purpose of moving 3500 megawatts of electricity. This amount of electricity would provide power to 1.4 million homes per year. The total project investment is approximately 2 billion dollars or 2 million dollars per linear mile. Mr. Cornell pointed out that the proposed line is projected to cut across either southern Christian County or northern Montgomery County. Some of the pluses include the use of local vendors for materials, transport and some labor. The company has also agreed to pay the county the amount of \$7000 per linear mile per year with a minimum of 20 years. There will be a public meeting for the purpose of discussing the possible land owners that could be affected and the compensation packages that will be offered. This meeting will be held in Pana at the Eagles on December 3, 2014 from 5 to 8 pm.

The board members also continued a long running discussion on the fate of Public Transportation program in Christian County. The county stands to lose a \$325,000 reimbursable grant if they don't file the proper paper work by the end of the year. Between the county and the Senior Citizens of Christian County, they have had 2 years to get the proper paperwork filed. It was moved, seconded and approved to have Chairman Schmitz contact CEFS for guidance on what needs to be done. It was agreed by all that public transportation is sorely needed in Christian County and to lose the grant would be the death of the program.

Outgoing County Clerk, Linda Curtin reported that there would be testing at the Christian County Courthouse on December 11, 2014 at 10 am for the purpose of filling the Supervisor of Assessment position that is being vacated by the resignation of Mike Gianasi. The test is just one of the necessary requirements that must be met in order to be considered for the position.

Delbra Pratt, chairwoman of the "In God We Trust" Put It Up committee, was on hand and presented the board with a framed poster with the National Motto, "In God We Trust". She stated they are a grass roots effort to get all buildings in the county to display the motto per House Resolution 13 that approves and encourages the display of the motto.

The board said farewell to 4 board members, Dick Breckenridge, Dave Reed, Greg Hager and Joe Marley. They were presented with Certificates of Appreciation. County Clerk Linda Curtin was also honored for her many years of service and was presented a certificate as well as a commemorative key.

## County Board Approves Public Transportation Resolution With Christian County Senior Citizens Center

The Christian County Board met in the last session of the year and approved a long awaited resolution authorizing the Christian County Senior Citizens Center to submit an application for public transportation funds in Christian County, one of only 3 counties in the state without public transportation. The Senior Center advised that they presently operate 10 buses and that many seats are available on these buses. The advantages to the County include no start up monies and funds reimbursed directly to the County quarterly and then reimbursed by the County to the Senior Center. There was some discussion about the charges to passengers. It was pointed out that presently the busses are used under a program called 5310 that does not require passengers to pay, however passengers can pay a \$2 fee if they choose. When the busses become public transportation, they will fall under the 5311 program which would require passengers to pay a minimal fee. The motion was approved with 1 no vote.

The Board also heard a report concerning the state of the financial software presently being used by the County Clerk and Treasurer's offices. Representatives from Zobrio, a financial software company, offered an upgrade or new system, stating the present system would no longer offer system updates in 18 months and support maintenance costs on the 20 year old system would increase by approximately 15%. It was decided to have the County Clerk and Treasurer develop their needs for a new or upgraded system and report back to the committee.

In other business the Board approved resolutions to appropriate funds in the amount of \$750,000 for maintenance during FY2015, \$60,000 for payment of social security and IMRF during FY2015 and \$107,900 for payment of the salary and expenses of the County Engineer for FY2015. All funds were appropriated from the Motor Fuel Tax Fund. The Board also unanimously approved a Memorandum of Understanding with AFSCME to transfer a highway employee, his income and insurance from the highway department to the new position of Building and Grounds Maintainer for the Courthouse. It was also noted that no candidates passed the testing required for the vacant Supervisor of Assessment. The meeting was adjourned at 7:05.

SUPERINTENDENT OF SCHOOLS, DR. GREG FERSTINEAU SPOKE IN SUPPORT OF SENATE BILL 16 FOR SCHOOL FINANCIAN AT THE CHRISTIAN COUNTY BOARD MEETING TUESDAY NIGHT

Superintendent of <sup>TAYLORVILLE</sup>Schools, Dr. Greg Ferstineau addressed the Christian County Board explaining how Senator Andy Manar created Senate Bill 16 for school financing. Ferstineau said Andy Manar wanted to make school financing one of his "top priorities". The Bill was produced by Manar – it's basis is to re-distribute money on the schools "ability to pay" and the "poverty ratio". Ferstineau went on to say the poverty ratio is about even in Pana and Taylorville schools.

Senate Bill 16 has passed in the Senate, and is now in the House. <sup>Many</sup> ~~Every~~ school district would get additional funding under Senate Bill 16.

Another item addresses was the Christian County CEO Program. Speaker Ken Hart, informed the Christian County Board that Christian County is losing its population – people are moving away.

Hart explained that the CEO Program is a year-long course designed to utilize partnerships that provide an overview of business development and processes. Our local business community partners with area schools to create project-based experience, meeting space, business tours and one-on-one mentoring. It's offered to High School Seniors early each morning and tells them how to get started, and how to grow their own business.

The CEO Program started six years ago in Effingham County and there are now sixty new businesses in Effingham because of the CEO Program. The program is geared to teaching High School seniors who want to go into business for themselves. Hart asked the Christian County Board to donate \$1000 to the highly successful program that will build business in our community. A motion was made, and the Christian County Board approved to donate to the CEO Program.

Next on the agenda, Greg Hager presented Highway, Building, Grounds, Enviromental, Zoning, Welfare reports from the October 15<sup>th</sup> meeting. Laura Wilkinson – Chairwoman of the Executive, Personnel Liquor Committee presented reports and Fred Curtin – Chairman of the Audit, Finance, Purchasing Committee presented reports. The committee reports were approved.

The next County Board meeting is Tuesday, November 18 at 6:30pm in the Christian County Courthouse – second floor Board Room.
