I am W. Cris Alexander, the designated Political File Compliance Officer for KLZ Radio, Inc., ("Company"). I am, as required, a senior manager, holding the title of Director of Engineering for Crawford Broadcasting Company, parent company of KLZ Radio, Inc., licensee of KLZ, since 1984. Further, I report directly to Donald B. Crawford, president of both Crawford Broadcasting Company and the Company.

This Compliance Report is provided in satisfaction of the requirements of the Consent Decree (the "Decree") issued in the matter of the Online Political Files of KLZ (FCC File No. POL-042121-3252459).

As shown in the attached spreadsheet, KLZ received no requests for broadcast air time and aired no political advertisements by or on behalf of legally qualified candidates for public office or which communicate a message relating to any political matter of national importance during the reporting period (from six months preceding the general election on November 2, 2021 until that date).

A Compliance Plan was developed and implemented as required by the Decree. The Compliance Plan included and was applicable to all radio stations owned by the Company. Included in the Compliance Plan is a detailed and comprehensive Compliance Manual (the "Manual"), which provides detailed information on the requirements of the Political Record-keeping Statute and Rule (the "Rule"), contains Operating Procedures that Covered Employees ("Employees") must follow to ensure the Company's compliance. The Manual also includes internal procedures and policies specifically designed to address preparing and uploading required information to the online political file in a timely manner and otherwise maintain full, complete and up-to-date information therein. In addition, checklists are included in the Manual that Employees must follow to ensure compliance with the Rule. The Manual is periodically reviewed and revised as necessary to ensure that the information within remains current, complete, accurate and effective.

As required by the Decree, a Compliance Plan includes training for Covered Employees on complying with the Political Record-keeping Statute and Rule.

I certify that I have personal knowledge that the Company (1) has established and implemented the Compliance Plan; (2) has utilized the operating procedures since the implementation of the Compliance Plan; and (3) is not aware of any instances of noncompliance with the terms of the Consent Decree.

I am able to make this report because I am personally part of the Company executive team which developed the Compliance Manual, Operating Procedures, compliance checklist, Compliance Training Program, distributed and reviewed the Manual with relevant personnel

and trained Covered Employees as to its components and requirements. I am also personally involved with others in the ongoing review of the Compliance Plan, including reviewing reports periodic reporting provided by Covered Employees and developing Compliance Plan revisions as needed, to ensure that the information remains current, complete, accurate and effective.

Unless stated otherwise in this report, all capitalized terms have the meaning attributed to them in the Decree.
