

## **Quarterly Significant Issues Report Period 3: July 1 – September 30, 2017**

This quarterly significant issues report reflects concerns facing our local communities, and details how our 'Talk Of Connecticut' radio stations are responding through weekly syndicated and public affairs programming, news reports, PSAs and streaming content. Our award-winning public affairs program, 'For The People' is locally produced by Public Affairs Director John Voket, and features up to 3 extended focus segments with several local PSAs included as breaks.

The locally produced Brad Davis Show has been serving state residents since 1977 on WDRC and The TALK of Connecticut stations, providing news, sports, traffic every 15 minutes, and weather updates from television partner WFSB. The program airs weekdays from 5am to 6am, with Brad joined by Dan Lovallo from 6am until 9am, and features a minimum or 10 minutes of local coverage daily. A synopsis of Brad and Dan's localized daily subject matter covered this quarter is attached to our report.

## Additional programming on the 'Talk of Connecticut Stations includes:

Midnight-5a - Red Eye Radio - Syndicated national overnight show taking calls on the issues of the day 9-10a - CT on the Hill with Dan Lovallo (LOCAL) - the latest political news coming directly from the state capital 10a-Noon - Ed Says - hosted by Ed Oliveira (LOCAL) - everything from local news and politics, to pop culture and national news.

Noon-1p - The Drew Mortgage Show

1-3p - The Dave Ramsey Show - practical, common sense money advice.

3-6p - The Savage Nation - Michael Savage's program showcases his passion to unearth the truth about liberalism, borders, language and culture, and his stand for America's families.

6-9p - The Schnitt Show - news, political commentary, lifestyle, and pop culture from Todd Schnitt.

9p-Midnight - The Lars Larson Show - America's top commentators take on the issues of the day

Our program occasionally features a series or "special report" - extended focus on a particular theme, or multi-faceted coverage on more broad or complicated issues. Our specials and series have focused on mitigating Connecticut's escalating teen traffic fatalities; the important public health services delivered by members of the CT Pharmacists Association; Connecticut's organic farms, farmers and gardeners; stigmas facing individuals with disabilities or mental health issues; water preservation and conservation; seasonal scams and consumer tips; even a frank discussion about concussion prevention following several high profile deaths and injuries among Connecticut youth and college athletes.

'For the People' is scheduled to air Sunday from 11am to noon, and each program is available after broadcast as a podcast on our station's website. Two to four local PSAs are aired during each program promoting causes, agencies, charities or programs serving our listeners. A separate PSA schedule managed and produced by the Public Affairs Director provides a maximum or two exposures daily, to six selected causes that extends through the entire guarter.

Thirty-second TRAFFIC reports on The Talk of Connecticut stations air four times hourly weekday mornings between 5:30 – 9am and twice hourly on weekday afternoons between 3 – 6pm. Reports of significant traffic events are made at other times when deemed appropriate by management or on-air staff.

**Connoisseur CT hosts LoveCT.com** – a web clearinghouse promoting and supporting individual and collective stations' community service partnerships, which is evolving through cooperative efforts among our stations' programming, promotions and client bases. We continue to inform listeners as this and other community outreach initiatives develop.

**Connoisseur's CTBoom.com** website also promotes our radio stations' public outreach and support of smaller neighborhood causes or 'boutique' charities serving our communities - as well as agencies and nonprofits that are supported by our stations' promotional efforts and commercial partners.

\*Each program segment listed below designates its related area(s) of coverage; length of the segment; and time the segment aired. The public affairs director makes every effort to ensure each significant issue is addressed during at least one program each quarter. The extended nature of our program presents opportunities where more than one significant issue or area of coverage might be addressed. And since 'For the People' is syndicated across eight stations, subject matter often contains statewide or regional versus community-specific impact.

## In 2017, For The People continues focusing on critical community issues related to:

**Aging & Veterans (A/V)** – promoting programs, legislation, local or regional agencies and how they address critical issues involving those over age 55, and veterans.

**Education & Youth (Ed/Y)** – responding to education-related issues, and/or concerns facing individuals under the age of 21 across Connecticut and the communities we serve.

**Environment & Agriculture (Env/A)** – focusing on issues, local agencies or initiatives that may impact, protect, sustain and/or enhance our local, state or global environment and agricultural interests.

**Grassroots Volunteerism (GV)** – promoting smaller boutique or hyper-local causes partnering with, or approaching our radio station and/or our staffers for assistance because they recognize the value of our broadcasting platform and the responsiveness we help inspire in community members we serve.

**Health & Human Services (HHS)** – examining how public health concerns are affecting the state and communities we serve; and how legislation; volunteer, grassroots, local, state or national agencies; as well as organizations supporting particular health causes or health education are addressing those issues.

Public Safety (PS) – highlighting issues specifically tied to public safety.

**Workforce & Consumer (W/C)** – reporting on initiatives, agencies or programs dealing with local, state, national and/or global economic conditions affecting Connecticut and/or the communities we serve; economic and workforce development; and/or programs directed to consumer education / protection.
