WSTQ is a unique station in that it covers a wide variety of subjects and issues that concern residents of the immediate and surrounding listening area. WSTQ lends a great deal of focus on issues that concern the rural landscape as well as urban areas, in hopes that there is not an alienation of a group or groups of people and their varying lifestyles. Issue: Animal Welfare

Program: Pet of the Week. Broadcast several messages informing listeners about the Pet of the Week and encouraging listeners to adopt or to support local shelters. Aired 7/1 for seventeen seconds at 7:16pm, 7/6 for forty-eight seconds at 3:45pm, 7/7 for twenty-three seconds at 7:47pm, 8/4 for one minute and sixteen seconds at 3:54pm and for twenty-seven seconds at 7:19pm, 8/9 for one minute and seven seconds at 3:20pm, 8/28 for seventeen seconds at 12:35pm, 8/31 for eighteen seconds at 7:36pm.

Program: Rural King Live Broadcast. Broadcast live at Rural King for a pet adoption drive in partnership with Illinois Valley Animal Rescue (IVAR). This broadcast encouraged listeners to donate to IVAR and consider adoption, and aired 7/17 from 10am-Noon.

Program: Orphan Kitten Club. Broadcast fifteen one minute messages informing listeners about the Orphan Kitten Club, an organization that encourages cat owners to take their cats to the vet. See Appendix H for broadcast times.

Issue: Charity

Compassion to others is important for the quality of life of a community

Program: Pack the Racks. Broadcast live at Peru HyVee for the Pack the Racks food drive to benefit the local food pantry. Aired 9/3 from 2-5pm.

Issue: Community

Community organizations build a community bond and also are an outlet for charitable giving in a town.

Program: LaSalle County 4H. Broadcast live for the LaSalle County 4H fair and encouraged listeners to connect with the local community and appreciate local farmers. Aired 7/8 from 4-6pm. Broadcast eighteen thirty second messages informing listeners about the LaSalle County

4H fair and encouraging listeners to attend and support the event. See Appendix G for broadcast times.

Program: National Sugar Cookie Day. Broadcast a thirty-nine second message informing listeners about National Sugar Cookie Day. Aired 7/9 at 3:22pm.

Program: Fireworks. Broadcast a sixteen second message informing listeners about the Fireworks Schedule. Aired 7/10 at 10:48am.

Program: Sweet Corn Festival. Broadcast live at the annual Mendota Sweet Corn Festival and encouraged listeners to stop by and engage in the community .Aired 8/12 from 5-7p.

Program: National Radio Day. Broadcast a twenty-two second message informing listeners about National Radio Day. Aired 8/20 at 1:39pm.

Program: Bureau County Fair. Broadcast live at the Bureau County Fair to encourage listeners to stop out and enjoy the local fair. Broadcast 8/25 from 4-7pm.

Program: Amboy Depot Days. Broadcast live at Amboy's Depot Days festival encouraging listeners to stop out and support the local community. Aired 8/28 from Noon-2p.

Program: Sandwich Fair. Broadcast live at the kick-off of the Sandwich Fair and encouraged listeners to enjoy the end of the summer with their community. Aired 9/8 at 4-6pm.

Program: Homestead Festival. Broadcast live in Princeton for the Homestead festival and encouraged listeners to stop by and support local business and efforts. Aired 9/11 from 1-3pm.

Issue: Crime and Safety.

Crime and Safety is always an important issue, both societal and personal.

Program: Fireworks. Broadcast a nineteen second message reminding listeners to be safe while setting off fireworks. Aired 7/2 at 11:50am.

Program: Police Car Seat Safety. Broadcast live at HyVee in Peru for the Police Car Seat Safety event and welcomed listeners to stop out and make sure their car seats are installed correctly. Aired 9/18 from 10am-Noon.

Issue: Economy

"it's the Economy, Stupid" – quote from Bill Clinton's Presidential Campaign, 1992. Without a strong economy, nothing else matters.

Program: HyVee Live Broadcast. Broadcast live at Peru HyVee to highlight, among other things, their new breakfast menu and special deals, and to encourage listeners to support local business. Aired on 7/6 from 7-9am, 8/19 from 4-6p, and 9/28 from 10-Noon.

Program: LIV Wellness Lounge. Broadcast live for the grand opening of LIV Wellness Lounge in downtown LaSalle and encouraged listeners to stop out and support the community. Aired 7/31 from Noon-4p.

Program: HyVee Gas Station. Broadcast live at Peru HyVee Gas Station to encourage listeners to take advantage of deals and support the local economy. Aired 8/13 from 8-10am.

Program: Bruce & Ollie's Grand Opening. Broadcast live for the grand opening of Bruce & Ollie's in Utica and encouraged listeners to come out and support local business. Aired 8/20 from 4-6pm.

Issue: Emergency Alert System

As a participating station in the EAS system, we receive and send tests and warnings.

Program: EAS tests. Sent the required monthly and weekly tests. Sent Severe Thunderstorm Warnings on 7/14 at 4:27pm, 8/9 at 8:16pm, 8/10 at 5:39pm, 6:10pm, 6:50pm, and 7:14pm, 8/11 at 8:07am, 8:33am, and 8:41am, 8/12 at 3:03am, 8/23 at 3:07pm, 8/24 at 5:26pm, 5:46pm, and 6:10pm, and 8/25 at 4:47pm and 5:03pm. Sent Flash Flood Warnings on 7/12 at 8:42pm and 11:36pm, 7/15 at 4:52am, and 8/9 at 8:02pm. Sent Tornado Warnings on 8/9 at 5:11pm, 5:56pm, 6:00pm, 6:52pm, 7:13pm, and 7:30pm. See Appendix I for broadcast times.

Issue: Employment

The current job market can be difficult to get into so knowing the fluctuations and changes regarding employment procedures can be an immense benefit.

Program: Equal Employment Opportunity. Broadcast three thirty second messages informing listeners about equal employment opportunities at Studstill Media. See Appendix A, Appendix B, and Appendix C for broadcast times.

Program: Diversity and Inclusion. Broadcast ninety-six thirty second messages informing listeners about the importance of diversity and inclusion in the workplace. See Appendix D and Appendix E for broadcast times.

Issue: Entertainment News

News plays an important role in society by keeping people informed. However, entertainment news can play a slightly different role in that it allows people a distraction from the world and provides listeners with a way to vicariously live a more privileged life.

Program: New Music. Broadcast several messages informing listeners about upcoming new music. Aired 8/2 for twenty-five seconds at 8:30pm, 8/4 for twenty-five seconds at 10:31pm, 8/7 for twenty-six seconds at 2:36pm, 8/26 for fifteen seconds at 9:31pm, 9/4 for twenty-one seconds at 4:31pm, 9/30 for nineteen seconds at 10:30pm and for eighteen seconds at 9:33pm.

Issue: Health/Wellness

This station recognizes that health is an important component in today's society. More and more listeners are taking up healthy lifestyles. Of course, there are always health scares and concerns to cover as well.

Program: American Academy of Pediatrics. Broadcast forty-two thirty second messages informing listeners about the American Academy of Pediatrics and encouraging listeners to take their children to the doctor. See Appendix F for broadcast times.

Issue: Summer Weather

Summer weather is very destructive, including the Utica tornado from last decade that killed 7 people. Listeners are very interested in the weather in the spring.

Program: Tornado Watch. Broadcast several messages informing listeners of the current Tornado Watch in effect. Aired 8/9 for twenty-one seconds at 3:00pm and for one minute and fifteen seconds at 6:18pm.

Program: Heat Advisory. Broadcast several messages informing listeners of the current Heat Advisory in effect. Aired 8/24 for twenty-seven seconds at 1:00pm.

Issue: Youth Issues

Program: Cantlin Law Firm. Broadcast a two hour live remote at the LaSalle Pool in partnership with Cantlin Law Firm to encourage families to enjoy the warm weather at the pool. Aired 7/27 from 5-7p.
