According to a recent report from Crain's Chicago Business, Exelon Corp. is beginning talks with state legislators about what can be done to improve the current market environment.

The plants rumored to be on the block include Clinton, the Quad Cities (Cordova), and Byron. Exelon isn't commenting specifically on the talks but said in a statement that the company is "working to identify market-based solutions that would enable the company to continue operating all of its nuclear plants."

The Clinton plant employs 652 workers with an annual payroll of \$54 million.

Jome says the trustees will look at about a 2.05 percent tuition increase for in-state students, and 2.03 percent for out-of-state students. That will only effect this year's incoming freshman.

The Heartland Community College Board of Trustees approved a tentative Fiscal Year 2015 budget on Tuesday.

The total budget is \$62 million, which is an 8.4 percent decrease from the FY '14 budget. It does show a small surplus, despite some anticipated revenue decreases. One of those, according to President Rob Widmer, comes from an anticipated three percent drop in enrollment.

Widmer said Heartland is also expecting a five percent decrease in state funding. That's despite the fact Illinois' budget did allow for level funding to community colleges. Widmer said just because the college system as a whole received level funding does not mean each school will get the same allocation.

A man once convicted of murdering his girlfriend has filed a lawsuit against three former officers with the Normal Police Department. Alan Beaman was found guilty of the 1993 slaying of Jennifer Lockmiller, but had that conviction overturned by the Illinois Supreme Court in 2008.

Beaman's lawsuit, which also includes the Town of Normal, accuses former officers Tim Freesmeyer, Dave Warner and Frank Zayas of unfairly targeting him as the killer and therefore allowing Lockmiller's true killer to remain on the streets.

Title: Former comptroller won't seek appeals

A former bookkeeper who stole almost \$54 million from a northern Illinois community has accepted she won't be able to reduce her nearly 20-year prison term. That's according to Rita Crundwell's lawyer. He says the imprisoned former Dixon comptroller decided not to pursue other appeals options.

Sauk Valley Media cites her attorney, Paul Gaziano, as saying he won't push for the full U.S. 7th Circuit Court of Appeals or the U.S. Supreme Court to hear her case. A three-judge 7th Circuit panel upheld Crundwell's sentence in November. She'd argued a lower-court judge abused his discretion by giving her more time than recommended under federal guidelines.

Crundwell used the money she stole over more than two decades to live lavishly and build a nationally-renowned horse-breeding operation.

Most of us have jobs in which we are pretty certain we can go home after our respective shifts. State Trooper James Sauter and Pontiac police officer Casey Kohlmeier did not.

They were presented posthumously the Medal of Honor by the Illinois State Police. In all today (Friday), sixteen officers from seven departments around the state were honored for heroism.

Sauter lost his life in March 2013, when a semi-tractor trailer - whose driver had allegedly fallen asleep - plowed into the rear of his parked car on an interstate shoulder. In October of that year, Kohlmeier was killed while parked in an interstate median. His vehicle was broadsided by an alleged drunk driver.

The institute last graded Normal's website in 2012 and gave it a 75. Recently, Bloomington's website received a score of 89, which resulted in the city being awarded the Institute's Sunshine Award.
