State Sen. Bill Brady, R-Bloomington, said Republicans who oppose a special election in 2016 to replace late comptroller Judy Baar Topinka face an uphill battle.

"Just the raw politics of it, given the fact (Democrats) have a majority and currently the governor, if I had to predict, I'd predict they would pass it," Brady said.

Brady told WJBC's Scott Laughlin, he understands why Democrats wouldn't want governor-elect Bruce Rauner to make a four-year appointment.

"Of course it makes partisan sense for the Democrats would want have another shot at the election since it's not a Republican who is going to be appointed<" Brady said.

Quinn appointed his budget director, Jerry Stermer, as interim comptroller after Topinka died last month. But Stermer's term ends when Gov.-elect Rauner takes office Jan. 12. Rauner has said that whoever he appoints should remain in office the next four years. But Quinn hopes in his last full week of office the special session he called for Thursday will result in lawmakers approving the special election.

BLOOMINGTON - Illinois lawmakers are expected to consider a special election for the comptroller vacancy this week, but state Sen. Jason Barickman, R-Bloomington, tells WJBC's Scott Laughlin, he would like to see a comptroller vote of a different kind.

"If there's going to be any vote this week on anything relating to the comptrollers office it ought to be that we plan to merge those offices," Barickman said. "That's a Constitutional amendment. We could take it up in the 2016 elections. It seems like the time is now to do that."

A bi-partisan bill to merge the comptroller and treasurer's offices that was introduced in 2013 by publican Senator Matt Murphy and Democratic Senator Kwame Raoul has been stuck in committee. Barickman said the Democratic House Speaker has kept this measure from seeing the light of day.

BLOOMINGTON - Local lawmakers say Gov. Bruce Rauner's State of the State address Wednesday was bi-partisan and set the tone for his upcoming budget address.

State Rep. Dan Brady (R-Bloomington) says there's no way for Rauner to please everybody.

"No matter what this governor does, he is going to make a group, associations, whatever, upset, because there aren't good answers to these problems, and there are painful solutions that he is going to have to try and implement," Brady said.

One such proposal in Rauner's State of the State speech Wednesday was consolidating local governments. Brady said he's in favor of that idea, all the way up to consolidating the comptroller and treasurer's offices.

Another proposal that Rauner offered Wednesday involves raising the state's minimum wage to \$10 per hour in seven years. State Sen. Jason Barickman (R-Bloomington) said the economy needs to improve before the legislature raises the minimum wage, so seven years isn't too long to wait.

The intergovernmental agreement for splitting the cost of electronics recycling in the area is now in the hands of the City of Bloomington and McLean County.

The Normal Town Council approved the deal Monday night. City Manager Mark Peterson said the agreement is retroactive to Jan. 1.

"We actually entered into the contract in, I believe, September. So we're taking care of all the cost from that point to the end of the year," he said.

Peterson explained recycling the electronics costs between \$8,000 and \$9,000 a month. Under the agreement, Bloomington will pick up 45 percent of the cost, Normal will cover 31 percent and the county will take on the remaining 24 percent.

Four candidates are fighting for three seats on the Normal Town Council in the April election.

Two are incumbents, two are challengers, and all agree right to work zones are a bad idea.

Incumbent Jeff Fritzen said the local community is "blessed" not to have a lot of "strife" between labor and management.

"My preference would be that our community could be a model for the rest of the state," said Fritzen.

"The cooperative relationship that exists locally comes through communication."

Fritzen's fellow incumbent, Chuck Scott, said he constantly experiences the high quality of work from laborers.

"Within the eight unions in my department alone management and labor often do agree," Scott said.

Challenger R.C. McBride does not believe right to work zones provide any benefit for either side. "Personally, I am hopeful that Governor Rauner will turn his attention to more constructive

conversations," McBride said.

Another newcomer, Kathleen Lorenz, had similar thoughts.

"(I've) read up on a lot of publications, both for and against," said Lorenz. "Coming away from that research, I am not convinced that it is an effective means towards competitiveness."

State Rep. Dan Brady said the Rauner administration is working on a solution.

"It's incumbent upon us (lawmakers) and the administration is looking - is there another way to do something?," Brady asked.

That might include a way to bypass a primary - and have the party chairmen in the district's 19 counties select a candidate.

"I suppose the only way something like that could be done would be some sort of legislation," Jim Tenuto, assistant director with the State Board of Elections said, adding that such a law would likely be challenged in court.

One option to avoid a primary is one runoff with all of the candidates. Tenuto said the law is intended to require the winner to get more than 50 percent of the vote.

Former neighbors testified this morning in the murder trial of Nicholas Compton.

Kristen Vannon and April Johnson both lived in the same apartment building as the victim's mother, Danielle Fischer, until a few months before three-year-old Robbie Cramer died in March 2013. Vannon and Johnson ran into Fischer, Cramer and Compton at Eastland Mall a few days before the child's death, and Vannon said she noticed Cramer was bruised, had an abrasion on his face and also lost

"It looked like there had been patches of hair missing, and then they continued to shave the rest of it off." Vannon said.

Assistant State's Attorney Adam Ghrist argues Compton abused Cramer, causing injuries that eventually led to a fatal seizure.

The mother of a murder victim testified in court Thursday.

24-year-old Danielle Fischer was called to the stand regarding the death of three-year-old Robbie Cramer in March 2013. 25-year-old Nicholas Compton is accused of causing injuries that eventually led to Cramer's death.

Fischer said she confronted Compton about injuries Cramer sustained in late Feb. 2013, but Compton responded harshly.

"'Are you kidding me? I've never hurt that boy. Don't ever text or call me again," Fischer said while reading a text message Compton sent her Feb. 28.

Fischer said Compton apologized, but the injuries didn't stop appearing.

"Well, you never have a <expletive> explanation as to why he has bruises all over," Fischer said in court Thursday, reading another text message she had sent Compton in March. "(Cramer) never had a problem before."

A Bloomington man will see 55 years in prison for shooting another man to death in May 2013. 29-yearold Michael Mays was sentenced Friday on charges of first-degree murder in the death of Aaron Robinson. Karen Robinson, Aaron's mother, says Mays should see more time in prison.

"He took my son's life, I think he should get life, which, by the time he gets out, it'll be most of his life anyways," Robinson said. "But he had no remorse from the time of the trial to now. He had no remorse

whatsoever."

Mays shot Robinson after a series of altercations on May 13, 2013, and Mays contends Robinson was the aggressor in the situation. The defense filed a motion for a new trial because they say Mays' criminal record had been entered into evidence in error, but judge William Freitag denied the motion. Both Mays and Robinson were accused of participating in gangs, but the murder was not considered gang-related. In asking for a harsher sentence, Assistant State's Attorney Jacob Harlow said Mays violated prison rules 13 times while in custody, including two fights. The defense argued those altercations were caused by friends of Robinson seeking revenge.

The family of two pedestrians killed say they want charges filed against the driver who hit them. Relatives of Pedro and Alejandro Guerrero rallied Sunday at the McLean County Law and Justice Center over the decision not to prosecute a drive who struck and killed the two in October 2013. State's Attorney Jason Chambers said there wasn't anything they could charge the driver with.

"Is there excessive speed involved? Is there alcohol involved? Is there drugs involved? Is there a cell phone or texting involved? Or did they try to conceal the identity of the driver? All of those were absent in this situation," Chambers said.

Chambers said the driver, whose name has not been released, did leave the scene after initially stopping, but he returned less than 10 minutes later and cooperated with authorities. Protest organizer Sonny Garcia said some community members believe the driver wasn't charged because both victims were Latino. Chambers said the decision not to file charges was not based on race. As cold as it was this morning, it wasn't cold enough for District 87 to close school.

District 87 Superintendent Barry Reilly told WJBC wind chills in the area of 25 below zero were close to the breaking point.

"It's a tough call to make, because if I see sustained wind chills over the course of the day that are going to remain in that 30 below mark with gusts even stronger than that, we are likely not to be in session," Reilly said.

Wind chills were reported as low as 23 below early Thursday.

Reilly said the district is unique in that its busses don't have long distances to travel if they break down. "Given the close proximity we have to our schools and our neighborhoods we are in a better position to have school than most districts are," Reilly said.

He said the district has school resource officers who were out this morning to help any students outside walking to school or were underdressed.

Reilly said the Bloomington-based school system only spans 10.5 miles a small fraction of the miles school districts such as Unit 5 and Olympia cover.

"Trying to analyze what is the most logical picture of projection of revenues that we would have available and managing our expenses and looking at expenses where we feel confident we know where those expenses are going to fall," Widmer said.

Widmer explained the school tried to make sure the increase would have the least amount of impact as possible on students.

"The tuition increase was what we felt was the amount that we really needed to have to proceed budgetary this year," he said.

Widmer said Heartland does have about \$300,000 in scholarship money available which could help lower the financial impact to any current or prospective students.

Superintendent Mark Daniel said Unit 5 has to find ways to reduce its costs.

"We're looking across the entire district trying to find positions we believe will not eliminate programs," Daniel said.

Over 20 teachers are not being brought back for the 2015-2015 school year.
