Police are trying to determine if there's a connection between the robberies and attacks on two pizza delivery drivers this week. Bloomington Police spokesman Dave White said the suspect descriptions are similar, but it was a different driver in each case. Both were drivers for Flingers Pizza. In the first incident on James Place just after midnight on Monday, police say the driver was approached by a teenage girl who the driver thought had placed the order. She was described as black, 5-foot-5 with medium build. The driver was then jumped by four black teens who took the pizza. Police didn't have any further description of the attackers. In the second incident at about 1 o'clock this morning, a driver making a delivery on East Walnut was met outside by a black female teen described as having a thin build. Police say the driver was then attacked by two black teens who were described only as skinny. They reportedly punched him and took the pizza, along with an undetermined amount of cash. Police say the victim in the second incident was taken to Advocate BroMenn Medical Center.

Prosecutors say an attempted first degree murder charge is still possible for a Pontiac man accused of breaking into multiple residences and trying to shoot someone. So far, 25-year-old Andrew Fosdick has been charged with home invasion, aggravated unlawful use of a weapon, possessing a firearm without a FOID card and reckless discharge of a firearm. Livingston County Judge Robert Travers set Fosdick's bail at \$1 million, which means he must post \$100,000 to be released from jail.

Authorities say Fosdick pointed a gun at a woman, telling her he would shoot if she called police. His gun reportedly clicked but would not fire.

An August 20th preliminary hearing is scheduled in Livingston County Court.

Two Central Illinois women have been sentenced to prison for selling counterfeit purses and other items purporting to be from designer brands like Chanel, Coach and Prada. Federal prosecutors say 51-year-old Jannette Grant of Bloomington and 50-year-old Kimberly Nein of Argenta pleaded guilty to conspiracy to traffic in counterfeit goods. Grant was sentenced to three years in prison and Nein was give two years. Both must pay nearly \$4,000 in restitution. Prosecutors say the women did business as `The Purse Lady' and sold the items throughout central Illinois. Law enforcement used search warrants to recover more than 15,000 items, including 2,000 purses and 900 wallets, from Grant's home and a warehouse Nein owned. The women said they regularly traveled to Chicago and New York to purchase inventory.

Labor leaders joined Illinois transportation secretary Ann Schneider and U. S. Sen. Dick Durbin (D-Ill.) today (Friday) to celebrate the new federal transportation bill, which President Obama signed today. Durbin and U. S. Rep. Jerry Costello (D-Belleville) were part of the conference committee to work out the final bill. "This is a great day today," said Schneider. "I'm very pleased that Congress and the president have established a solid transportation reauthorization bill that puts Illinois on strong footing going forward." "This highway bill is an economic engine," said Brad Schaive of the Laborers International Union of North America, pointing to not only the paychecks that will be spent in Illinois communities, but also the business producers of raw materials will get before the projects begin. IDOT plans to bid out 60 projects next month, totaling \$106 million.

McLean County interim State's Attorney Ron Dozier is taking steps to get concealed carry in the state, by no longer charging offenders with unlawful use of a weapon if that person has a valid FOID card. In an e-mail obtained by WJBC, Dozier says he has been quietly changing policies of the office since he took over in December to bring them in accordance with the U-S Supreme Court. Dozier says there have been recent cases where his office has decided not to charge a person with a weapons crime. Jason Chambers, who will take over the office when Dozier leaves, says he's not bound to Dozier's policy. Dozier says certain questions will be asked to determine if anyone who has a valid firearms owners identification card won't be charged with unlawful use of a weapon or aggravated unlawful use of a weapon.
