A new group of business leaders wants to recruit 300 CEOs and 1,000 small businesses in Illinois to push for "common sense" bipartisan immigration reform.

The Illinois Business Immigration Coalition includes leaders from Peoria-based Caterpillar Inc. as well as Motorola Solutions Inc., the University of Illinois, trade groups and immigration-rights advocates. Chicago Mayor Rahm Emanuel backs the coalition.

Caterpillar CEO Doug Olberhelman spoke at a kickoff event Monday in Chicago. He says the manufacturer has trouble filling both high- and lower-skill jobs and immigration reform could help.

The coalition is forming as lawmakers in Washington get ready to hammer out details of a potential immigration law overhaul. Business and labor leaders last week agreed on broad outline.

Emanuel says it's ``a huge opportunity" that shouldn't be squandered ``because of politics."

A 26-year-old Lincoln woman has been sentenced to more than 21 years in prison for producing child pornography.

The U.S. Justice Department announced that Laura Sigler of Lincoln was sentenced in federal court in Springfield to 21 years and 10 months in federal prison. She pleaded guilty to producing in November 2011 pornographic images using a 5-year-old child. She sold the images for rent money. She will be on supervised release for life following her release from prison.

The Justice Department says a co-defendant was sentenced in January to 19 years and seven months in prison. Anthony L. Ferguson pleaded guilty to the same charges.

The two are accused of working together to defraud Towanda Grain Co., Printz's creditors and others.

Both have pleaded not guilty.

The state Department of Agriculture took the grain company over in 2010 after it was notified of financial irregularities. Another company later bought the assets.

Attorneys have agreed on the 12 people who will hear the trial of a man accused of beating to death a central Illinois couple and three of their children.

The last of the dozen jurors in the trial of Christopher Harris were seated Monday afternoon. It came after almost four full days of interviews.

Now attorneys have to agree on four alternates. It isn't clear yet when testimony will begin.

Harris pleaded not guilty to the 2009 murders of 46-year-old Raymond ``Rick" Gee and 39-year-old Ruth Gee. Sixteen-year-old Justina Constant, 14-year-old Dillen Constant and 11-year-old Austin Gee were the young victims.

Prosecutors say Harris and his brother, Jason Harris, broke into the home intending to sexually assault Justina Constant and rob the family. Jason Harris' trial hasn't been scheduled.

Title: Livingston County Mental Health Court not supported by State's Atty

PONTIAC - Mental health courts, subsets of the judicial system with special networks created to provide necessary services to those facing court action and mental illness, are designed to help keep people from returning to the judicial system by dealing with the root of their behaviors rather than the behaviors themselves.

Livingston County State's Attorney Seth Uphoff has no problem with the concept of a mental health court. Uphoff, in fact, thinks they're a good idea.

He doesn't think they're a good idea in Livingston County, however.

Several judicial and government officials in Livingston County have been working toward a fully implemented mental health court for months, but by state law Uphoff has to sign off on the idea, and he's not sure it's right for Livingston county because of the area's relatively small population.

"The concern is that we want to make sure that there's sufficient need in Livingston County to have a full-fledged court program," Uphoff said.

Uphoff stresses that he fully supports the idea of a mental health court, and that he understands the need for it and the sensitivities that have to be respected in dealing with the mentally ill. He added, however, that he's also an elected official who has an obligation to guard against unnecessary expense, and he believes that a fully-realized mental health court won't be cost effective in Livingston County because of the small number of cases that will actually qualify for special consideration.

Uphoff pointed to programs in Peoria and McLean Counties and said they're a good investment because the larger populations of those areas create more need. Uphoff stressed, too, that a mental health court environment isn't necessary for people to receive mental health services through the courts. In fact, he said as far as individual defendants are concerned, they have access now to the same services they'd have in a mental health court environment.

Gov. Pat Quinn says House Speaker Michael Madigan's pension-reform plan

deserves a Senate vote.

The Democratic governor said the proposal is comprehensive.

Illinois has nearly \$100 billion in pension debt because of years of state underfunding.

Senate President John Cullerton has a different idea he plans to call for a vote Thursday afternoon. Public employee unions back that proposal.

The House approved the Madigan bill last week. It would require employees to pay 2 percent more toward retirement benefits. It would reduce annual cost-of-living increases for retirees and raise the retirement age for workers under 45.

Cullerton's proposal would offer employees a choice between health insurance or cost-of-living increases. He says it would survive a court challenge.

The Cullerton bill is SB2404. The Madigan bill is SB1.

Anxiety and anger are growing among state employees and retirees who wonder what will happen to their pocketbooks if lawmakers make expected changes to the state's pension systems.

Workers spent their careers paying into their pension funds what the law told them to pay. But the state for decades skipped or shorted its required payments.

Now lawmakers are scrambling to fix a multibillion shortfall in the money needed to cover promised payouts to current and former employees who belong to five state pension systems.

Paul Morton is an office assistant for the Illinois Department of Healthcare and Family Services. He calls some of the legislature's proposed changes legalized robbery.

He says he won't be able to afford his health care costs upon retirement if his pension benefits are diminished.

Senator Dick Durbin says Congress must act to stop interest rates on some student loans from doubling.

The rate hike is scheduled to occur July 1st on federally subsidized Stafford loans. Durbin says that could mean more than 365,000 Illinois students with Stafford loans would have to pay almost \$1,000 more in interest over the life of their loan.

The interest rate is set to increase from 3.4 percent to 6.8 percent.

Durbin supports a Senate proposal to keep the interest rate level for two years while Congress works on a long-term plan for the federal student loan program. That legislation stalled this week after a Republican filibuster.

A Republican proposal also failed.

The Illinois Democrat says lawmakers must ensure education is affordable for students from working and middle-income families.

Illinois transit advocates are proposing a plan to fix the state's deteriorating roads through a new tax that would raise the price at the gas pump.

The Transportation for Illinois Coalition says the \$800-million-dollar-a-year plan is necessary to get a toehold on needed repairs to roads, bridges and rails.

The influential group is pushing legislation to replace the current 19-cents-a-gallon motor fuel tax with a 9.5 percent wholesale tax. It would add about 14 cents to today's price of a gallon of gas.

Coalition co-chairman Doug Whitley (WIHT'-lee) laid out the plan for the AP in advance of making it public.

The proposal would also increase vehicle licensing fees. Bill Fleishli (FLYSH'-lee) of the Illinois Petroleum Marketers Association says the fuel tax would hurt business.

Union officials said Friday the ratification vote came after a three-day strike where 97 percent of the nearly 800 workers did not cross the picket line.

Bloomington City Manager David Hales explained to the school board that developers want a break on property taxes for five years in order to invest one-point-six million dollars to renovate the building with apartments and retail space. Board President Pro Tem Steve Perry says the amount of revenue the district was getting is rock bottom for a building with commercial value.

Hales says the school district is getting 24-hundred dollars from the property now, but when the project is done, it could increase to 20-thousand dollars in an annual basis for the district.
