Nisha Mohammed said anytime the phone rings, they hope it's the answer to their prayers. Right now, Taj has painful gout in his legs and he's on dialysis...

If they can get a kidney from a donor with type O positive blood, they'll have the surgery at O-S-F in Peoria.

A new year means resolutions and a popular one is getting to the gym. A recent study shows Bloomington is a top location for exercise instructors.

AdvisorSmith conducted a study and it ranked Bloomington as the 6th best midsize city for fitness trainers. 312 cities were analyzed based on fitness trainer salaries, cost of living, and job availability.

The study showed Bloomington hosts 20 percent more jobs for fitness trainers on a per-capita basis compared to the U.S. average.

The average annual salary for a fitness trainer in Bloomington is over 45-thousand dollars, which is 2 percent higher than the national average.

According to the study, Bloomington was ranked higher than Peoria, Champaign, and Chicago. Rockford came in at number two behind Charlottesville, Virginia.

A woman from Normal who was found guilty of killing her 8-year-old stepdaughter has had her sentencing vacated after hiring a new attorney.

Cynthia Baker, who was found guilty in November of first-degree murder in the death of Rica Rountree, has hired Phil Finegan to represent her, according to our news partner Heart of Illinois-ABC.

Finegan said he is requesting more time to gather information.

A delay was granted, with the next status hearing to be held February 24th. Baker was scheduled to be sentenced on January 31st.

A jury found Baker guilty on November 19th and prosecutors argued during the trial she had kicked Rountree so hard in the stomach that the child ultimately died of the injuries.

Finegan (FIN-igan) said last month he had plans to ask the judge to vacate her sentencing and ask for time to review court transcripts to file a motion with allegations of ineffective counsel.

Through her trial, Baker was represented by Todd Ringel.

Although Baker was found guilty, investigators in a post-trial press conference said the investigation into Rountree's death is ongoing.

A movie theater on Normal's north side is hoping to sell alcohol to moviegoers.

AMC Classic, located at 201 McKnight Street, is asking for a Class R liquor license to sell various draft and bottled beer, wine, frozen margarita's and other items.

The Normal Liquor Commission will vote on the license Monday night before the town council meeting.

A staff report to the commission say the license would not be issued until inspection reports are approved by the McLean County Health Department, Normal Fire Inspection Division, and the Normal Building Inspection Department.

Normal Police have arrested Richard Rountree for circumstances surrounding the death of his 8-year-old daughter Rica.

In a news release Tuesday, authorities said Rountree was taken into custody for allegedly endangering the life or health of a child under the age of 18, and is accused of conduct which makes him eligible for an extended-term sentence.

Rountree's girlfriend, Cynthia Baker, was found guilty in November of first-degree murder in the death of her stepdaughter. Her sentencing was vacated January 3rd and has hired Phil Finegan to represent her.

Prosecutors argued during Baker's trial she kicked Rica so hard in the stomach that the girl ultimately died of her injuries.

The circumstances surrounding Rica's death remains an open and active matter, according to Normal Police and the McLean County State's Attorney's Office.

The McLean County Libertarian Party is questioning the credibility of the Normal Police Department.

The party voted unanimously to create a resolution asking the Normal Police Department to address specific events that have happened in the last few months, according to Party Chair Steve Suess.

Suess says the arrest of a Normal police officer for allegedly stealing \$12,000 during a 9-1-1 call shows corruption within the department, according to our news partner Heart of Illinois-ABC reporter Stephanie Rodriguez. That and a social media post--on NPD's Facebook page the party feels was "making light of the war on drugs"--have led them to ask the department for "accountability."

Heart of Illinois-ABC reached out to Normal Police Chief Rick Bleicher for comment but he declined. Suess says the party wants an acknowledment from the department that they screwed up.

The Facebook post the party is referring to is still on the department's page while the criminal investigation into the Normal Police officer who allegedly stole the money has been handed over to state police.

A one-stop shop for all things broken, the West Bloomington Revitalization Project (WBRP) is launching its second Fix-it Cafe.

Aimed at eliminating waste, WBPR Project Manager Armando Baez said the goal of the Fix-it Cafe is not only to bring the community together but to fix broken items.

"There are other ways of using all of the resources that we have. I think there is just access of stuff everywhere in the world," added Baez. "This attitude that if it's broken, we should just throw it away has to stop. So if there is something that you have, whether it be again, it's pretty open."

With a team of fixers to help fix broken items, Baez said the first Fix-it Cafe at the Normal Public Libary was a hit.

"At the Normal Libary, it was funny to see what people brought in," said Baez. "We will have people that know how to fix stuff, and we will do our best to fix it. It's just a place where people can get together and get some things repaired."

The Fix-it Cafe will run from 4 p.m. until 7 p.m. on Jan. 30th at the WBRP Tool Library located at 724 W. Washington St. in Bloomington. The event is free of charge.

Police posted on Facebook to let people know they're replacing old cameras as well as adding more.

News partner, Heart of Illinois ABC reports, that right now, they have eight cameras that are clearly marked, as well as two more that are able to be deployed for large events or in a rapid response situation.

BPD Cheif Dan Donath says the cameras were first implemented in 2013 and can be programmed so they don't record someone's home life.

Donath said they want to upgrade older units and add five to seven more public safety cameras each year, with locations driven by crime statistics.

At this point, police don't need any additional funding from the city.

Rountree is accused of child endangerment in connection to his 8-year-old daughter's death January of last year.

Rountree's girlfriend, Cynthia Baker, was found guilty in November of first-degree murder in the death of Rica Rountree, but saw her sentence vacated on January 3rd when she hired a new attorney with plans to argue for ineffective counsel in her murder trial.

The motion by Rountree's public defender specifically asks for the case to be transferred to the Chief Judge for reassignment.

Our news partner, Heart of Illinois -ABC reports about 1,000 people will work there, and the company recently announced it's helping Lincoln Motor Company develop luxury electric vehicles. Lincoln's parent company is Ford, which is investing \$500 million in Rivian.

In a statement, UAW Region 4 Director Ron McInroy noted the union's history at the former Mitsubishi Motors plant in Normal, and with Ford.

McInroy says there are a lot of skilled and talented workers around Normal who will make an excellent Rivian workforce and build a world class quality product.

Adding that the union looks forward to these jobs returning and UAW members having the opportunity once again to organize and form their local union which has meant so much to that community.

Rivian plans to start producing its R1T pickup truck and R1S sport utility vehicle later this year.

The restaurant has moved to Farmer City as a local group hopes to build a new grocery store in the West Market Street plaza.

WBRP Secretary Bevin Choban says the microloan to Rosy's was successful as the business was able to pay back the money.

Choban says the organization wants to spur growth in the neighborhood and creating economic development in the area is a key focus in the city's comprehensive plan.

Bloomington-Normal's only business licensed to sell marijuana for medical use has permission from local leaders to become the first dispensary in the Twin Cities to sell cannabis for recreational use.

Our news partner, Heart of Illinois ABC reports the Normal Town Council voted unanimously Monday night to approve a special use permit for The Green Solution on Northtown Road, mirroring a 6-0 vote last week by Normal's Zoning Board of Appeals.

It became legal on New Years Day for Illinois businesses to sell marijuana for recreational purposes, but Bloomington-Normal residents must go to Peoria, Champaign, or Springfield to purchase the drug.

Nathan Wang, new markets manager for parent company, Jushi says the group is excited about all the support from the community and the town council.

The business owner is seeking a dual-use license from the state government.

The dispensary will be open daily from 8 a.m. to 10 p.m., there won't be a drive-thru, and video cameras will be posted at building entrances and in the parking lot.

The Green Solution does not anticipate odor problems because the business won't be growing marijuana. However, if the smell does become a problem, the owner plans to install a charcoal filter to the building's heating and air conditioning system or use another air treatment.

The business also will put in place special procedures to handle potentially higher traffic during the first two weeks that recreational marijuana is sold at the location.

The father of murder victim Rica Rountree pleaded guilty today (Thursday) in McLean County Court to a felony charge of endangering his daughter's life.

Our news partner Heart of Illinois ABC reports Richard Rountree was sentenced to eight-years in prison for his guilty plea to a felony child endangerment charge.

A jury late last year found Rountree's girlfriend, Cynthia Baker, guilty of fatally beating the eight-year-old girl in Normal in 2019. Baker has not been sentenced yet.

As for Rountree's punishment, McLean County State's Attorney Don Knapp issued a statement and said "acknowledging that no sentence can ever adequately counterbalance the loss of life, we believe this sentence is appropriate."

McLean County's largest school district may wind up sticking with the same school bus company next school year even though the school board, administrators, and parents are far from satisfied with the current provider.

The school board will consider extending its multi-million dollar contract with First Student for another year to provide more time to study a consultant's report about various transportation options.

Our news partner Heart of Illinois ABC reports those options include hiring another bus operator, or the district setting up its own bus system, which could take up to two years, according to School Board President Barry Hitchins.

First Student was criticized at the start of this school year for late buses, not having enough drivers, and communication breakdowns.

Hitchins released the following statement:

"At the Unit 5 Board of Education meeting in January we heard a presentation from a transportation consultant. That presentation included a cost benefit analysis and proposed timeline of 18-24 months for potential insourcing. This raised some concern about the timeline needed for potentially changing transportation service providers. This timeline concern as well as the general risk associated with changing transportation service providers lead the Board to direct to Unit 5 administration to seek a one-year extension with First Student. This extension will provide the time needed to assess the full report provided by the transportation consultant and determine the best solution for Unit 5 student transportation going forward."

Unit 5 would boost its subsidy to First Student by 3.75 percent from the current year to about \$9.5 million. The proposed contract extension includes financial penalties for lack of performance.

The board will vote on the contract extension in the coming weeks.

The Normal Town Council is expected to decide Monday night whether to give the city manager a pay raise that would boost her salary above her predecessor's pay.

Mayor Chris Koos is recommending the council raise Pamela Reece's salary by 55-hundred dollars to just over 190-thousand dollars, according to our news partner Heart of Illinois ABC.

The town council promoted Reece two years ago from her previous job as assistant city manager to replace retiring city manager Mark Peterson. Peterson made 189-thousand dollars in his last year on the job. He was Normal's city manager for 20 years.

Reece is entering the final year of a three-year contract. Mayor Koos said in a memo to the council that the proposed salary increase for Reece "reflects a fair and competitive wage" for the city manager's position.

Reece is only the third city manager in Normal's history, and is the first woman to hold the position.

For the third straight year, trustees of Heartland Community College are raising the cost of attending the school.

The board voted unanimously Tuesday night to boost tuition and fees by \$5 per credit hour to \$163, with the increase expected to generate about \$500,000 for the fiscal year starting July 1.

The board chose to enact a series of smaller tuition and fee hikes rather than a larger one-time increase.

Our news partner, Heart of Illinois ABC reports administrators noted in a report to the board that more money is needed because of anticipated salary increases, a deficit in the current budget, and volatility in projected tax revenue.

A task force released a report last year that called on the district to keep the overall property tax rate unchanged, while at the same time maintain students' costs at "reasonable" levels.

In a report to the board Heartland staff said at the new rate it expects Heartland to continue to be the most affordable higher education option in the district.

The Heartland Community College District covers McLean, Livingston, and Logan Counties.

Early voting is underway for the March 17th primary in Illinois, but in McLean County, early voting has been "very light."

That's according to McLean County Clerk Kathy Michael, but she says it's not unusual for it to be light at this point. Vote by mail ballots, however, seem to be heavier than usual. Michael says her office has received over 1,000 ballots with another 300 to 400 requests for ballots to be mailed. That does not include the Bloomington Election Commission.

Early voting at the Government Center in downtown Bloomington has been going on since February 6th. Early voting hours are currently 8:30 to 4:30 Monday through Friday.

This weekend early voting can be done at Eastland Mall. Voting areas will be set up in the corridor area in front of the former JC Penny store along with the Bloomington Election Commission. Those will be open both Saturday and Sunday from noon to 6 p.m.

Sunnyside also runs summer programs to introduce children to healthy food at an early age and to also teach kids about farming practices.

At tonight's Bloomington City council meeting, a proposed license between the city and Sunnyside is on the agenda, possibly widening the scope of the community garden reach.

Bloomington's proposed \$230.3 million budget for the next fiscal year includes a money to repair a downtown parking garage that at least two city council members would like to see torn down.

Our news partner, Heart of Illinois ABC reports city staffers recommend the council approve \$1.3 million to repair the 46-year old Market Street garage, which has 350 spaces. The staff said repairs would give the garage another 5-7 years of use.

A couple of council members said Monday night they're tired of spending money for temporary solutions.

Council member Jamie Mathy says enough is enough

A couple of years ago, a council majority rejected the idea of turning the Market Street deck into a new public library and Connect Transit transfer center.

Also in the budget, to be finalized in the coming weeks, is \$738,000 for design work on a new O'Neil Park swimming pool on Bloomington's west side.

The aluminum pool is 45 years old, but was supposed to last 25 years. City staffers said there have been enough repairs to open the pool again this summer.

The proposed budget is 1.2 percent more than the current fiscal year's budget, but city staffers recommend property taxes remain unchanged. The next fiscal year starts May 1.

Administrators of the Wonsook College of Fine Arts at Illinois State University have been planning for a huge renovation project for years and now they have \$52.3 million to get it done.

Last month Governor J.B. Pritzker released the state funds for the university to begin working on structural, electrical and flooding issues.

Wonsook College of Fine Arts Dean Jean Miller told our News partner, Heart of Illinois ABC, that the project is not just about updating the look of their building, but creating spaces for students to use the facilities for a variety of programs.

As of right now, the plan is to create dance studios, facilities for the college's growing video game design program and their glass blowing major, among other things.

ISU Graphic Design Senior Hannah Piemonte said although she will not see the changes, she is excited for the next generation of students.

The project—that is funded by the Rebuild Illinois gas tax—will be broken down into two phases with the first expected to last just over a year and a half and the second about 12 months.

ISU has yet to say when they plan to begin construction.

A Lexington contractor won't have to go to jail, but he'll have to pay back tens of thousands of dollars to customers for home construction projects he didn't finish.

In an agreement with McLean County prosecutors, our news aprtner Heart of Illinois ABC reports, Justin Barr of Post Frame Solutions pleaded guilty to theft by deception of over \$10,000. It's the first felony conviction for Barr, who faces similar charges in Woodford, Livingston, and Marshall Counties.

Barr, 41, will have to pay one of his customers \$25,000 and another customer \$18,000, all from the bond money he posted to be released from jail.

In court, McLean County Assistant State's Attorney David Rossi told the judge one of the victims hired Barr's company in September 2017 to build a house and garage in Kappa.

According to the prosecutor, Barr would come up with a variety of excuses for not finishing the work, including that he was busy with other jobs, he needed to order a different type of screw, and various family members and even his dog had died.

Barr will also have to perform 240 hours of community service as part of his 2 1/2-years on probation.

McLean County prosecutors want a Bloomington man behind bars again for his father's murder after a judge granted the man a new trial for the 1991 killing.

However, an appeals court earlier this week determined the judge should have based his ruling on a different legal standard to determine if Donald Whalen should be tried again for beating and stabbing his father William at the family's downtown Bloomington bar almost 29 years ago.

State's Attorney Don Knapp told our news partner, Heart of Illinois ABC Wednesday his office filed a motion to revoke Donald Whalen's bond.

Whalen came up with \$100,000 cash to be released from the McLean County Jail. He was allowed to post bond after Judge Scott Drazewski found new evidence was "more likely than not" to have affected the jury's decision, and "the likelihood of a different result is great enough to undermine the confidence in the outcome of the original trial."

However, justices on the Fourth Appellate Court ordered Drazewski to consider whether it's "probable" or "more likely than not" that the new evidence would have produced a different result.

Whalen was sentenced to 60 years in prison. He spent almost 28 years behind bars, and likely would have been released after serving about two more years because of good time credit.

Whalen is represented by lawyers from the University of Chicago's Exoneration Project, who can appeal the latest ruling to the Illinois Supreme Court.

Unit 5 is writing a roughly \$3 million dollar check for upgrades at one of its older buildings.

Our news partner Heart of Illinois ABC reports Kingsley Junior High currently uses a boiler for heat in the winter and room units to cool classrooms in the summer.

Soon, the boiler rooms of the 1950's will be replaced with a geothermal unit, according to Craig Montgomery, Director of Custodial Services.

Kingsley will be the 14th building in the district to get the upgrade and the district says the \$3 million dollar upfront cost is worth every penny. Executive Director of Operations Joe Adelman says the geothermal unit at Parkside Junior High has reduced gas by 98 percent and electricity by 68 percent.

So what does this mean in terms of dollars and cents in the school's operating costs?

By that math, Unit 5 saves just over \$48,000 per month, or just over half a million dollars per year.

The district says the geothermal system at Kingsley will be fully installed and operational in time for next school year.
