Dear Mr. Ebner:

On behalf of KXTV-TV ("KXTV"), this letter responds to the above-referenced Notice of Informal Complaint dated January 31, 2006 ("NOIC"), in which the Commission requests a response to a complaint ("Complaint") filed with the FCC by Sheri A. Farinha Mutti ("Complainant") with regards to KXTV's broadcast of visually accessible weather emergency information on December 31, 2005.

The Complaint alleges that during the period of December 30, 2005 to January 1, 2006, emergency flood warnings and evacuation notices for residents of Sacramento and San Joaquin, and other northern California counties broadcast by three (3) Sacramento area television stations, including KXTV, did not include sufficient visual emergency information in an accessible format for deaf viewers.

Before addressing the allegations in the Complaint and KXTV's actions, it must be noted that the Complaint lacks specific pertinent information, is vague and ambiguous in certain respects, and, because this is a generalized Complaint against three Sacramento television stations, is inapplicable to KXTV in certain respects.

First, the Complaint contains no information about any specific KXTV news report or coverage for which KXTV allegedly failed to provide emergency visual

information. The Complaint merely states that "there was no captioning provided during the audio and live segment portions".

Second, the Complaint is unclear as to whether a weather emergency existed, was imminent, constituted a potential threat now or in the future, or was merely feared. For example, the Complaint states:

in the video portion of newscast during its regularly scheduled televised news, live segments; both applicable to emergency flood warning and evacuation notices primarily intended for resident of the Sacramento and San Joaquin Counties, as well as the northern counties. All of whom, were affected by on-going flood warnings, people everywhere were audio informed of evacuations in areas due to levee overspills that is everyone but deaf or hard of hearing residents. Furthermore, there were threats of damages to different rivers --their levees of then feared, potential cracks and leaks, while elsewhere on the streets of Sacramento were sewer pipes overflowing.

Furthermore, the following paragraph in the Complaint clearly addresses the Complainant's general fear about possible future emergency conditions rather than actual emergency conditions:

This particular weekend however, without access to such emergency information, certainly created a completely stressful situation, with our anxiety growing by the minute, and had there actually been a catastrophic levee break residents who are deaf and hearing, we deaf, hard of hearing, and others with additional disabilities would more likely to have been the last ones to see it coming and/or evacuated. [emphasis added]

Third, the Complaint addresses the alleged failures of three (3) Sacramento area television stations, KXTV, KCRA, and CBS 13/UPN 31, to provide captioning information of weather-related events that occurred "throughout the New Year weekend (Dec. 30st – January 1st 2006)". In fact, KXTV provided emergency coverage only on December 31, 2005.

Despite these defects and the over-reaching nature of the Complaint, in a good faith effort to accurately respond to the NOIC, KXTV has thoroughly reviewed its available records of its broadcasts during the time period. As described below, KXTV provided frequent visual only text and information through squeeze-backs (as defined

below) ("Squeeze-Backs")1 during regular programming, and maps and graphics of severe flood conditions during numerous live reports that interrupted regular programming.

Visual Information Presented During Regular Programming (Squeeze-I. Backs)

KXTV presented weather emergency information in a visual only manner during regular programming on December 31, 2005 involving the use of Squeeze-Backs beginning at 4:37:51 a.m. and continuing periodically throughout the day until 9:35:19 p.m., a total of 38 times. The attached Exhibit A provides a complete list and description of the time and contents of each Squeeze-Back presented during December 31, 2005. As can be seen, many of these Squeeze-Backs announced road closing, flas flood warnings and evacuation orders for specific locations. None of the text in the Squeeze-Back blocked the closed-captioning of the ongoing regular programming.

Live, Special Cut-In Short-Form Reports During Regular Programming II.

In addition to Squeeze-Backs, KXTV interrupted regular ABC network programming to broadcast live reports 16 times on December 31, 2005 ("Live Short-Form Report(s)"). The attached Exhibit B provides a complete list and description of the time and contents of each Live Short-Form Report. The anchor's aural presentation in each Live Short-Form Report was accompanied by a full-screen, color, real-time map of the areas affected by thunderstorms and flooding, complete with cursor arrows, and a color bar to indicate storm intensity.

Some of the Live Short-Form Reports featured an on-screen textual list of affected areas, and some were accompanied by a full-screen text of the areas affected by the flood warning. For example, the Live Short-Form Report broadcast at 6:32:07 a.m. stated in large letters on the full screen:

> Flood Warning Urhan & Small Stream *Continued Yuba Sutter Shasta

Amador Nevada Tehama

A Squeeze-back" is a visual presentation consisting of a compression of the station's regular programming to the right portion of the screen and superimposition of (1) a bright red vertical screenlength box on the left that contains the words "Weather Alert" or "Traffic Alert" and (2) a bright red horizontal bar across the bottom of the screen containing detailed information in text form about the locations and projected paths of the storm and floods, about severe thunderstorm warnings, flood watches and warnings, small stream flooding, affected traffic patterns, closed roads and ramps, and evacuation orders. During each Squeeze-Back, the audio is that of the regularly-scheduled programming; there is no audio specific to the Squeeze-Back. Consequently, no captioning is required.

The Live Short Form Report at 7:50:12 a.m. displayed the following in large full-screen letters:

Flood Stage At or above:

Arcade Creek

Winding Way, Watt Ave.

Consumnes River

Additionally, some of the Live Short-Form Reports featured "Futurecasts", which display accelerated-time predictions, full-screen color maps indicating future snowfall and rainfall amounts with an accompanying colorbar that corresponded to colors of appropriate areas on the map.

III. Live, Special News Reports During Regular Programming

In addition to the Squeeze-Backs and Live Short-Form Reports described above, KXTV provided two (2) expanded special news reports from 12:20:47 p.m. to 1:02:38 p.m., and from 2:02:39 p.m. to 2:15:56 p.m. ("News Report"). Each News Report featured video of flooding conditions at specific locations with accompanying text at the bottom of the screen identifying the location. For example, video showed vehicles submerged in flood waters with accompanying text at the bottom of the screen indicating the street locations. The News Reports also featured full-screen color-coded maps of affected areas with corresponding colorbars to indicate intensity of the storm in the areas labeled on the map.

IV. Captioned Newscasts

KXTV provided captioning during its 5:00 p.m. to 6:00 p.m. newscast (except for those portions consisting of live field reports) and provided real-time closed captioning for the duration of its 6:00 pm. to 6:30 p.m. special newscast, each of which included an expanded weather report.

Future Compliance Measures

Although KXTV provided the visual information described above, it acknowledges that it could have taken additional steps to enhance its visual presentations. In this regard, KXTV has reaffirmed the following procedures for the visual presentation of emergency conditions in the future:

- Contact the Station's closed captioning provider as soon as possible for the provision of real-time closed captioning during emergency conditions.
- Pending the commencement of the real-time closed captioning, activate KXTV's own visual elements, including machine-captioning, crawls and supers, andassign a producer to listen to coverage and continually update the crawl, squeeze back, text, or character generator relating the information being given aurally until real-time closed captioning is in place.
- Ensure that visual crawls continue to be assigned to a designated producer for manual keyboarding of relevant information, such as emergency weather conditions, safety tips and road closures.
- Continue to use the station's Weather Alert System to generate on-screen maps and text throughout the broadcast day.

In addition, the Station will post visible reminders in the newsroom of the need to caption emergency coverage and will include the phone number for the captioning service. KXTV will also incorporate the visual emergency presentation guidelines into training of new employees.

Summary

KXTV understands the importance of providing visual information about emergencies in a manner that is accessible to persons with hearing disabilities. However, without having a particular complaint about KXTV programming, it is difficult to address this matter with more specificity.

As described above, for the day in question KXTV broadcast information about emergency conditions using visual methods such as Squeeze-Backs. full-screen graphics and text, maps, and expanded and special news coverage.

KXTV promptly responded to the Complainant, acknowledging the receipt of the Complaint, and copies the Complainant in this letter to the FCC.

^{*} In order to verify that advertising spots actually ran, KXTV records it programming using a method known as "slo-scan". This method "burns" a time/date code of the actual date and broadcasting times onto the disc at the time of recording. In some of these recordings, these "burned in" codes are superimposed over a portion of the text that appeared at the bottom of the screen during the telecast. Such text, however, was present, unobscured and clearly visible on the bottom of the screen and did not contain any date/time codes during the original broadcasts. In those instances where these codes obscured the text, an * appears in the following narrative descriptions. KXTV has modified its equipment so that in the future these codes will appear in the middle of the screen.
