Judgement may be confessed as often as necessary, and a photocopy of this agreement shall be sufficient warrant. The advertiser assumes responsibility for compliance of broadcast material with all federal, state and local advertising rules and regulations. All commercials become the property of the radio station.

The parties to this advertising agreement affirm that nothing in this agreement, or any of the actions, benefits and obligations relating to it, discriminate in any way on the basis of race or ethnicity. Fayette Broadcasting Corporation does not discriminate in the sale of advertising time, and will not accept advertising which is placed with the intent to discriminate on the basis of race or ethnicity. Any provision in any order or agreement for advertising that purports to discriminate, or has the effect of discriminating, on the basis of race or ethnicity, is hereby declared null and void." "Unless otherwise specified, 30 day notice needed for cancellation."
