Josh,

Thank you for writing and for your passion in this race and the future of Bend. Free and open elections are key to keeping democracy alive and well and I am always encouraged to see multiple candidates vying for the same office. However, every day we have challenging editorial decisions to make at OPB. The decision about who to include in this debate follows criteria that we have had in place for the last decade and we plan to stick with that.

As far as the legality of this decision, newscasts, news programs and news stories do not trigger equal time rules because candidate appearances are driven by journalistic decisions, not by the station's desire and ability to offer commercial time to candidates. This is an important provision that protects stations' First Amendment rights to decide what topics and guests merit news coverage based on editorial decisions, not on regulatory requirements.

OPB considers *Think Out Loud* to be a bona fide news program as it is integrated with our newsroom organizationally and reports to me, the Executive Editor of News.
