Dear Mr. Evertz:

This is in reference to the request filed on June 16, 2023. RVC requests a further extension of the STA granted on May 23, 2019, to continue operating daytime using the nighttime pattern with reduced power to allow time to file the required FCC Form 302 application.¹ In support of the request, RVC stated that little progress was made over the past six months, and therefore additional time will be needed to complete the remaining repairs to the daytime antenna system in order to file the application to update all operating parameters.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED, and RVC may continue to operate during daytime hours using the licensed six tower nighttime DA pattern with a **maximum** reduced nominal power of 30 kW, with no change to the licensed nighttime hours 50 kW operation. RVC must reduce the daytime 30 kW power level further or cease operation if complaints of interference are received, and use whatever means are necessary to

protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR §1.1310.

This authority expires on **January 2, 2024**.²

²Periods of operation pursuant to this STA shall be recorded in the station's records (see 47 CFR § 73.1820). The records shall include start/stop dates and times of such operation. These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
