NEWSCHANNEL 5 NETWORK, LLC, LICENSEE OF WTVF, NASHVILLE, TENNESSEE (FACILITY ID NO. 36504) REQUESTS SPECIAL TEMPORARY AUTHORITY ('STA') TO COMMENCE OPERATIONS ON CHANNEL 25 AT A LOWER ANTENNA HEIGHT AND EFFECTIVE RADIATED POWER ('ERP') THAN THOSE AUTHORIZED IN WTVF'S CONSTRUCTION PERMIT FOR CHANNEL 25 (SEE FCC FILE NO. BPCDT-20110824ACF) (THE 'PERMIT'). THE STA IS REQUESTED IN CONNECTION WITH THE STATION'S CONSTRUCTION OF THE FACILITIES SPECIFIED IN THE PERMIT.

THE WORK REQUIRED TO CONSTRUCT THE FACILITIES SPECIFIED IN THE PERMIT WILL REQUIRE CHANGES TO THE TOP OF WTVF'S TOWER, WHERE THE ANTENNA FOR THE 1,000 KW CHANNEL 25 FACILITY WILL BE LOCATED. WHILE THE TOWER WORK IS BEING COMPLETED, WTVF REQUESTS STA TO COMMENCE OPERATIONS ON CHANNEL 25 AT 130 KW ERP AT 509 METERS AMSL AND 244 METERS AGL. (THE PERMIT AUTHORIZES 1,000 KW ERP AT 616 METERS AMSL AND 351 METERS AGL.) THE REQUESTED TEMPORARY FACILITIES WILL USE A SIDE-MOUNTED ANTENNA (DIELECTRIC MODEL TUA-O4-2/8U-S) ON THE SAME TOWER AS AUTHORIZED IN THE PERMIT. WHEN WTVF COMMENCES OPERATIONS PURSUANT TO THE REQUESTED STA, IT WILL EMPLOY THE STRINGENT (FULL-POWER) EMISSION MASK, AS SPECIFIED FOR THE FULL-POWER OPERATION IN THE PERMIT.
