Exceptions to this would include technical outages, Sharathon or any special broadcast pre-emption. WOAK reserves the right & privilege to change days & airtimes as is deemed in the best interest of the station.

The program provider covenants and agrees that it shall provide timely payments to WOAK of \$200 per month.

As a bonus, WOAK will air 2 additional mentions of Program Provider per day for an additional \$50 per month (\$200 value). This mention can be as a program promo. Initial & date if agreed:
