A new investigation instigated by Missy Anastasi, mother of one of the infants, unearthed new evidence which pointed to her ex-husband Garrett Wilson, a successful salesman of musical instruments and four-times married father of both infants. Wilson who had taken out life insurance policies on both babies, was tried for the 1987 murder of his son, Garrett Michael, found guilty and sentenced to prison. The Crowes have filed a civil lawsuit alleging police interrogators and the prosecutor violated the family's civil rights. Despite the testimony of his ex-girlfriend Mary Ann Shore, who led police to the spot where Brenda Sue's body was buried, jurors found Ignatow not guilty for lack of evidence. However, six months later new incriminating evidence -- Brenda's jewelry and photos from the night of her murder -- were discovered in Ignatow's former home. Because of the double jeopardy provision of the U.S. Constitution which specifies that citizens cannot be tried more than once for the same crime, Ignatow will never serve time for the murder of Brenda Sue Schaefer but he has been imprisoned for perjury. The crime formed the basis of writer Barbara Davis' book Precious Angels in which she expressed the belief that Darlie was the killer and that her wounds were self-inflicted. Darlie was tried

d for murder, found guilty and sentenced to death. Subsequently, Davis received information about previously undisclosed evidence which convinced her of Darlie's innocence. She and others including Texas millionaire Brian Pardo are fighting to have Darlie's conviction overturned.

Darlie's future is now in the hands of the Texas Court of Criminal Appeals. Barbara Davis' 25-year-old son was killed when he allegedly threatened police with a loaded gun during a drug-related raid. Davis, found during the raid to be in possession of GHB, an illegal recreational drug, has filed a wrongful death suit against the police.
