Hi JoAnn,

I want to make sure we do this correctly, since it has to be uploaded into the public file...

On contract# 89085 on KCYE, we missed some streaming spots, so the client paid CIA \$350 on 10/28 for this station...due to the missing streaming spots, he was only billed \$310, so we need to issue a refund of \$40.

On contract# 89081 on KOAS, same thing here...he paid CIA \$350 on 10/28 (total payment was \$700) for this station. He was only billed \$335 so we need to issue a refund of \$15.

Total refund for this client Elect David L Washington, is \$55 net.

I also found the other one (was in as Local Agency instead of Political Agency ☺) but it's contract# 89071 for Comm to Elect Shell Mercer...same thing, we missed streaming spots...they paid CIA \$350, but were only billed \$303 gross, so we need to refund \$39.95 net.

Please let me know what paperwork you need from me, and then I will need a copy of your submission paperwork for the public file.
