Topic: Chinese engineer jailed for 14 years for stealing U.S. business secrets

A Chinese-American chemical engineer who participated in China's "Thousand Talents Program" to recruit scientific talents was found guilty of stealing trade secrets and economic espionage in the United States last month. The U.S. federal court in Tennessee sentenced the defendant to 14 years in prison and a fine of \$200,000 on May 9. Xiaorong You, the 59-

year-old defendant from Lansing Michigan, who worked for Coca-Cola and Eastman Chemical Company from 2012 to 2018, stole trade secrets on the BPA-free lining of canned beverage cans, which cost to nearly \$120 million in research for inter-company. After the defendant stole trade secrets, he opened a company in China related to the above-mentioned technology, and the Chinese company Weihai Jinhong Group, which cooperated with it, was subsidized by the Chinese government with millions of dollars. The judgment held that there was evidence that Xiaorong You intended to benefit the Chinese government, of Weihai City in Shandong Province.

Topic: 18-year-old gunman kills 21 in Texas elementary school
massacre

A bloody shooting occurred on May 24 at an elementary school in the southwestern Texas town of Uvalde. The suspect, 18-year-old high school student Salvador Ramos, shot his grandmother at home. He then drove to Robb Elementary School, crashed the car and entered the campus on foot, broke into the school and opened fire. At least 21 people were killed, including 19 children, and the gunman was eventually shot dead. The gunman had previously hinted to others that he was going to commit the murder, believing that he committed the crime alone. This was the deadliest school shooting in Texas history. Wearing a bulletproof vest and armed with a rifle, Ramos closed the door immediately after breaking into the school, and shot wildly at the children and teachers present. Two police officers were injured in an exchange of fire with the gunman after police arrival. A Border Patrol team was called to break into the elementary school and eventually killed the shooter. Victims were primary school students aged between 7 and 11, and two adults, including a 44-year-old female primary school teacher. The gunman's grandmother was shot and taken to hospital in critical condition.

American movie star Johnny Depp and his ex-wife Amber Heard sued each other for defamation after their divorce. After a six weeks hearing, the jury found that both were responsible for defamation, but favored Johnny Depp. Amber Heard faked the abuse and asks for \$15 million in compensation. The jury also convicted Johnny Depp's attorney for slandering Amber Heard, accusing her of claiming that the abuse was a hoax, and awarded Amber Heard \$2 million in damages. Johnny Depp said in a statement that his life and career have been significantly affected by the false allegations over the past six years. The purpose of this lawsuit is to tell the truth and describe the ruling as giving him a new lease of life. Amber Heard, who attended the court in person to hear the verdict, expressed disappointment after hearing the verdict and issued a statement describing her heartbreak at the ruling. The two were married for less than two years. Amber Heard wrote in the Washington Post in 2018 that she had been subjected to domestic violence. Johnny Depp subsequently lost a number of film opportunities. He and Amber Heard sued each other in libel lawsuit where Depp is seeking \$50 million in damages, and Heard is suing for \$100 million.

Topic: Power outage in Hong Kong; fire caused cable bridge broke in two

CLP's cable bridge near Hong Kong MTR Long Ping Station exploded and caught fire last night. The entire bridge was caught in flames. Fire was extinguished after about an hour and a half. No casualties were caused, but the cable bridge was broken in two. The accident caused major power outages in Yuen Long, Tin Shui Wai and Tuen Mun, affecting more than 500,000 people. The train service of the MTR Tuen Ma Line was blocked for a time, and the hospital also suffered from unstable power supply. Some emergency patients at the New Territories West Hospital Cluster had to be

transferred. About two hours after the accident, power was largely restored to the three districts.
