The Covid 19 epidemic in some communities in Brooklyn and Queens of New York City continues to rebound. Mayor Bill de Blasio said that the positive rate of the new crown in nine postal codes in the city has been higher than 3% for seven consecutive days. He has reported to the state government. Anti-epidemic plans are submitted. The nine communities that have rebounded from the epidemic plan to implement a "pause" from October 7 (Wednesday). Non-essential industries will be prohibited from operating, all schools will be closed, and restaurants will be closed for indoor and outdoor operations. Only allowed Takeaway; Bill de Blasio said that once the state government approves it, it will be implemented immediately.

The WTO Selection Committee has agreed to recommend Ngozi Okonjo-Iweala, former Nigerian Finance Minister, as the new Director-General, but the United States has indicated that it will not confirm her appointment. The Office of the United States Trade Representative later officially expressed its support for South Korea's Minister of Trade, Yoo Myung-hee, as WTO Director-General, stating that she is an excellent trade negotiator and capable of leading the WTO in "very difficult times".

The U.S. presidential election is unresolved. Several key states including Nevada, Pennsylvania, Georgia and North Carolina have no result. The latter three states are temporarily led by President Trump. In the 2020 general election on the 3rd, voting under the Covid19 pandemic, the Democratic nominee running for public office in the Queens district hit an overwhelming victory. The Chinese Rep. Meng Zhaowen, who ran for reelection in the 6th district of the House of Representatives in New York, won more than 63 votes. % Overwhelmed the Republican nominee, Thomas Zmich, who took the oath of Congress for the fifth time in January next year in Washington. State Senator Liu Chin-yi for the 11th District of the Northeast Queens District of New York also repelled the Republican challenger Elisa Nahoum without any surprises. The Korean-American Flushing 40th District State Representative Kim Dui-seok won the Chinese police Li Zhide in the Democratic primary election. In the general election, he won more than 80% of the votes to defeat Li Zhide, who was represented by the Justice and Peace Party.

If the Thai king issues a decree in Germany he may be deported Topic:

The King of Thailand Vajiralongkorn has lived in Germany in recent years, and the German parliamentarians are worried that the King of Thailand will run the country far away in Germany. The German Bundestag warned on Sunday (22nd) that if King Tai issues a decree in Germany, he may be deported. The King of Thailand enjoyed diplomatic immunity during his stay in Germany, and Congress stated that he still has the right to deport him. However, according to the assessment of the Bundestag Academic Service Agency, the German government is almost unable to sue the king. Even if the king is on vacation in Germany, his identity still represents Thailand, and it is difficult for law enforcement agencies to regard him as an "unwelcome person" and deport him. German Foreign Minister Maas warned last month that Thailand's anti-government demonstrations continued, and the King of Thailand would not be able to issue orders in Germany, stating that the German side had made it clear that policies affecting Thailand could not be issued on German territory.

Trump lawyer Giuliani diagnosed and go to hospital

US President Trump posted on a social networking site on Sunday (6th), confirming that Giuliani, a private lawyer who has been running around trying to make a comeback for him in the presidential election, has been diagnosed with new crown pneumonia. It is reported that Giuliani has been admitted to Georgetown University Hospital in Washington, D.C., but the hospital has not confirmed. Trump wrote on Twitter: "Giuliani, the greatest city chief in New York history and tirelessly exposing the most serious election fraud in American history, is diagnosed with the Chinese virus."

Trump wished Giuliani a speedy recovery. Giuliani appeared on Fox News earlier on Sunday, telling Trump's legal challenge for the general election in many states. Giuliani attended the State Assembly hearing in Michigan last Wednesday. He confessed about election fraud and did not wear a mask. During the period, he asked a female witness to remove the mask so that those present could hear clearly, but she refused. He went to the Georgia State Assembly hearing the next day to give evidence. He did not wear a mask, but it is unknown how he became infected.

sentenced to 2 months after appeal

Earlier, an 18-year-old American medical student went to the Cayman Islands, he was prosecuted for violating the local mandatory isolation policy and sentenced to four months in prison. After a round of appeals, the local judge announced on Tuesday that the sentence was reduced to two Months. Skylar Mack, a medical student in Georgia, went out without permission when he went to the Cayman Islands on the 27th of last month because he did not comply with the local 14-day compulsory quarantine and quarantine measures and removed the official smart strap for tracking

passengers. Went to watch her boyfriend's water skiing competition, but was eventually discovered by other contestants and reported to the authorities. The two were charged with violating the quarantine policy and sentenced to four months' imprisonment.
