**Post-Filing Requirements**

Following the filing of the station's license renewal application, the station must air announcements with the text provided below and in accordance with the following parameters:

During the four consecutive weeks following filing of the renewal application:

- A total of six announcements must be aired beginning no later than five business days after the FCC accepts the application for filing. (We will provide you with the acceptance date.)
- They must broadcast at least once per week, but not more than twice per week (when two are aired during the same week, they may not be on the same day)
- Announcements must air between 7:00am and 11:00 pm local time, Monday through Friday

Visuals containing the full text of the announcement must accompany all oral announcements.
