

## **Post-Filing Renewal Announcements (Radio)** [FCC Rule 73.3580]

Starting no later than Friday, December 10, 2021, begin broadcasting the post-filing renewal announcements. A total of six announcements must be made over a four week period starting with the first announcement. Each station must broadcast at least one per week, with no more than two announcements in the same week and none on the same day. The announcements must be made at any time between 7 a.m. and 11 p.m. local time Monday through Friday.

### **Certification of Post-Filing Renewal Announcements**

The attached Certification of the broadcast of the post-filing renewal announcements should be completed within 7 days of the last date the announcement is aired. The Certification should be uploaded to each station's FCC-hosted online public inspection file. 


