KSAT-TV ("Station") certifies that all 12-and-under children's TV programs carried during this quarter on its fifth digital channel 12.5, Start TV Network, were formatted so that, as a matter of standard policy and practice, the programs would not exceed the "commercial matter" time limits of §73.670(a) of the FCC's rules:

Weekdays: 10 minutes in any clock-hour children's programming (5 minutes or less in a stand-alone half-hour program);

Weekends: 10 minutes in any clock-hour children's programming (5 minutes or less in a stand-alone .5 hour program).

Effective 01/02/07, upcoming programming promos, with certain exceptions, count as commercial matter.

The following is a list of all Start TV Network programs provided to KSAT-TV designed to meet the Educational/Information requirement for children 13 to 16 years old during the 2nd Quarter 2019, April 1, 2019 through June 30, 2019. 
