Prepared for a Purpose is Antoinette's inspiring true story of faith, courage and compassion in crisis. Antoinette Tuff is a true picture of grace, courage and heroism. But before she made headlines on that fateful day in August, she was a woman who faced and overcame her own pain and hurt.
