To Whom It May Concern:

Gray Television Group, Inc., on behalf of its licensee subsidiaries Gray Television Licensee, LLC and Yellowstone LicenseCo LLC ("Gray"), hereby provides you with this formal notice under 47 C.F.R. § 76.55(e) with respect to each television station currently owned by Gray (each, a "Station"). Attachment A hereto lists the Stations.

For the carriage cycle of January 1, 2015, through December 31, 2017, Gray elects RETRANSMISSION CONSENT STATUS for each full-power Station on each cable television system that, at any time during the carriage cycle, serves any community located in any Station's television market (as defined by the FCC), including each such system that is owned or managed, directly or indirectly, by your company. To our knowledge, your systems that retransmit the signal(s) of our Stations are identified in Attachment B hereto.

Furthermore, Gray elects not to renew, extend, or roll-over the term of any retransmission consent agreement that may be in place between our companies at this time. At this time, we are preparing for this round of retransmission consent renewals, and we anticipate commencing all negotiations in September.
