**2nd Quarter – 2020 (April – May - June)**  
**July 9, 2020**

This quarter has been different than any we have experienced. Most of our programming has stayed the same. But our list of Church announcements and other announcements of events in the community dropped to none. They now contain some announcements of outdoor Church services and then a daily report from Brent Blevins of the cases of Covid in Boyle County. We have conducted several interviews and made many announcements from Ephraim McDowell in an attempt to keep all of our listeners informed of the health concerns in our community.

**\*Brent Blevins, Boyle County Health Department:** Brent Blevins from the Boyle County Health Department and Mildred Drake shared Boyle County's progress in the Covid battle. The interview aired May 19, 2020 at 6 PM and May 20, 2020 at 6 AM.

**\*Junction City Post Master, Paul Worley:** May 17 – 23, 2020 was named mailbox awareness week. This is a time Kentuckians are asked to make improvements to your mailbox and mailbox area to help the postal service. Ideas are to make sure the post and mailbox are sturdy, easily accessible. Also that numbers are easy to read. If these areas are not maintained it makes it very difficult for mail carriers and especially substitute carriers to deliver the mail. WDFB conducted an interview with Paul Worley, the Junction City Post Master and replayed it several times during the week.

**\*Boyle County Emergency Management Director – Mike Wilder:** WDFB conducted an interview with Mike Wilder, Director of Emergency Management concerning Boyle County and the needs of the community with the Corona Virus, Commodity distribution and other important issues for our County. **\*Haven Care:** During the month of May we had an interview with Tiffany Johnson, director Of Haven Care (pregnancy center) concerning the needs of the center and also the effects of Covid-19 on the center. **\*Trille Bottom, Boyle County Clerk:** Due to the need for absentee voting for the primary and Boyle Counties Courthouse being closed/reopening, we conducted an interview with Boyle County Clerk, Trille Bottom. **\*Commodity Distribution:** Community Distribution is such a need in our community.

They are given out the first Thursday of each month and WDFB was able to give announcements for those that qualify for this program. We have also been able to encourage our listeners to be a volunteer in this program. During April they are not able to distribute the food because of Covid. We were able to let our listeners know about this as well. So thankful they have been able to receive extra help from different agencies (National Guard and Air Patrol) so people in need can received the food.
